ANTHC-FURNISHED INFORMATION**

referred to as the "Recipient", has requested, and is authorized, to receive the documents as specified in the attached Request for Information form (Form 107-01). The documents are to be used solely for the purpose specified in the request, and are provided by the Alaska Native Tribal Health Consortium (ANTHC) subject to the terms of this agreement.

The parties to this document agree as follows:

1. Recipient use of named documents will be for the sole purpose of the named project and/or contract described herein and not for fulfilling requirements for work outside the scope of this agreement or for any other project or contract.
2. Recipient shall furnish all labor, software, and other aids necessary to the use of the documents for the purpose described herein without cost to ANTHC.
3. The Recipient agrees not to reuse these documents, in any format, in whole or in part, for any reason other than for ANTHC project(s), agreement(s), and/or contract(s) specified herein. The Recipient agrees not to transfer these documents to others without the prior written consent of ANTHC, and then, only subject to terms that are the same as this agreement. The recipient further agrees to waive all claims against ANTHC resulting in any way from any unauthorized use and/or changes to or reuse of documents for this or any other project by themselves or anyone other than ANTHC.
4. These documents are not construction documents. ANTHC makes no representation regarding the accuracy or completeness of the documents provided. By use of these documents, the Recipient is not relieved of its duty to fully comply with established statutory requirements, including, and without limitation, the requirement to check, confirm, and coordinate all dimensions, boundary and object locations, and details, take field measurements, verify field conditions, and coordinate its work with that of other contractors or parties for the project.
5. Under no circumstances shall delivery of the documents, for use by Recipient, be deemed a sale by ANTHC. ANTHC makes no warranty, express or implied, as to any matter whatsoever, including the condition or application of the documents, their merchantability, or its fitness for any particular purpose. Recipient accepts for its use according to this agreement, the documents "as is." In no event shall ANTHC be liable for any loss of profit or any consequential damages as a result of Recipient's use or reuse of these documents.
6. In consideration for the ability to utilize ANTHC documents listed herein, the Recipient hereby agrees to hold harmless ANTHC, its officers, agents and employees, for any liability resulting from the use of said documents. Recipient hereby agrees to save ANTHC, and the Village and/or City named in the project/contract, harmless from all claims, demands, suits, judgments, actions, costs and expenses, including attorney's fees, arising from or connected with any damage or injury (including death) to persons or property resulting from the possession, use, or application of the document(s), and Recipient shall notify ANTHC immediately of any accidents, damages incurred, or injuries sustained on account of or in any way resulting from or arising from Recipient's use of the document(s).
