Start time is 7:30 a.m., Saturday, May 10, 2014. The committee will make every effort to give each team at least 3 games; standard half court games will be played to 15 points or 25 minute time limit; win by one.

To play in OMD 3 on 3 Classic all players must be eight years old, or older, by May 10, 2014.

Divisions will include 12 and 14 years old and under, High School, and Open; boys & girls / men & women for all divisions. All genders are encouraged to participate. The committee will try to place teams in the appropriate division. Divisions will be determined after reviewing all the teams entry information. This year, there will be a limit on the number of teams allowed. The committee has the right to place any team in any division.

Players may play on only one team.

Adverse weather conditions and unplayable situations may result in modification or cancellation. Under these unlikely circumstances, each team will receive their t-shirts and registrations package. Under no circumstances will the entry fee be refunded.

Release/Waiver

The undersigned, wishes to participate in the 2014 OMD 3 on 3 Classic to be held on May 10, 2014 on the tennis courts at Oroville High School.

Knowing these risks, the undersigned covenants agree not to sue, and waives, releases and discharges OMD 3 on 3, (including its officers and agents), the city of Oroville, the Event, all employees, assigns or anyone acting for or on their behalf ("Released Parties"), from any and all claims of liability for death, personal injury or property damage of any kind, or nature arising out of or in the course of my participation in this Event.

In the event that the undersigned shall make demand, claim, or file suit based upon the Event, then that undersigned agrees to hold harmless and indemnify the Released Parties from any costs, loss, demands, claims, or suits made by that undersigned. The indemnification shall include, but not limited to, all court costs, legal fees, and investigation costs. Those amounts shall be paid at the date incurred by any or all Released Parties.

The undersigned expressly agree that the foregoing is intended to be as broad and inclusive as permitted by law, and that any interpretation should be made for the benefit of the Released Parties.

The undersigned grants full permission to any and all of the foregoing to use any photography, video tapes, motion pictures, recording, or other records of this Event.
