sands of plastic forks-knives-spoons; plenty of homemade pies and cakes.



# Sessions to propose Personal Savings Accounts for all Americans

In the aftermath of their recent election victory, Democratic leaders have pledged to work on a bipartisan basis to solve the problems facing our nation. In that spirit, I suggest Democ-rats and Republicans can successfully work together

to create personal savings accounts for all Americans outside the Social Security system, an idea that politi-cians from both political parties have supported for years.

For the first time since the Great Depression, our country's saving rate has fallen into negative territory, with more than half of all American workers having less than \$25,000 in savings, excluding their primary residence. More troubling, almost half of the 152.7 million Americans who worked in 2004 worked for an employer that did not sponsor any retirement plan and another 17.3 million did not participate in their employer's plan.

The solution for this problem is to create a national system of personal savings accounts modeled after the successful Thrift Savings Plan (TSP) for federal employees. Federal Federal employees pay Social Security taxes and receive the same Social Security benefits as everyone else. But the TSP



program allows federal workers to invest a portion of each paycheck - along with a government match for part of these contributions - into one of six investment accounts (or some combination of these accounts), including a government securities fund and a common stock fund.

Over the past two decades, this system has been an unqualified success, as federal employees have received large returns on the money they have invested.

To fix our national savings problem, we should create a TSP-style system for all Americans.

Under legislation I will be introducing in the next Congress, individual personal retirement accounts - called PLUS Accounts (for Portable, Lifelong Universal Savings Accounts) - would be established for every American at birth and would be endowed with a \$1,000 contribution paid for by the federal government. This money could be invested in a limited number of investment funds similar to those offered by the TSP program, with the parents of each newborn choosing their preferred funds. Parents and grandparents also would be allowed to contribute up to \$5,000 annually to these accounts.
