13. General Information

The NC General Assembly under NC General Statute 143-52.3 (House Bill 713-Ratified-2011 S.L.) has directed the Department of Administration to use multiple award schedule contracts for the purchase of all ground maintenance, construction, communications, and forestry equipment. This contract specifically covers: Construction Equipment as defined in the aforementioned NC General Statute as: excavators, wheel excavators, track loaders, compact track loaders, wheel loaders, skid steer loaders, backhoe loaders, crawler dozers, crawler loaders, wheel dozers, motor graders, utility cranes, compactors and appropriate attachments or equivalent products and attachments.

2. Scope of Contract

This Statewide Term Contract (760H) will become effective from January 1, 2012 for a term of 36 months. Any Statewide Term Contract awarded pursuant to this solicitation will not replace any existing contracts for these items, but end users will have the option to use this contract in lieu of any other contracts.

If the state or any authorized user of this contract is offered the same item on the exact same terms and conditions as those provided herein by a vendor other than a current contract vendor (herein known as alternate vendor) for a price that is at least 10% less than the current contract price (including options, features, accessories) under this contract , the state or any authorized user of this contract may purchase those items from the alternate vendor if the current contract vendor does not agree to "match" the alternate vendor's price.

Some definitions used herein-Attachments- enhance or contribute to the functionality of or safety of the piece of equipment (include strobe lights and back up alarms-can be aftermarket)-Accessories-items added to equipment that provide user comfort or aesthetic value (radios, a/c, canopies)-Attachments, options, accessories must be ordered at same time with equipment in order to receive the applicable discounts.

NON-STATE AGENCIES ELIGIBLE TO PARTICIPATE IN THIS CONTRACT

In accordance with North Carolina General Statutes, certain non-state entities described below, may participate in this contract on a voluntary basis. Any of the non-state entities that choose to participate in this contract must abide by the terms and conditions that are set forth in this contract.

Nonprofit corporations operating charitable hospitals, local nonprofit community sheltered workshops or centers that meet standards established by the Division of Vocational Rehabilitation of the Department of Health and Human Services, private nonprofit agencies licensed or approved by the Department of Health and Human Services as child placing agencies, residential child-care facilities, private nonprofit rural, community, and migrant health centers designated by the Office of Rural Health and Resource Development, private higher education institutions, counties, public school units, cities, towns, governmental entities, volunteer fire departments, rescue squads, and other subdivisions of the State and public agencies thereof.

3. Taxes

Prices or Discounts shown herein do not include any North Carolina sales or use taxes.

4. Abnormal Quantities

For state agencies and for purposes of this Invitation for Bids and any resulting contract award, any agency requirement that exceeds 10 units per order in any one category must be forwarded to the Division of Purchase and Contract for processing. The Division, at its sole discretion, may process any such requirement in one of the following ways:

- 1) Purchase may be authorized at the current level of pricing with the current contract vendor(s)
- 2) Additional discounts from the current level of pricing may be negotiated with the current contract vendor(s)
- 3) A separate Invitation for Bids may be issued for the requirement

5. Minimum Orders

This contract will be for a minimum order of 1 unit for any single order. Agencies are authorized to purchase from best available sources on orders less than this minimum order value.

6. Placement of Orders

Orders will be placed throughout the contract period on an as-needed basis for the quantity required at the time, and will be issued directly to the respective contractor(s) or their designated suppliers. Contract changes, if any, over the life of the contract are implemented by contract addenda released by the Contract Administrator to the contractor.

ORDERING INFORMATION:

Contractors are required, upon request of any user, to provide the user with catalogs and descriptive literature and a listing of authorized dealers complete with toll free phone and FAX numbers. This information is to be provided to the ordering agency within 5 business days of the request. Such information shall be provided at no charge to the user.

End users under this Statewide Term Contract are required to contact multiple contractors to obtain best value bids to fulfill and end user's specific needs, including but not limited to: features, options, accessories, attachments, prices, Executive Order Number 50 Price Matching requirements, reciprocity requirements, delivery, warranty, safety features, service locations, and other issues important to the end user. The contacted contractor shall within 24 hours or other time period as requested by the end user, provide by fax or email to the end user the following offer information: make/model number, description of features (complete specification sheet), MSRP price, State of NC Pricing and firm delivery date, service location(s) in proximity to end user's delivery location. In addition, the questionnaire herein shall also be faxed to the end user at same time as the other requirements. The price(s) in such offer may not exceed, but may be less than, the prices agree to at the time of award.

One copy of operator's manual shall accompany the delivery of the equipment. Ordering agencies are STRONGLY TO CONFIRM ALL FEATURES/OPTIONS/ATTACHMENTS/ACCESSORIES PRIOR TO PLACING ORDER.

Our end-users/agencies will be required to obtain a minimum of three (3) quotes (if a category has less than 3 vendors, then obtain quotes from all of those vendors in that category) from vendors under contract for any item with the total purchase price which exceeds \$10,000.00; if the end-user is not purchasing from the lowest bidder provided under this contract, the end-user/agency must provide a satisfactory prior justification in writing to the SPO for approval. Orders will be placed throughout the contract period on an as-needed basis for the quantity required at the time, and will be issued directly to the respective contractor(s) or their designated suppliers. Contract changes, if any, over the life of the contract are implemented by contract addenda released by the Contract Administrator to the contractor. If the contractor is accepting orders and/or delivering through other parties, for example a manufacturer accepting orders and delivering through a dealer network or dealers receiving orders through a network of other dealers, then it is the responsibility of the contractor to apprise such parties of all such contract addenda.

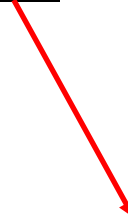

13) Occupational Safety and Health Act & SAE Standards

The equipment offered herein shall be furnished with all applicable equipment and accessories as required by the Occupational Safety and Health Act (U.S. Department of Labor and the N.C. Department of Labor). Noise at ear level of the seated operator, with cab doors and windows open shall not exceed OSHA requirements for 8-hour operator exposure.

The grader shall be furnished in accordance with all applicable SAE and ISO standards in effect on the date of bid and continue to meet the standards and updated standards throughout the contract period.

13) CATALOGS & MANUALS: NCDOT

The successful bidder shall furnish as part of the contract the following to the NCDOT Production Control Manager of the Equipment & Inventory Control Unit:

13. One (1) operator's manual for the specific make & model of equipment shall be in each piece of equipment when delivered. *Failure to furnish will delay payment.*

B. Two (2) electronic format copies of descriptive parts catalogs, operator's manual and shop/service manuals containing OEM Part Nos. covering all systems, components and accessories for the specific make & model of equipment purchased. These are to be delivered to the NCDOT Production Control Manager at 4809 Beryl Road within ten (10) days after receipt of purchase order.

DOT reserves the right to refuse delivery of any equipment until the electronic or paper manuals have been received, approved and accepted. Payment will not be rendered by DOT until manuals are received and determined to be suitable for use in NCDOT's electronic infrastructure.

DELIVERY AUTHORIZATION MUST BE RECEIVED FROM THE PRODUCTION CONTROL MANAGER BEFORE ANY EQUIPMENT IS DELIVERED.

C. Two (2) electronic format copies of updates to the parts catalog and shop manuals for the specific make and model of equipment delivered shall be furnished to the State at the same time such updates are furnished to a dealer. Expenses incurred by the State as a result of the vendor failing to provide updates under section C will be passed to the vendor.

Electronic Format: The successful vendor shall be responsible for providing the electronic media as described above in Adobe Portable Document Format or an electronic format pre approved by NCDOT.

D. In lieu of electronic format, the State will accept two (2) original paper versions of items listed above. Paper version is to be presented in 8.5" by 11" portrait presentation.

NOTE: Parts catalogs, service manuals, operator's manuals, or other material needed to satisfy these requirements are not to be bid as separate items. All materials shall be furnished as specified and applicable to the equipment bid, at no additional cost. The vendor specifically agrees that such material supplied under this section may be copied or reproduced in any manner for use by NCDOT.

2) PILOT MODEL:

The NCDOT reserves the right to require that a pilot model be made available inspected and approved before any units are shipped. Inspection for compliance with specifications shall be at contractor's plant or another site acceptable to the State and final inspection and acceptance of all other units will be made at the N.C. Division of Highways Equipment Depot, Raleigh, NC. If required, the pilot model inspection date will be set when a purchase order is issued

3) DEMONSTRATION (RALEIGH):

Prior to award and upon written request, the NCDOT reserves the right to request a demonstration of the exact model offered herein. The demonstration would be for the purpose of observing the equipment in operation, which may answer concerns not otherwise addressed in the bid document or literature provided by the vendor. If requested, the bidder should be prepared to demonstrate the equipment within 30 days after receiving written notification from the NCDOT. The demonstration would be free of any charge to the NCDOT at a site selected by NC DOT. Such demonstration does not constitute full and final approval of the equipment. All units will be inspected for compliance with the specification upon receipt at the destination required.

4) PRE-CONSTRUCTION MEETING:

The NCDOT reserves the right to require a pre-construction meeting to be held in Raleigh, NC prior to fabrication of the equipment. A representative of the successful bidder, who has technical expertise and the authority to make decisions regarding mechanical aspects of the machine, shall be present at the meeting. The meeting is to be scheduled by agreement between the successful bidder and NCDOT DOT.

5) COLOR: (NCDOT)

Units supplied under this specification shall be painted with a lead free, "North Carolina Department of Transportation Safety Yellow" which shall be visually inspected for suitable match in the following manner; Prior to the finish painting of equipment, the successful bidder will be provided a paint chip by the North Carolina Department of Transportation which has been prepared utilizing a minimum of one (1) mil thickness of lead-free gray primer and a minimum of two (2) mil thickness of lead-free Dupont Centari # 54701A, ALT 2. The successful bidder shall be required to return the NCDOT paint chip and furnish two (2) 3 1/2" x 8" painted panels representing the finished color for approval. If approved, one panel will be returned to contractor and the other will be retained by State for color comparison. Color of equipment must then match the color-approved panel. The vendor must furnish a copy of the current MSDS sheet for the paint used which indicates that the paint is lead free with the submitted color chips.

Paint which has met the North Carolina Department of Transportation color specification includes but is not limited to: Dupont Centari # 54701A, ALT 2.

Wheel discs, stainless steel, polished aluminum and molded plastic parts are exempt from this requirement and are acceptable in the manufacture's standard color.

6) TRAINING:

Training is required and the successful bidder shall furnish a qualified representative to instruct the owner's operators in proper operation, maintenance and service of the equipment for a minimum period of eight (8) hours in 3 location(s), statewide. NCDOT reserves the right to require training for any additional units purchased during the contract period. The number of training locations may increase or decrease with each purchase order based on the quantity of items purchased. After a period of six (6) months a trouble shooting and repair training session shall be held by a repair technician instructing owner's mechanic in the repair techniques at a location appropriate for NCDOT needs, each for up to 8 hours as deemed appropriate. All training sessions shall be coordinated with and at the convenience of NCDOT through the office of the Equipment Plant and Maintenance Manager, (919) 733-2220.

A completed Equipment Preventative Maintenance Questionnaire (EPMQ) form with supporting documentation must be submitted by the successful bidder ***within ten (10) days after receipt of Purchase Order***. A blank EPMQ form is included in this specification.

The EPMQ form consists of blanks in which servicing information is to be listed for the equipment furnished. This is a generic form and blanks that are not applicable are to be completed with N/A. The information supplied on the EPMQ form is entered in a DOT Division of Highways equipment database that is accessible by all of our shops.

DOT reserves the right to refuse delivery of any equipment until the EPMQ form has been received, approved and accepted. Payment will not be rendered by DOT until the EPMQ form is received and determined to be suitable for use by NCDOT. DELIVERY AUTHORIZATION MUST BE RECEIVED FROM THE PRODUCTION CONTROL MANAGER BEFORE ANY EQUIPMENT IS DELIVERED.

Special Note:

Information provided on the EPMQ form must be correct or successful bidder will be assessed for expenses incurred as a result of incorrect information being provided.

Supporting documentation is required with submission of every form.

This supporting documentation can consist of a manual or any part of a manual that supports the service information provided on the EPMQ form. We will accept an owner's manual, operator's manual, parts manual, service manual, technical manual, bill of material, engineering technical document or copies of pages from any of these manuals that contain the required service information. DOT must be able to verify any copies of manuals or pages furnished came from the manufacturer's manual for the make and model of equipment being provided.

10) WARRANTY: NCDOT

Each piece of equipment is to be warranted "bumper to bumper" for a minimum period of 12 months from respective dates the equipment is put in operation regardless of mileage or hours. Defective parts found to be free of negligence or accident will be replaced free of charge to the State. Such replacement is to include all parts, labor, freight, and travel to site where equipment is down (statewide locations). If warranty work needs to be performed at an authorized dealer facility the bidder is responsible for providing transportation to and from or reimbursing the State for transportation. There shall be no reduction (prorating) of coverage resulting from age or mileage during the warranty period.

an authorized dealer facility the bidder is responsible for providing transportation to and from or reimbursing the State for transportation. There shall be no reduction (prorating) of coverage resulting from age or mileage during the warranty period.

In addition, any specific provisions in the manufacturer's standard warranty that exceed any of the above requirements become part of the warranty for this contract.

Any periodic inspections, which may be required and performed by the vendor or his representative, shall be without charge to the State.

The manufacturer(s) shall list the State of North Carolina as an authorized service account and warranty work may be performed by State employees when it is in the best interest of the State. Such work will be reimbursed at the Dealer's current labor rate and for the standard time allowed for the repair.

Bidder is advised that deviations taken to the above warranty paragraphs may cause nullification of bid. Bidder specifically agrees to above warranty paragraph by signature of the "Execution of Bid" contained herein. The bidder understands and agrees that if a manufacture's warranty is submitted with their bid, it is to be considered for informational purposes only. It is not intended in any way to take exception to any requirements nor to impose any conditions whatsoever on this bid.

The contractor guarantees items offered to be free from any and all defects in material, packaging, and workmanship and agrees to replace defective items promptly at no charge to the State, for a period of as stated in the vendor standard warranty information..

13. Substitutions

Substitutions after order placement are not permitted without prior approval of the ordering agency. Failure of the contractor to comply with this requirement may result in the removal of the contractor from the contract.

14. Other Information- The vendor shall provide the following special requirements to NC Dept. of Transportation (NCDOT), all other users may or may not require them. To be specified in the purchase order

BACKUP ALARM:

Equipment shall have a backup alarm and may be mfr or dealer installed. Backup alarm shall be in accordance with SAE J994, electronic type (not ding dong), shall become activated immediately upon backing of equipment (not activated by motion detection), must be audible above the surrounding noise level of the equipment, must be a sealed type unit to protect internal components from moisture, dust and contaminants, resists effects of vibration, single or dual tone is acceptable, and minimum one year warranty shall apply.

REPAIR PARTS DELIVERY:

Bidder shall maintain access to a complete inventory of repair parts for the offered equipment, located within the United States, for ten (10) years after the date of acceptance of the equipment. Critical repair parts from this inventory shall be received by the designated repair depot within five (5) working days after request. "Critical repair parts" are defined as those parts, which are essential for the safe and proper operation of the machine.

For critical repair parts, a penalty of \$124.72 per working day shall be levied against the bidder and deducted from parts invoice(s) for each working day that completed delivery is in excess of the five day limit. This penalty will only apply in cases where the parts order has been placed with the bidder. This penalty clause shall be in effect for three (3) years from date of acceptance of equipment offered on this bid.

The State may waive the above repair parts penalty in any instance where such non-performance, in the determination of the State, is due to factors other than those under control of the bidder and/or manufacturer.

STANDARD EQUIPMENT:

Any additional equipment or accessories listed in manufacturer's current literature, as standard but not listed in these specifications must also be furnished.

SERVICE UPON DELIVERY:

Units shall be complete, serviced and ready for operation when delivered.
