6. Starting in 2014, there will be a new GED test. The current version of the test is expiring at the end of 2013 and your scores will expire also if you don't finish & pass the tests at that time. You must finish & meet the passing requirements of the GED by the end of 2013 or you will need to restart the testing process in 2014.
