West Penn Power Rebate Requirements

1. Applicant must be a Pennsylvania residential customer of West Penn Power.
2. Rebate applications are valid for qualified appliances purchased beginning January 1, 2012 through May 31, 2013.
3. Rebate application must be postmarked by June 7, 2013.
4. Customers who purchased qualified appliances before January 1, 2012, also may be eligible for rebates. Call 1-888-265-6684 for more details.
5. All rebated products must be listed by the EPA as ENERGY STAR® qualified on www.energystar.gov.
6. Application must be accompanied by a legible copy of the dated sales receipt or proof of purchase that includes the manufacturer, ENERGY STAR® model number, serial number, store name, store location, purchase price and date of purchase.
7. Payment will be issued to the account holder and mailing address on record with the utility.
8. To be eligible for a clothes washer rebate, home must have an electric water heater.
9. Please allow up to 90 days from the date all required information is received to process your rebate(s).
10. All rebated products must be used at the service address specified on the rebate application.
11. Program procedures, requirements and rebate levels are subject to change or cancellation without notice and are subject to available program funds.
12. West Penn Power and/or its designees including program administrators do not endorse any particular manufacturer or product as part of this program.
13. By participating in this program, Customer agrees to allow the local utility (West Penn Power Company) to take ownership of the Energy Efficiency resource credits associated with the measures generated through this program. Your local utility may at its sole discretion then aggregate your credits with other similarly situated customers and bid the credits into the PJM market through an auction. Any proceeds from any such bids accepted by PJM will be used to offset the costs charged to the utility's customers for compliance with state mandated energy efficiency and/or peak demand requirements.
