

TO ADHERE AS A CORPORATE MEMBER

This form of adherence is for duly established institutions or associations having activities on the international, national or regional level in the field of public administration. In countries where there is a *« National Section »*^{*}, *«* the National Section concerned shall be notified of any application for corporate membership. In the absence of a negative recommendation by the National Section within three months of such notification, *»* the Executive Committee may confer corporate membership on the requester.

The Executive Committee of IIAS grants corporate membership.

The corporate members are informed of IIAS activities and have priority to participate in them. They attend the General Assembly, but are not represented on the Council of Administration and, consequently, not on the Executive Committee. They receive a free-of-charge subscription to the International Review of Administrative Sciences and benefit from a 50% reduction on the price of other publications of the Institute which appear during the year and 10% on all prior publications. They also enjoy a preferential rate as a member for the registration of conferences, round tables and congresses.

The annual subscription fee is of at least 224,00 €.

The enclosed form is to be completed and returned to IIAS.

Statutes should be annexed to the request form, insofar as they are available in one of the official languages of the Institute.
