Frequently Asked Questions

What are the benefits of the mentor program?

Mentors

- Given the satisfaction of knowing one of our clients, employees, or students on a 1:1 basis and helping them be successful in their career
- Opportunity for individuals to mentor adults
- Eligible to participate in in-house training through Goodwill Corporate University
- opportunity to network with other mentors through semi-annual "Match Events"

Mentees

- Receive support from someone that is focused solely on their needs
- Ability to connect with someone they are not associated with at school, work or in their daily life
- Opportunity to explore a new career path
- Chance to share their ups and downs with a friend

How often and where will I meet with my mentee?

- The matches will be encouraged to meet face-to-face twice a month and talk by phone or email on alternate weeks so that they have some type of contact each week
- Matches should meet in public places in which both individuals feel comfortable, but should not meet in the mentor's or mentee's home
- Face-to-face meetings may take place any time of the week and do not have to last a long time, 45 minutes minimum
- Weekly meetings will provide an opportunity for the matches to get to know each other better so they are comfortable addressing any subject the mentee may need help with

How long will I be matched with my mentee?

Goodwill Trainee or Student

- A client match will last a maximum of three months past the mentees completion of a Goodwill training program in order to provide additional support for the mentee in their first weeks at a new job. Goodwill programs vary from 8 weeks to 2 years and mentors will have an opportunity to indicate which program they would like to work with.
- A match may continue past the maximum of six months, but adjustments will be made to the support provided by Goodwill for the match. The match will still be able to attend Goodwill mentor/mentee functions, but will no longer be eligible for reimbursement through Goodwill.

Goodwill Employee

• An employee mentor match length will be based on the Individual Development Plan of the individual employee

What type of training will I receive before I become a mentor?

Each mentor will be required to attend 4 hours of training before beginning any service with Goodwill. The training will consist of an overview of Goodwill including the following:

- Overview of the history of Goodwill
- A description of the programs offered at Goodwill so you will understand what type of connection your mentee has to Goodwill.
- Information on what a Goodwill client looks like. What is their background? How did they come to Goodwill?



- Training on the warning signs that may indicate additional services are needed need for clothing, food, etc assistance
- Responsibilities and limitations of Mentors
- Brainstorm suggested activities you can do with your mentee
- Provide contacting information for and an overview of the structure of Goodwill's Career Services programs
- Review of Goodwill's Corporate University classes that will be available to you
- An opportunity to meet other new Mentors.

How will I be matched with my mentee?

- A Career Services staff person will identify a client in need of a mentor and notify the Volunteer Services staff of the need or the Corporate University staff will notify the Volunteer Services Staff of an employee wishing to have a mentor
- The Volunteer Services staff will maintain a list of individuals interested in becoming mentors and will notify an individual when they have a match
- The new mentor will complete a Mentor Profile form, including background check, when they express interest in the program
- The Mentor Profile form will be reviewed by the Career Services or Corporate University staff and Volunteer Services staff members to determine if it is a good match
- The new mentor will meet with the Career Services or Corporate University staff member
- The mentor will attend the 4 hour training session
- The mentor and mentee will be introduced at a Goodwill location for the first time
