New CLSA Scholarship Fund

ver the past several years, the Board of Governors received a number of requests from foreign students in Africa, Asia, and Eastern Europe for financial assistance to study canon law. Likewise, CLSA members have raised concern that eligibility requirements for our existing scholarship award required two items some worthy applicants could not meet: the applicant must be a citizen of the United States of America and he or she must commit to a five years of canonical work within the United States upon completion of a licentiate degree. After considerable deliberation, a proposal was made to the board to establish a new scholarship program specifically for men and women who are foreign national students.

The name selected for the new scholarship fund was the Valentine Schaaf, O.F.M. Scholarship Fund. A member of the Cincinnati, Ohio, Province of St. John the Baptist, Father Schaaf (1883 – 1946) has the distinction of serving as the Dean of the School of Canon Law, The Catholic University of America (1933 - 1937) and professor until 1939. In 1944 Father Valentine was elected the 113th successor to St. Francis of Assisi and served as the first American Minister General of the Order of Friars Minor. Father Schaaf's family created a website on his life and activities at http://bill.laudeman.com/ schaaf. Father Valentine's love for canon law and his Franciscan missionary zeal makes him an ideal patron for this worthy cause.

In early spring 2003, the Province of St. John the Baptist offered a contribution over the next two years based on the society's fund raising efforts for this project. At the May 2003 board meeting, the board authorized the Executive Coordinator to draft a letter sent to the men and women religious in the United States seeking funds for this scholarship fund for religious and foreign nationals. That effort already raised approximately \$12,000 in cash with the promise of future pledges.

The Board of Governors, reviewed the progress of the Schaaf scholarship fund in January 2004 and will provide directions to the Scholarship committee for future activity. The Valentine Schaaf O.F.M. Scholarship Fund is growing and the board waits for that day when sufficient funds will exist to aid our brothers and sisters of other lands to pursue an education in canon law.

would like to start with a few items from the January meeting of the Board of Governors. One of the issues that generated much discussion was the relocation of the

office of the CLSA Executive Coordinator. By the end of May we need to vacate the space we have occupied at The Catholic University of America. The BOG reviewed the report from the special task force made up of past presidents and treasurers. With a careful eve toward fiscal responsibility on behalf of the CLSA, the BOG decided to seek some additional information and clarification of proposals before a decision is announced. I am hoping that the final decision is reached by the time you receive this Newsletter. It will be announced to everyone (probably by a special mailing and on our website) as soon as possible. I am confident that vou will be satisfied to know that the task force and the BOG took into consideration the mission of the CLSA, its current and projected financial condition, and the needs of the Executive Coordinator's office in making a decision. A number of options were considered, including possible sites in the Washington, DC area and elsewhere. I want to thank the members of the task force and the BOG for their efforts in addressing a very important and pressing need of the CLSA.

The topic of strategic planning also resurfaced during the January BOG meeting. Whenever the BOG tries to address for example how to run a canon law publishing business, questions inevitably emerge about who we are as a society of canonists and what we want to accomplish in service to our members and to the people of God. We did not have much time to spend on strategic planning in the January meeting because the agenda was so full, but it will be on the agenda for the April meeting. There was a consensus among the members of the BOG that a strategic planning process is overdue not only for the benefit of the BOG, but for the good of the CLSA. More about this after the April meeting.

Elsewhere in this newsletter you will read about a new scholarship fund that will some day assist canon law students from places throughout the world where financial resources are extremely limited. The great need for such financial aid was underscored when I visited with students at St. Paul University in Ottawa, Canada on February 3rd. They share an enthusiasm for the study of canon law and a desire to continue that study at least through the publications of the CLSA when they return home to places all around the world. However, even the cost of student membership in the CLSA is beyond their means.

Speaking of Ottawa, it allowed me to visit with two BOG members who are professors at St. Paul's: Lynda Robataille and Patrick Cogan. Dean Roland Jacques, OMI was a gracious host at the university where I gave a lecture: *The Role of the Advocate in Cases of Sexual Abuse of Minors by Clergy.* Msgr. Patrick Powers, President of the Canadian Canon Law Society, gave me a quick tour of the city and I had the pleasure of meeting with Most Rev. Marcel Gervais, Archbishop of Ottawa who invited me to stay at his residence.

I had a similarly enjoyable experience at the end of October when I visited the School of Canon Law at the Catholic University of America in Washington. I gave the students a lot of credit for being so attentive during my talk in the late afternoon! The Dean, Msgr. Brian Ferme, was a great host and I had a chance to greet a number of the professors. resently in the final stages of production, this latest volume of the CLSA Marriage Research Committee, Marriage Studies V: Sources in Matrimonial Law, contains a collection of resources for the composition of law sections on eighteen different grounds used in the adjudication of marriage nullity cases. The format for each ground follows the same sequence: 1) identification of pertinent canons; 2) papal and/or conciliar teachings on marriage, with special emphasis on the aspects of marriage subsumed within the specific ground, and on Papal allocutions to the Rota addressing the ground or issues within the ground; 3) passages

from rotal jurisprudence; 4) types of proofs required for the specific ground; and 5) a final subsection which provides lengthier references or presents specialized matters relative to the specific ground. This volume attempts to be user friendly and to be a resource for canonists actively involved in tribunal ministry. The paperback volume also comes with a CD of the complete text.
