# TAFT LAW SCHOOL

## Dear Applicant:

Attached is the newest book list from Legal Books Distributing. This list will provide you with information about the required and optional books for your courses at Taft Law School. We have worked with Legal Books for many years and feel they offer quality service at competitive prices. However, you are not required to purchase your books from them or any other particular bookstore. As you will see from the information below, this book list is subject to change over the next couple of months.

Publishers of legal books frequently add new editions of books. This is fine for traditional law schools that start everyone in August or September. However it is a problem for our students that start throughout the year. Here is our advice for buying books:

- 1. Wait until about a week before your start date to buy your books. By then all new editions applicable for your start should have been announced and available. We supply all the materials you need for the <u>first three weeks of school</u>. Therefore, if you order your books a week before the start, you will have about four weeks for the books to arrive.
- 2. Buy the newest edition of the book available, even if it does not match the edition listed in the course syllabus. Sometimes new editions are not available to us in time to update the syllabus. However, most booksellers return the old editions of their legal books as soon as the new edition is announced. In most courses, the changes between editions are minor. Usually the only difference you will note is that the pages listed in the reading assignment will be off by a few pages. This can easily be worked around. Please call the Taft Law School office any time you need help making this adjustment.
- 3. Although we have asked you to wait until two weeks before the start of school, make sure you buy your books before your start date. Sometimes we ask Legal Books Distributing to hold a certain amount of the older editions of a book if we know the new edition will not be available until after the start. After the start, Legal Books will return its unsold inventory to make room for the new edition. If you do not buy your books prior to the start, you may get caught in the gap between the return of the old edition and the arrival of the new edition. You need your books before the start of each course. Plan your purchases now.
