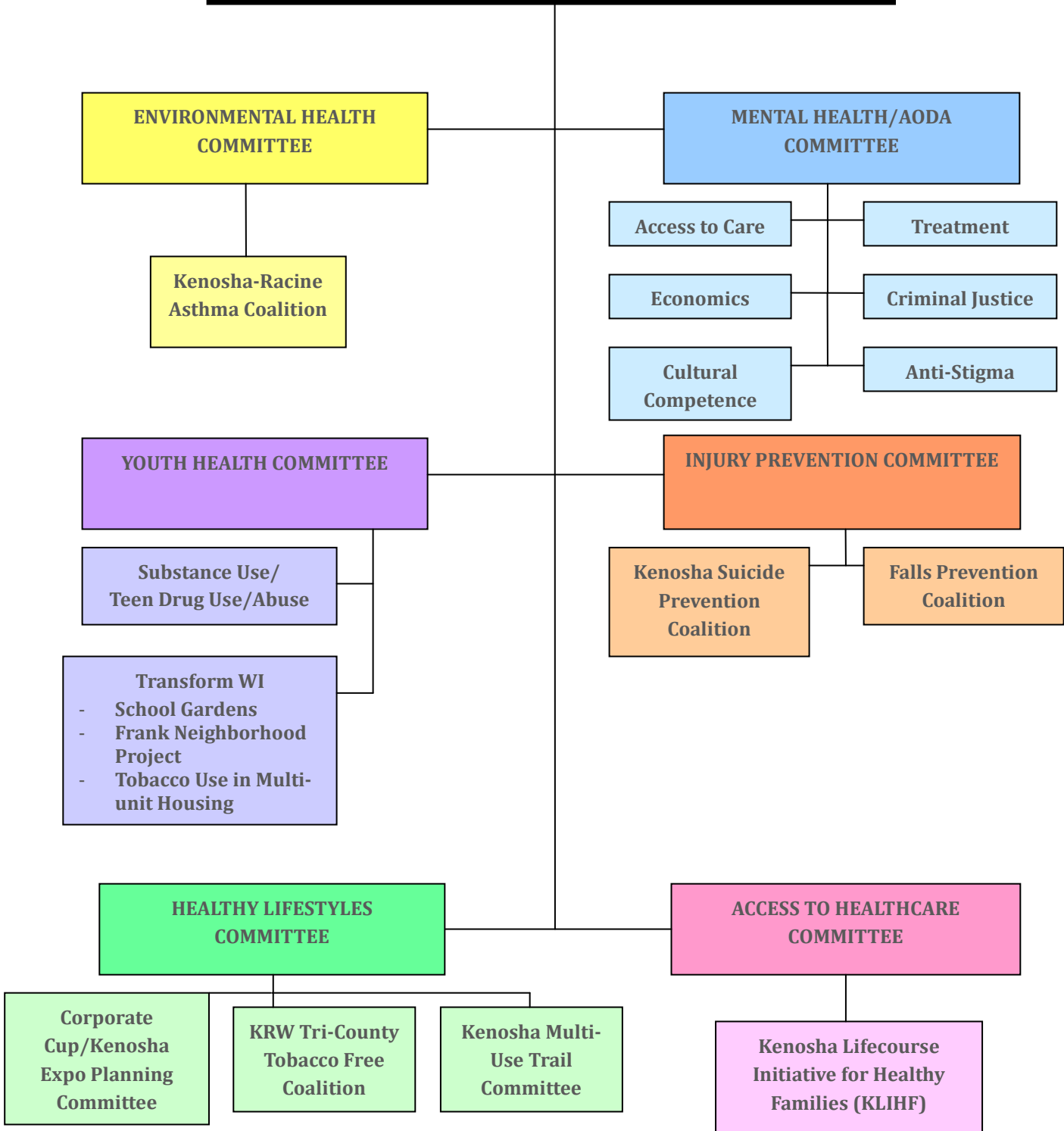

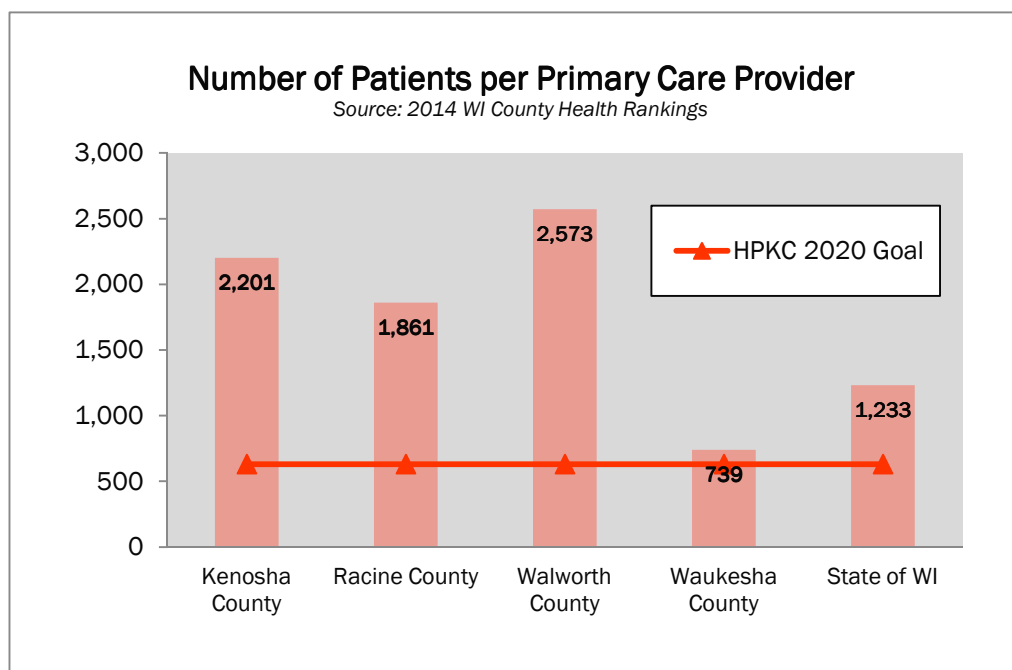

COMMITTEE HIGHLIGHTS:

- Access to Health Care Committee:
 - o Coordinated outreach of information on the Affordable Care Act and BadgerCare reform changes to the community.
- Kenosha Lifecourse Initiative for Healthy Families (KLIHF):
 - o Engaged multi-sector Collaborative of 110 stakeholders since 2010.
 - o Attracted \$650,000 in LIHF grants awarded to four community partner organizations:
 - Centering Prenatal Program – group prenatal care
 - Dismantling Racism Initiative – health and socioeconomic equity
 - Fatherhood Involvement Initiative – support father engagement during pregnancy and childhood
 - Healthy Families Kenosha – home visiting and parent education
- Kenosha County Division of Health:
 - o Held the 6th Annual Kenosha Immunization Symposium to discuss vaccine policy changes. Continued to talk with providers on the importance of accurate and timely entry into the Wisconsin Immunization Registry (WIR).

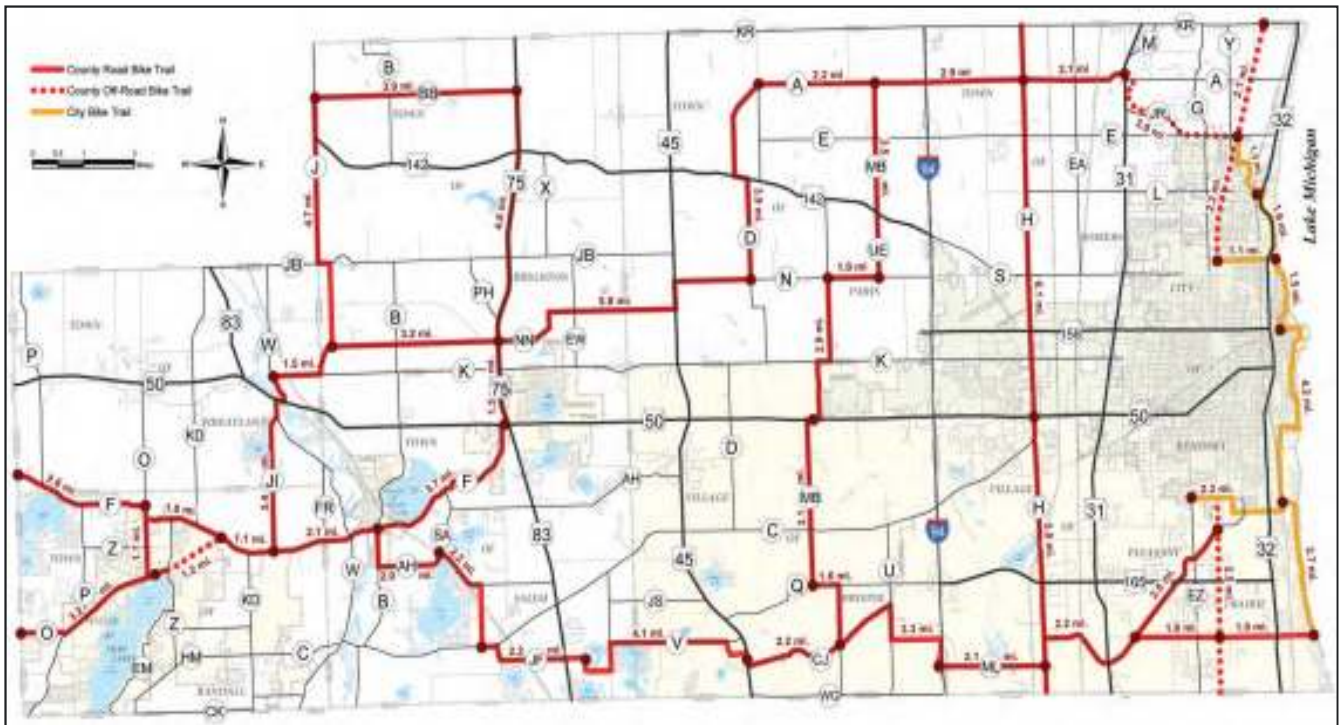
COMMITTEE HIGHLIGHTS:

- Healthy Lifestyles Committee:
 - o 15 companies participated in the 2013 Corporate Cup Event.
- KRW Tri-County Tobacco Free Coalition:
 - o Continued to work with landlords to promote smoke-free multi-unit housing. Conducted education on other tobacco products (OTP's) and lobbied for tax parity for OTP's.
 - o Kenosha County rate for WI Wins compliance checks dropped from 7.3% in 2012 to 3.4 % in 2013. Decrease in local retailers selling tobacco products to youth.

- Multi-Use Trail Committee:
 - o Developed and distributed the Comprehensive Bike Plan for Kenosha County and coordinated a County Multi-Use Trail Committee.
- Transform WI Grant:

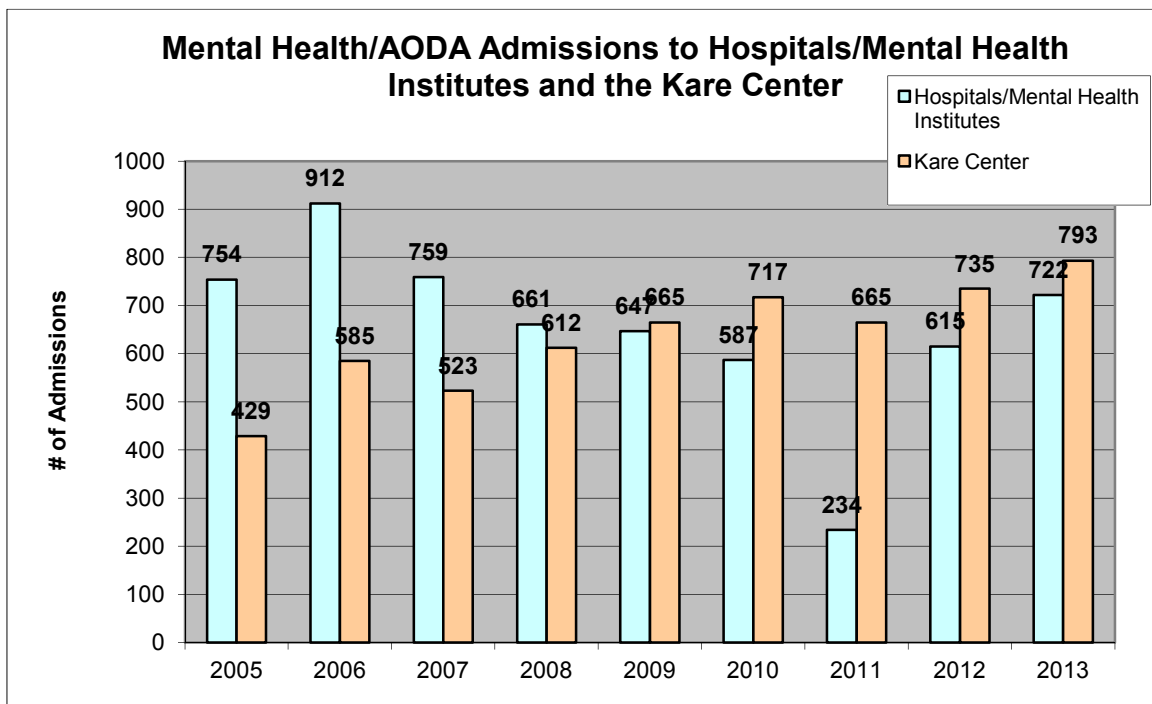
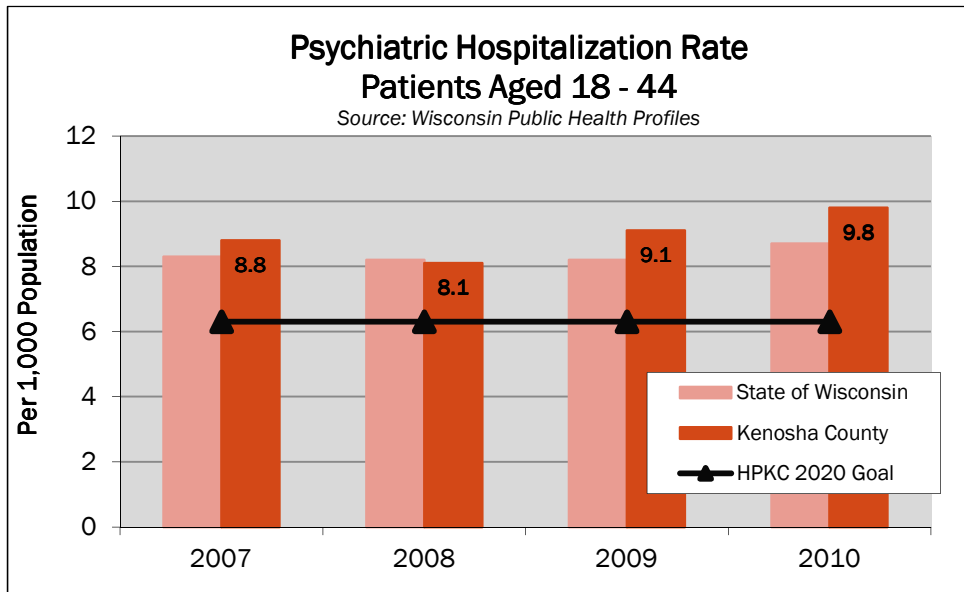

COMMITTEE HIGHLIGHTS:

- Mental Health Committee:
 - o Educated the public and advocated relative to provisions in the state budget that would affect persons with mental illness. One item was removed from the budget, with the help of advocates from Kenosha County, that could have resulted in over 500 people losing their Medical Assistance.

HEALTHY PEOPLE KENOSHA COUNTY 2020

- Encouraged the temporary addition of a position in the Mental Health Resource Center to help mental health consumers with enrollment in Badger Care and the Marketplace.
- Efforts to improve services for Hispanic persons were improved with outreach efforts of the Hispanic Outreach Committee and the addition of Spanish speaking staff at the Mental Health Resource Center.
- Strategic Prevention Framework Partnership for Success II (SPF PFS II) Grant:
 - Coordinate 6 permanent medication collection boxes in Kenosha County for the community to dispose of expired and unused prescription/over the counter drugs.
 - Developed a harm reduction video that will be shown to all inmates in the Kenosha County Detention Center. The video was produced as a result of a number of community members dying from opiate overdoses after recently being released from jail. Another CHANCE is an acronym for:
 - C- Clean needles
 - H-Have a taste (start low and go slow)
 - A-alone don't do it
 - N-Naloxone, be sure to have it available
 - C-Community supports, know where to go for help
 - E-Educate yourself on the dangers of overdose
 - Coordinated a meeting with local Judges to discuss the prevention activities occurring. All local law enforcement agencies were there along with several Kenosha County Judges, Public Defenders and the District Attorney's Office.
 - Presented during the 2013 Red Ribbon Week annual Meeting. There were 80 community members present. The presentation included the dangers of prescription drug abuse, where to get help in our community and how to help prevent teens from getting access to your prescription medications.
 - ARIDE - Advanced Roadside Impaired Driving Enforcement was provided to 14 officers (4 from Kenosha County). This training is the first step before being eligible to become a DRE, Drug Recognition Expert. These trainings allow law enforcement officers the ability to address the gaps between standard Field Sobriety testing and Drug Classification.
 - Held an Anti-Heroin Summit entitled "*Why Didn't I See it?*" *Waking Up from Every Parent's Nightmare*. There were over 125 community members in attendance.

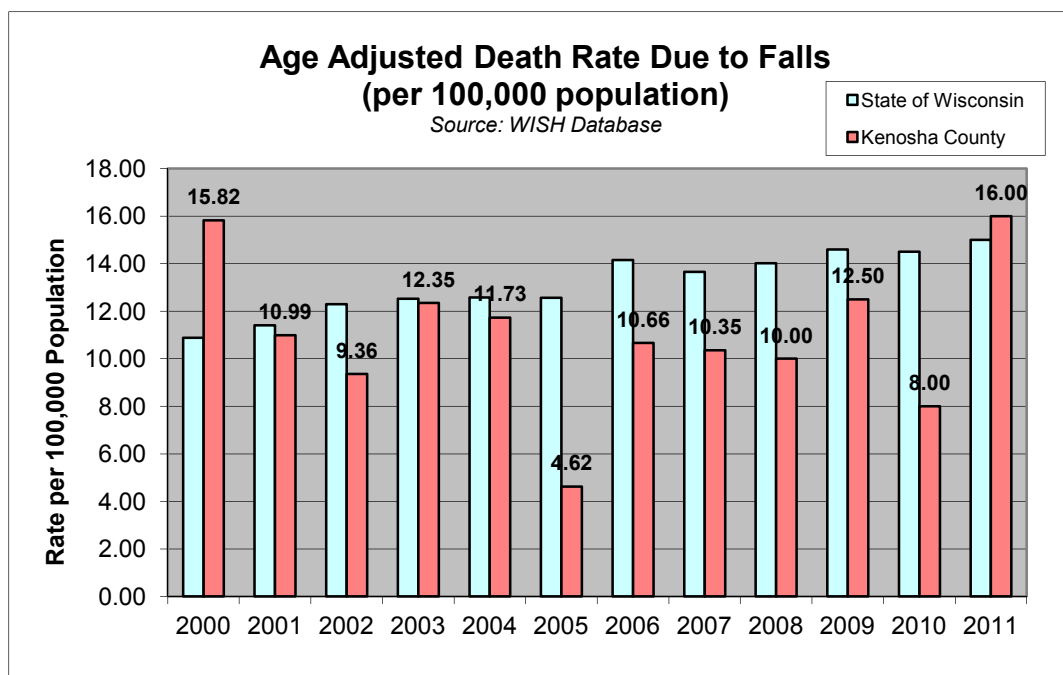

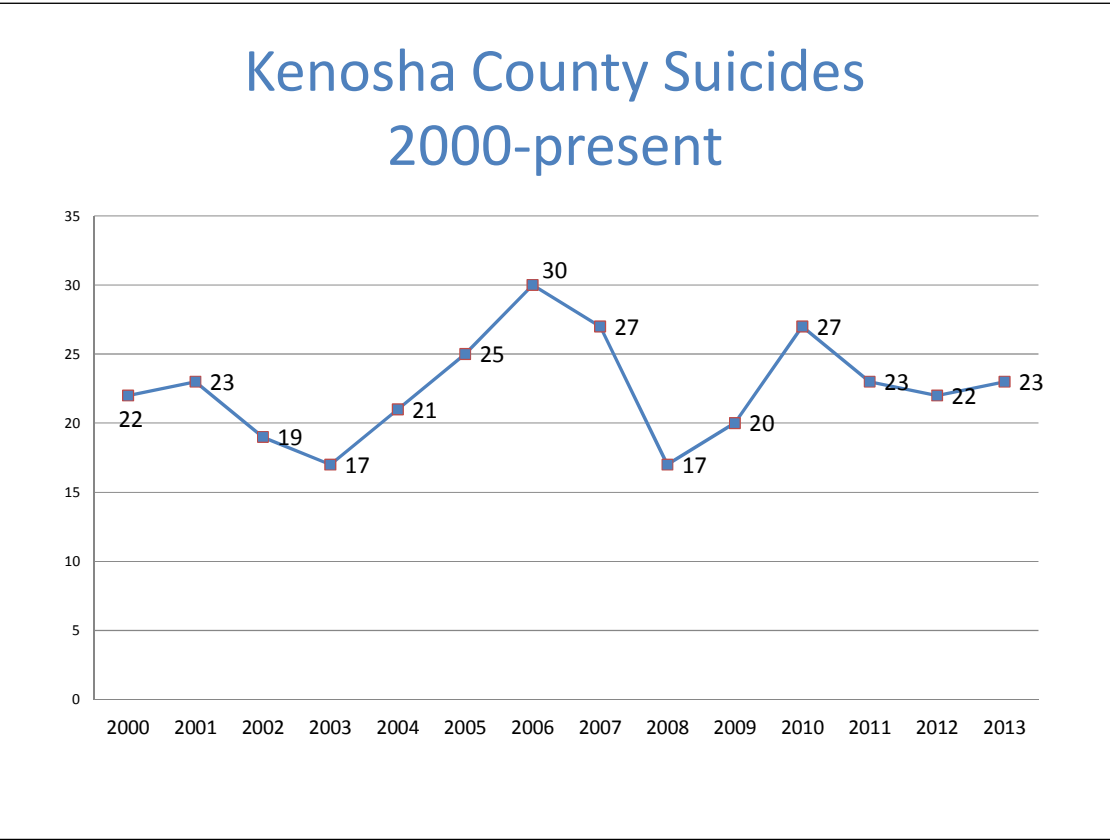
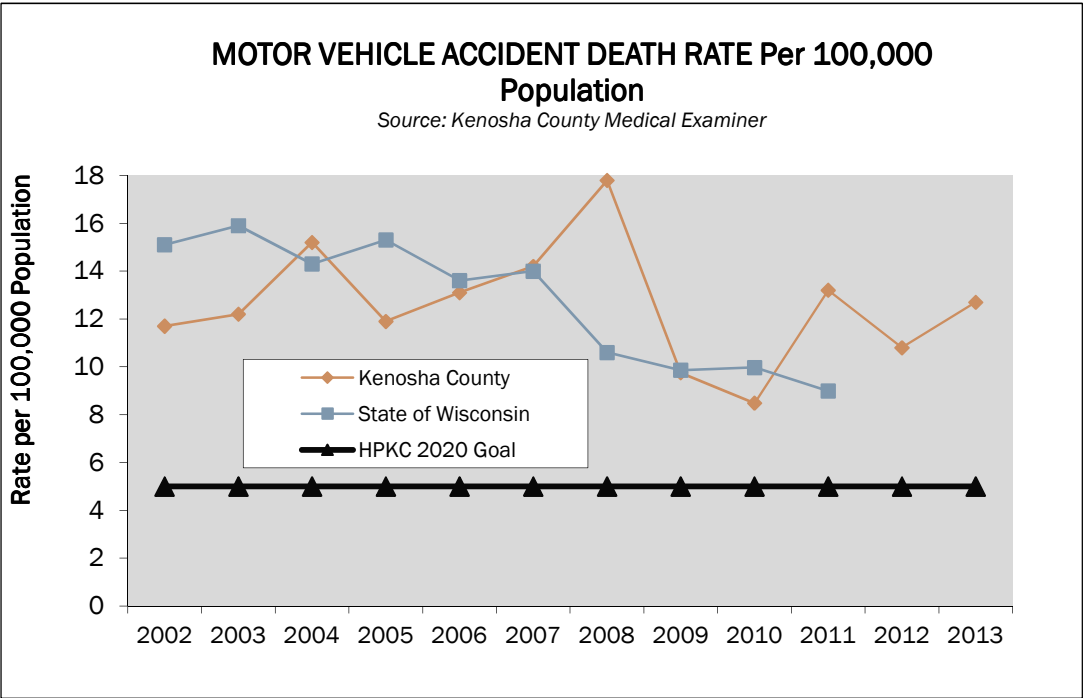

COMMITTEE HIGHLIGHTS:

- Kenosha County Suicide Prevention Initiative
 - o 2,416 lbs. of medication collected through the four permanent medication collection boxes.
 - o 2,733 cable gun locks distributed.
 - o 25 new members added to the coalition.
 - o Self-Harm and Death Analysis Review Team (SDART) was formed and met multiple times.
 - o 1,067 individuals trained in Question, Persuade, and Refer (QPR).
 - o Received a grant to participate in the Mantherapy Campaign.
 - o Clergy Summit held.
 - o College Advisory Board was formed and discussed creating a web based directory of support groups.
- Kenosha County Falls Prevention Coalition
 - o Formed to work within the community to educate consumers and professionals about reducing the risk of falls and helping people to remain independent at home as long as possible.
 - o Website developed with local falls prevention resources and a falls risk assessment.

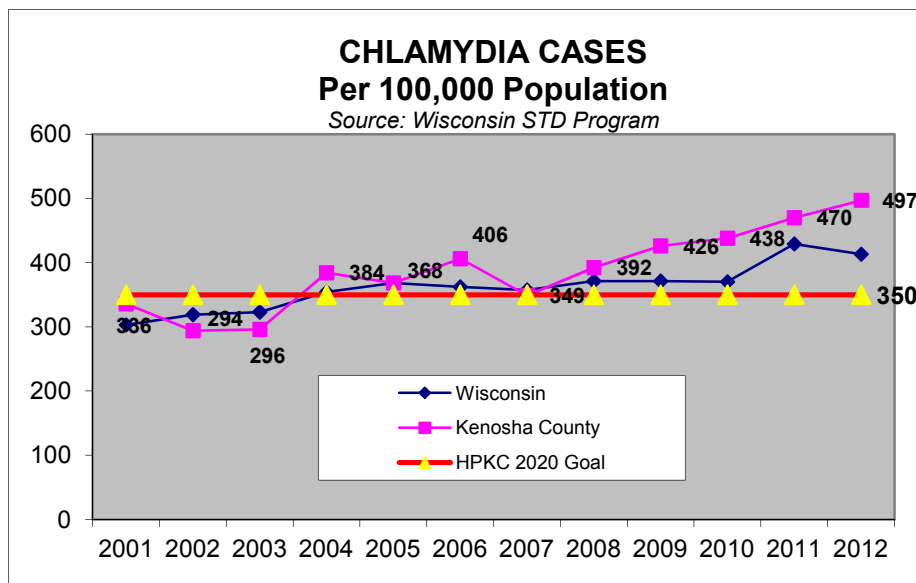

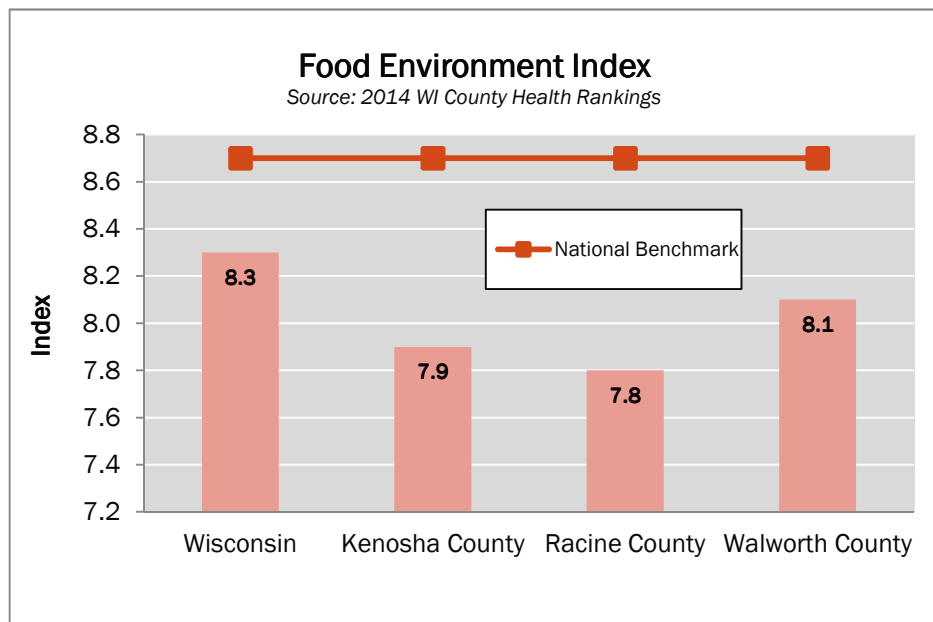

 - o Focused on farm to school which is food/nutrition education, local procurement, and school gardens.

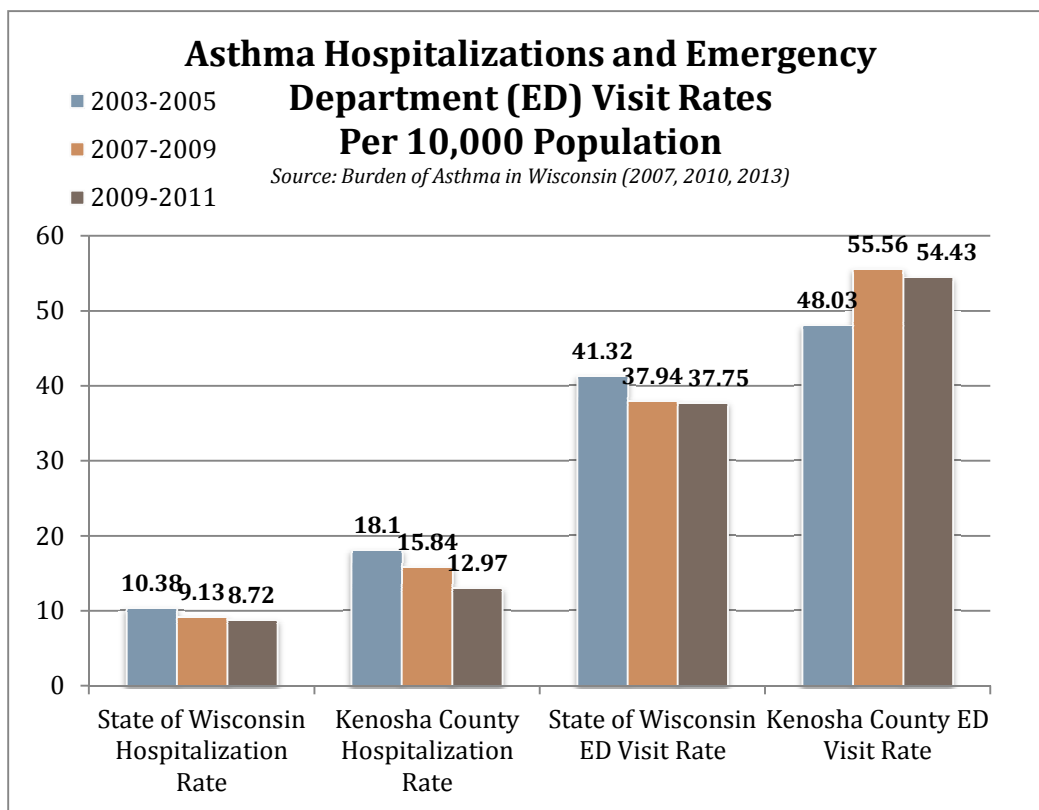

- Kenosha/Racine Asthma Coalition:
 - o Participated in the Wheaton Franciscan Health Fair.
 - o Held Asthma 101 Training for Kenosha Unified School District Staff as part of a school in-service.
 - o Met with local pharmacies about implementing the Asthma Care Fax.
 - o Expanded membership to include EPA Region 5 representation.
