**Rules:**

1. Up to two individuals will be honored in 2014 that contributed to Floral Park between 1990 and present. An unlimited number of individuals can be honored that contributed to Floral Park prior to 1990.
2. All current and past residents of Floral Park may make nominations. Nominators may nominate one post-1990 individual and any number of pre-1990 individuals for this 2014 inaugural year.
3. Nominations will be accepted until midnight, August 30, 2014. **They may be mailed to FPNA, PO Box 11366, Santa Ana, CA 92711-1366 or conveyed to a member of the FPNA board of directors.**
4. A selection committee consisting of FPNA board members, immediate past board members, all past board presidents and one at-large member selected by the board will deliberate and select the Legacy Award nominees that will be honored during 2014. A final 2/3rds vote is necessary to achieve induction status.
5. A formal induction ceremony will be held in December at Sarah Mae Downie Park coinciding with the annual FPNA Holiday Party scheduled for December 13, 2014.

**Criteria for the Floral Park Neighborhood Association Legacy Award**

The Floral Park Legacy Award may be awarded annually to one or more individuals who have made lasting and significant contributions to the quality of Floral Park. The contribution can come in the form of leading or participating in an initiative, work, project or committee that has added to the historic, social or aesthetic quality of the neighborhood or to the mission of the Floral Park Neighborhood Association. A single very significant contribution or a series of contributions is sufficient to warrant consideration for the award.

An individual does not have to be a resident of Floral Park to be considered for the award. For instance, a builder, business person, political figure or community leader that provided distinguished and lasting contributions of significant value to Floral Park is qualified for consideration.
