GHAREF Hospital Engagement Network Program

GHAREF has been awarded a Centers for Medicare and Medicaid Services (CMS) Hospital Engagement Network (HEN) through the Center for Medicare and Medicaid Innovation (CMMI). The GHAREF HEN will receive funding to coordinate the implementation of projects under the CMS Partnership for Patients initiative. Based on the Institute for Healthcare Improvement's (IHI) model, the Partnership for Patients is a public-private partnership aimed at reducing hospital injuries and complications by 40% and hospital readmissions by 20% over a three-year period.

Based upon our successful proposal, CMMI has contracted with GHAREF to support Georgia hospitals' efforts to achieve the goals of the Partnership for Patients: improving the quality of care and patient safety while lowering costs. As a Hospital Engagement Network, GHAREF will:

- Design intensive programs using nationally recognized consultants to teach and support Georgia hospitals in making care safer;
- Conduct training for Georgia hospitals and care providers;
- Provide technical assistance for Georgia hospitals and care providers; and
- Establish and implement a system to track and monitor Georgia hospital progress in meeting quality improvement goals.

Purpose

This workshop will focus on how to implement a root cause analysis to facilitate rapid cycle improvement in your hospital. Participants will learn about methods to simplify the process, how to conduct an RCA, and will work in groups to go through a Root Cause Analysis on identified issues.
