THE CAUSE: Since 1985, the Tooele Art's Festival has been providing great art, entertainment, food, and fun to the community. The entire arts festival is free to the public thanks to wonderful sponsors and year-round fundraising efforts (like this 5k).

THE COURSE: The 5K course is a flat, out-and-back on the Mid-Valley Trail to the west of Tooele and basically consists of gravel roads. The roads are accessible for runners, walkers, and parents pushing strollers. The 5K will start at 9:30AM. The Kids K course is a short out-and-back, also on the Mid-Valley Trail, starting at 9:00AM.

DIRECTIONS:

- From I-80, Lake Point or Stansbury Park: From SR 36 turn west to SR 138. Turn South on Sheep Lane; proceed to intersection with SR 112. Turn east on SR 112 and continue 2.11 miles to Rogers Road.
- From Grantsville: Drive east towards Tooele on SR 112. Rogers Road is located 2.11 miles east of Deseret Peak Complex.
- From Tooele: Drive west towards Grantsville on Utah Avenue. Rogers Road is located .88 miles past the railroad crossing.

SPECIFICS:

There will be water along the course with goodies at the finish for both 5K and Kids K finishers.

Awards will be presented to the top finisher in each age group.

Unfortunately, t-shirts will not be available this year.

PERMISSION AND WAIVER OF LIABILITY AND INDEMNITY AGREEMENT

DESCRIPTION AND LOCATION OF EVENT

DATE RELEASED SIGNED

In consideration of being permitted to enter for any purpose any **AREA** (herein defined as including but not limited to the concessions and other areas appurtenant to any area where any activity related to the event shall take place), or being permitted to compete, officiate, observe, work for , or for any purpose participate in any way in the event, **THE UNDERSIGNED**, for himself/herself, his/her personal representatives, heirs, and next of kin, acknowledges, agrees, and represents that he/she has, or will immediately upon entering any of such restricted areas, and will continuously thereafter, inspect such restricted areas and all portions thereof which he/she enters and with which he/she comes in contact, and he/she does further warrant that his/her entry upon such restricted area or areas and his/her participation, if any, in the event constitutes an acknowledgment that he/she has inspected such restricted area and that he/she finds and accepts the same as being safe and reasonably suited for the purpose of his/her use, and he/she further agrees and warrants that if, at any time, he/she is in or about restricted areas and he/she feels anything to be unsafe, he/she will immediately advise the officials of such and will leave the restricted areas:

1. **HEREBY RELEASES, WAIVES, DISCHARGES AND COVENANTS NOT TO SUE** the promoter, participants, any persons in any restricted area, promoter, sponsors, advertisers, owners and lessees or premises used to conduct the event and each of them, their officers and employees, all for the purposes herein referred to as Releasees, from all liability to the undersigned, his/her personal representative, assigns, heirs, and next of kin for any and all loss or damage, and any claim or demands therefor on account of injury to the person or property or resulting in death of the undersigned, whether caused by the negligence of the releasees or otherwise while the undersigned is in or upon the restricted area, and/or, competing, officiating in, observing, working for, or any purpose participating in the event;

2. **HEREBY AGREES TO INDEMNIFY AND SAVE AND HOLD HARMLESS** the releasees and each of them from any loss, liability, damage, or cost they may incur due to the presence or the undersigned in or upon the restricted area or in any way competing, officiating, observing, or working for, or for any purpose participating in the event and whether caused by the negligence of the releasees or otherwise.

3. **HEREBY ASSUMES FULL RESPONSIBILITY FOR AND RISK OF BODILY INJURY, DEATH OR PROPERTY DAMAGE** due to the negligence of participant or otherwise while in or upon the restricted area and/or while competing, officiating, observing, or working for or for any purpose participating in the event.

EACH OF THE UNDERSIGNED expressly acknowledges and agrees that the activities of the event are very dangerous and involve the risk of serious injury and/or death and/or property damage. **EACH OF THE UNDERSIGNED** further expressly agrees that the foregoing release, waiver, and indemnity agreement is intended to be as broad and inclusive as is permitted by the law of the Province or State in which the event is conducted and that if any portion thereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect.

EACH OF THE UNDERSIGNED HAS READ AND VOLUNTARILY SIGNS THE PERMISSION AND WAIVER OF LIABILITY AND INDEMNITY AGREEMENT, and further agrees that no oral representations, statements or inducements apart from the foregoing written agreement have been made.
