

ORDER RE PETITION FOR WRIT OF HABEAS CORPUS

for a Writ of Habeas Corpus

Petitioner herein is confined at San Quentin State Prison, having been sentenced to a term of seven years to life.

In this, his most recent petition for a writ of *habeas corpus*, <sup>1</sup> Petitioner contends that he is overdue for his next parole hearing. On March 3, 1999, the Board of Prison Terms (hereinafter, "the Board") denied him parole for two years. Under the language of Penal Code §3041.5(b)(2), Petitioner was entitled to have his next hearing no later than March 3, 2001. Apparently that hearing has not taken place, nor has it been scheduled. Therefore, this court concludes that the Board is slightly in violation of the requirements of Penal Code §3041.5(b)(2).

The Board is ordered to convene Petitioner's next biennial parole hearing within 120 days from the date of this order.

The petition also claims that Petitioner should immediately be released from custody because he should have been found suitable for parole at his last hearing in
