	b) This Rider does not relieve Seller of Seller's obligations under Standard "W" for facts known to Seller. However, except as required in this Rider and in Standard "W", Seller extends and intends no warranty and nakes no representation of any type, either express or implied, as to the physical condition or history of the Property.
	c) Seller has received no written or verbal notice from any governmental entity or agency as to a currently incorrected building, environmental or safety code violation.
	d) Subject to the provisions and limitations of this Rider, Buyer waives any claims against Seller and, to the extent permitted by law, against any licensee involved in the negotiation of the Contract, for any defects or other damage that may exist at Closing of the Contract and be subsequently discovered by the Buyer or anyone claiming by, through, under or against the Buyer.
2.	nspection Period and Right to Cancel.
	a) Buyer shall have days from the Effective Date (Inspection Period") within which to have such aspections of the Property performed as Buyer shall desire and utilities shall be made available by the Seller luring the Inspection Period.
	b) Buyer shall be responsible for prompt payment for such inspections and repair of damage to and estoration of the Property resulting from such inspections. This provision shall survive termination of the Contract.
	c) If Buyer determines, in Buyer's sole discretion, that the condition of the Property is not acceptable to Buyer, Buyer may cancel the Contract by delivering facsimile or written notice of such election to Seller within 8 hours after the expiration of the Inspection Period. If Buyer timely cancels the Contract, the deposit(s) paid shall be immediately returned to Buyer; thereupon, Buyer and Seller shall be released of all further obligation under the Contract, except as provided in Subparagraph 2.(b), above.
