## **Championship Tournament Rules & Regulations 2014**

- The Annual Championship Tournament is sponsored by NCUSBCA and is open to all current NCUSBCA members who are bowling in a NCUSBCA certified league. This tournament will be governed by all rules set forth by the NCUSBCA and USBC.
- 2. Squad Times: All team members and both members of doubles team must check in with tournament officials at least thirty (30) minutes prior to squad time and must show current USBC membership card. All substitutes in team lineup must be made one (1) hour prior to scheduled squat time. Squad times are as follows:
  - Team: Saturday, March 1, 2014, 10am and 2pm; Sunday, March 9, 2014, 10am and 2pm.
  - Doubles/Singles: Sunday, March 2, 2014; 10am and 2pm, and Saturday, March 8, 2014, 10am and 2pm.
- Locations: Team Event: Base Bowling Center, Bldg 1339, Camp Pendleton, CA 92055; 760-725-6109.
   Doubles/Singles Event: Surf Bowl, 1401 South Coast Highway, Oceanside, CA 92054; 760-722-1371.
- 4. Entry Closing Date: Tuesday, February 25, 2014, 9:00 PM.
- Mail In: Mail completed entry, fees, and needed verifications to: NCUSBCA, Nancy A. Arvanitis, Association Manager, 4212 Vista Del Rio Way, #8, Oceanside, CA 92057. 760-231-8676. Make checks or money orders payable to: NCUSBCA. There will be no refunds after entries have been received, processed and scheduled. If check is returned, a \$25.00 fee will be assessed. Mail in entries must be postmarked no later than February 25, 2014.

#### 6. Entry Fees: Adult

- a. Team Event: \$9.00 Lineage; \$1.00 Expense, \$10.00 Prize Fund=\$20.00 per person.
- b. Singles Event: \$7.50 Lineage, \$1.00 Expense, \$11.50 Prize Fund=\$20.00 per person.
- Doubles Event: \$7.50 Lineage, \$1.00 Expense, \$11.50
   Prize Fund=\$20.00 per person.

## 7. Entry Fees: Youth

- a. Team Event: \$9.00 Lineage, \$1.00 Expense, \$5.00 Scholarship Fund=\$15.00 per person.
- b. Singles Event: \$7.50 Lineage, \$1.00 Expense, \$6.50 Scholarship Fund=\$15.00 per person.
- c. Doubles Event: \$7.50 Lineage, \$1.00 Expense, \$6.50 Scholarship Fund=\$15.00 per person.
- 8. All Events: Adult and Youth: \$5.00 optional prize fund.
- 9. <u>Handicap</u>: Handicap is based on 100% of 230.
- 10. Entering Averages: ADULT: In the following order:
  - a. 2012-2013 Highest Certified Average, if none,
  - b. 1/1/2014 Highest Certified Average of 21 or more games, if none,
  - 2013 Summer Highest Certified Average of 21 or more games, if none,
  - d. Scratch (230).
  - e. If bowler's current or summer average is ten (10) or more pins higher than bowler's 2012-2013, then current average must be used per USBC Rule 319a. <u>This rule</u> also applies to Youth Bowlers.
  - f. Any bowler who has ONLY A USBC SPORT AVERAGE must submit and use his/her adjusted SPORT LEAGUE average utilizing the USBC Average Adjustment Scale.
  - g. USBC RULES SHALL BE WAIVED: 319d (Reporting Prior Prize Winnings), 319c (Average adjustment for entry, 319f (Canadian Tenpin Federation Averages).
- Multiple Entries: Team: Any four bowlers, three games.
   No more than two bowlers may compete more than once in

- Team Event. The first score bowled in Team Event will count towards All Events. Doubles/Singles: Any two bowlers, three games doubles then three games singles on adjacent pair. No individual shall be eligible to bowl more than once in Doubles & Singles Event. If a bowler enters the singles event, they must also enter doubles event. Substitutions may be made in case of emergency.
- 12. <u>Prize Fund:</u> Team/Doubles/Singles prize fund payout will be based on one (1) in six (6) ratio. All Events payout will be based on a one (1) in twelve (12) ratio. All youth prize fund will be in the form of Scholarships sent to the SMART fund held at the National USBC.
- 13. <u>Lane Courtesy:</u> Single Lane courtesy will be observed.
- 14. Only the team captain who signs the entry form may make changes in the schedule and this must be done in person, by signed letter, or in the association office at association address or at tournament site.
- 15. <u>Rule 11 Forfeit- Delay of Game:</u> No unreasonable delay in the progress of any game is permitted. If a player or team refuses to proceed with a game after being directed to do so by the tournament official, the game or series shall be declared forfeited.
- 16. Rule 12 Approaches Must Not Be Defaced: The application of any foreign substance on any part of the approach that detracts from the possibility of other players having normal conditions is prohibited. This includes but is not limited to talcum powder, pumice, and resin on shoes, and/or soft rubber soles or heels that rub off onto the approach.
- 17. Rule 17: Grounds for Disciplinary Action (17b) Improper Conduct: Bowlers may be subject to disciplinary action for improper conduct. Disciplinary action may include removal from the tournament and/or loss of games and/or prize winnings. Improper conduct includes, but is not limited to, physical and verbal abuse toward other persons, foul or vulgar language, damage of center equipment (hitting/kicking ball returns, tables, chairs or score consoles), harassment, and unfair tactics.
- 18. Rule 18: Bowling Ball Altering Surface: Altering the surface of a bowling ball by the use of abrasives while bowling in USBC competition is prohibited. All bowling balls so altered must be removed from the competition.

  NOTE: If it is shown the bowler had prior knowledge his/her actions were in violation of Rule 18, the game(s) in which the violation occurred is (are) subject to forfeiture. In addition, the bowler is subject to dismissal from the tournament and suspension of membership. Competition is defined as the remainder of the current game and remaining game(s) in the series being bowled. The use of USBC approved cleaning agents and polishing machines is permissible.
- 19. <u>Rule 303 Management:</u> Tournament management has supervisory control of all technical parts of the operation of the tournament including the following:
  - a. Drafting the schedule and prize list.
  - b. Enforcing the tournament rules provided they are not in conflict with any USBC rules.
  - Deciding all disputes, complaints, or protests involving any USBC or tournament rules, or appeals from the decision of tournament personnel.
  - Deciding any matter about the operation of the tournament, when inconsistent with the tournament rules or USBC rules.
  - e. Accepting or rejecting any entrant. The decision of tournament management shall be final except where an appeal is made to local association or USBC Headquarters. (See Rule 329 for appeal procedures).


- 319a. Conditions that Apply: The following conditions apply
  to averages in handicapped or classified tournaments, unless
  the tournament rules state otherwise, except that only USBC
  league averages shall be accepted. (This rule does not
  apply to Youth).
  - Individual averages must be based on a minimum of 21 games in a USBC league.
  - b. When the previous season's average is used, and at the time of bowling an entrant has a current average for 21 or more games that is 10 pins or more higher than the prior season's average, the current average must be used
  - c. Bowlers are responsible for verifying his/her own average, whether submitted by the bowler, the team captain or others. If the submitted average is lower than required and results in a lower classification or more handicap, the bowler's score is disqualified. If the submitted average is higher than required, prize winnings will be based on the submitted average. In the case of a team of two or more bowlers, the averages will be combined to determine if the correct total is higher or lower than the submitted total.
  - d. Average corrections can be made up to the end of the bowler's first game of a series. Or, if an extension of time has been granted in writing by tournament management before the end of the first game of a series, the correction can be made within 48 hours after the end of the series.
  - e. When an association publishes a yearbook, a tournament using previous season averages to determine handicap or classification, shall use the yearbook to verify averages, if furnished, and not require the association to verify averages from that association
- 21. <u>USBC Rule 319c Average Adjustments (Rerating)</u>: The average of a bowler may be adjusted upward before participation in any event. If the assigned average is not accepted by the bowler, the entry fee shall be refunded.
- 22. Rule 323 Pacers No pacers allowed.
- Rule 324 Lineup Changes: No changes in lineup permitted once entrants are scheduled.
- 24. <u>Rule 328 Changing Delivery:</u> In the tournament, once the bowler has declared which hand and entering average for said hand and has taken his/her first shot, he/she shall continue to use that hand throughout the tournament unless, due to injury, the bowler finds it impossible to continue with the same hand. The bowler may seek approval of the tournament director to continue with the opposite hand.
- Rule 329 Protests and Appeals: Protests and appeals
  must be in writing stating the grounds for the protest or
  appeal.
  - A protest involving eligibility or playing rules must be filed with tournament management and:
    - Adult Tournaments: Within 72 hours of the infraction, or prior to tournament prizes being paid, whichever occurs first.
    - Youth Tournaments: Within 72 hours of the infraction.
  - b. The decision of the tournament management shall be final, unless a written appeal is filed with the local association or USBC Headquarters and:
    - Adult Tournaments: Within 10 days of notification of tournament management's decision
    - Youth Tournaments: Within 72 hours of notice of the decision.

- Upon notification of a protest or appeal, tournament director must withhold all affected prizes until the protest or appeal is resolved
- The decision of the local association may also be appealed to USBC Headquarters. The decision of the USBC Headquarters is final and binding on all involved parties.
- 26. NCUSBC Dress Code: The following is not authorized for wear or on equipment; no blue tooth devices of any type, no ear buds/head phones, no sexual or profane advertisements, soiled trousers, trousers with holes/rips, tank-tops, see through garments, halter-tops, strapless tops, shirts or t-shirts with profanity, drug paraphernalia pictures, pictures of an explicit nature, tobacco, alcohol, bike shorts, sweats, spandex, short skirts (no more than 4" above knee), "cut-offs" or short shorts of any kind etc. No hats, bandanas or doo rags will be worn at any time during tournament play unless a valid medical reason is given.
  - a. The use of IPODS, CD players or any other electronic listening device is prohibited!! EXCEPTION: Must be deemed necessary for an autistic person and approved by the Tournament Director prior to competition.
  - The use of cell phones must NOT interfere with the tournament (bowler must bowl when it is his/her turn).
     All phone calls and text messaging must be done on the concourse area.

# TOURAMENT DIRECTOR HAS FINAL SAY IN ALL DRESS CODE ISSUES!!!!!

The penalty for violation of any portion of these rules shall be possible suspension from USBC. Such suspension shall remain in force until removed by the legal committee of the USBC.

A Contract of Mutual Responsibility: To the Tournament Director of the 7<sup>th</sup> Annual Championship Tournament, acting for those whose names appear on the entry form. I hereby enter those listed in the events, indicated and all agree to abide by the tournament and playing rules and regulations prescribed by the NCUSBC, including all provisions set forth on the entry form, together with the playing rules and regulations of the United States Bowling Congress. Entry fees as shown on this entry form are herewith enclosed for the events entered. The entrants, whose names appear hereon or their authorized substitutes, hereby agree that the NCUSBC, its Officers and other agents shall be liable only to the extent of returning entry fees if and when this Team shall be prevented from bowling any event in this Tournament, which may be brought about by fires, strikes, lockouts, labor difficulties or other causes beyond the control of the NCUSBC. "Premature termination of the Tournament brought about by war, national emergency causes relating thereto or there from fires, strikes, lockouts, labor difficulties or other reasons beyond the control of the NCUSBC shall cause the foregoing prize schedule to be prorated in accordance with the number of entrants who have bowled in each of the respective events up to the time of termination"
