

RENTAL APPLICATION

APPLICATION STANDARDS

All applicants pass through a screening process:

- 1. **Income Level** A gross income of at least 3 times the monthly rent amount is required. Submit a paystub from your current employer. If self-employed, submit tax returns for the past two years.
- **2. Credit History** To determine satisfactory credit, we run a report through a credit report agency. Credit history from the past two years will be evaluated.
- 3. Rental History Will verify your past and current rental history. Prior evictions will result in a denial.
- **4. Criminal History** To determine a successful background check, criminal history will be processed. Prior felonies will result in a denial.
- 5. Pets -Breeds of dogs not accepted at any of our properties include: Chow, Pit Bull, Doberman, and Rottweiler. We charge a \$150 non-refundable pet fee and a pet rent of \$20 per month for all normal pet situations.
- **6. Smoking** We do not allow smoking inside any of our homes.
- **7. Identification** We require you to show a valid driver's license prior to completing the application and require a *copy* of your license or government issued ID upon approval, prior to signing the lease.
- **8. Occupancy Standard** We follow the suggested occupancy standard of two people per bedroom. In excess of that are grounds for denial.

*ONCE APPROVED, THE HOLDING/EARNEST DEPOSIT WILL BE DUE WITHIN 48 HOURS IN ORDER TO TAKE THE HOME OFF THE MARKET AND HOLD IT FOR YOU UNTIL THE MOVE-IN DATE.

APPLICATION & ADMIN FEE
