## Your Pension Benefits are <u>SAFE</u>

Just like clockwork, the critics of public defined benefit pension plans routinely hit the news with assertions that state-sponsored pension systems are in deep financial trouble, and are soon going to run out of money to pay benefits. Such is the case in a recent article that appeared at an internet news site claiming that Oklahoma state pension plans will run out of money in the year 2020. Commenting on a study by two college professors from a prestigious Big Ten university, the internet article did not specifically name the Oklahoma Teachers' Retirement System as the reason for the gloom and doom prediction, but since TRS is the biggest and most poorly funded of Oklahoma's pension systems, it had to be the target.

Once more, let's refute the study's thesis with respect to TRS. The Teachers' Retirement System will not run out of money in 2020, and it will be able to continue making benefits payments in full for decades to come. Proof of that is the recent annual actuarial study for the retirement system, in which the actuaries presented their projections that the system, with no changes in current fundamental assumptions, will be able to pay out benefits all the way through the year 2050. Even at that date the system will still have billions in assets and a projected funding level of 28.9%. Of course, that would be a decline of about 19% from the current funding level, but nowhere near the exhaustion of funds predicted by the professors' study.

In the interest of full disclosure, OREA believes that TRS is poorly funded. It needs more money, and plenty of it, to achieve an acceptable level (75-80%) of fiscal health in the next 20-30 years. But, the study highlighted in the internet article is so far off base that it truly warrants one TRS trustee's comment that it was "irresponsible." TRS is not in financial crisis. Responsible leaders making responsible decisions based on sound knowledge of the retirement system can make TRS secure for all present and future retired educators. That's what OREA believes, and that's what we will work to accomplish.

## Board (Partially) Restores TRS "Credit"

At its December regular meeting, the state Board of Education took action to direct \$18 million in funding to the Teachers' Retirement System as partial payment for the TRS retirement "credit" for active educators. Since 1998, the legislature has appropriated \$35 million per year to pay for a fixed dollar amount of TRS contributions required of educators currently employed. The 2010 legislature, however, did not specifically earmark money for the "credit," resulting in a Board decision to divert the funding from its intended purpose toward an additional allocation for school districts to help pay for employee health insurance premiums.

For several months, Board officials and Republican legislative leaders had been at loggerheads over whether enough funding had been provided by the legislature, and where it should have been directed. The Board's action prompted a request from the TRS Board of Trustees for a state Attorney General's opinion. Recently rendered, the AG opinion declared that the funding should have gone to TRS.

OREA supported the action of the TRS Board of Trustees to seek the AG's opinion, and is pleased that at least a portion of the "credit" funding has taken place. The end result of the contentious process is that TRS got some money, but less than it should have. We're not surprised, because that's emblematic of the pattern of long-term neglect of the retirement system by Oklahoma's political leaders.

## Toward a Brighter Future

An improving state economy and shrinking budgetary deficits offer some hope that 2011 and the years

beyond will be better ones for retired educators and all Oklahomans. In contrast to bleak numbers in the 2009-11 budget years, the state Board of Equalization received relatively good news in December from the state Tax Commission and the Office of State Finance.

Preliminary tax figures indicate a revenue shortfall for the

2012 Fiscal Year beginning July 1 of \$226 million or less, contrasted with deficits three times higher each of the last two years. The Board of Equalization will certify final revenue figures in February, on which the legislature will craft next year's state budget.

OREA lobbyists, supported by OREA members, will give it their best shot to achieve an ambitious set of legislative goals recently announced by the Government Relations Committee and Board of Directors. The 2010 elections are behind us, and the task at hand is to work in cooperation with legislators of both parties to promote a positive climate for retired educator progress. Let's work together, not alone, to speak with one strong voice for Oklahoma's retired educators.



1. Protect and improve the Teachers' Retirement System (TRS) defined benefit plan design.

2. Achieve a TRS cost-of-living benefits adjustment (COLA) comparable to other state retirement systems by amending pension statutes to establish the same assumed COLA rate for all systems.

3. Increase the TRS health insurance premium subsidy for retired educators by \$100 per month, and provide individual retirees the option to enroll/reenroll in state-sponsored health insurance programs after initial retirement upon occurrence of a qualifying event.

4. Ensure adequate actuarial funding for the Teachers' Retirement System.

5. Increase from \$5,000 to \$7,500 the death benefit payable to beneficiaries of retired educators.

6. Protect the state's revenue base by balancing any tax cuts with corresponding withdrawals of tax credits.

7. Provide a one-time "catch up" benefits improvement to qualifying retired educators living at or below the poverty level, and who meet years of service criteria.

8. Support adequate state funding for public education at all levels.

OREA has had plenty to say about the defined benefit (DB) versus defined contribution (DC) pension argument before, and we'll have more to say in the future. For the time being, however, let's make clear our belief that a change from the current defined benefit plan design of the Teachers' Retirement System to a defined contribution program would undermine the retirement security of present and future retired educators.

The key words are "retirement security." A DB plan provides retirement security. A DC plan does not. After careers of service to the school children of Oklahoma, retired educators have the right to expect financial security for all their retirement years. They should not have to worry about outliving their retirement money. They should not have to be responsible for making complicated investment decisions on their own, nor should they have to pay exorbitant fees to investment professionals, many of whom have shown in recent years their ability to lose money just like amateurs. OREA believes in personal saving and investing, but it should serve as a supplement to guaranteed income provided through a defined benefit pension plan.

For currently retired educators who believe that a switch from a DB to a DC plan for future retirees not presently in the retirement system will do them no harm, please consider that the likelihood of periodic cost-of-living benefits adjustments (COLAs) for current retirees will diminish significantly if lawmakers succeed in shifting the burden of planning and saving for retirement from the state to the individual.

We'll say more on this issue in the future. Right now we encourage retired educators to have something to say to their legislators today.

## Legislative Makeup Heavily GOP

The 2010 elections tilted political power in the legislature strongly in the direction of the Republican Party. From a 26-22 advantage the last two years, the GOP picked up five additional seats in the Senate to reach a strong 31-16 advantage. Newly elected Lt. Governor Todd Lamb has resigned from the Senate, and a special election will be held soon to choose a replacement. The seat is considered safe for the Republicans, which would provide the party a two-thirds majority.

In the House, Republicans increased their majority from 62-39 from the previous session to 70-31 in 2011, more than a two-thirds majority.

Both the House and Senate will be under new leadership, with Brian Bingman of Sapulpa replacing the termed-out Glenn Coffee as Senate President Pro Tem, and Kris Steele of Shawnee taking over for termed-out Chris Benge as Speaker of the House. Add in Republican Governor Mary Fallin, and you've got a clean sweep when it comes to writing the laws of the state.

The significant electoral shift in recent years has changed the political ball game at the state Capitol. OREA members are encouraged to take note. In particular, in regions of the state where members did not regard lobbying of their Republican legislators as useful when the GOP was in the minority, members are encouraged to become more active players on behalf of the OREA legislative agenda. Your support is needed. In fact, retired educators will not win without you.



The 2011 legislative session begins Monday, February 7, and ends no later than Friday, May 28. ## March 1 Membership to Determine Delegate Allocation

OREA state office records of a local unit's membership as of March 1, 2011 will be used to determine delegate allocation for the 2011 House of Delegates, to be held in conjunction with the Annual State Convention in Tulsa on Friday, May 20. Following the same formula used last year, local units will be entitled to an automatic delegate for their elected president, plus an additional delegate for 2-30 members, or major fraction thereof. Thereafter, an additional delegate will be granted to the unit for every 30 members, or major fraction thereof. Delegates and alternates may be elected at any time, but not later than April 10, with the proper delegate forms filed at the OREA office no later than April 15. The state office will notify local units of their delegate numbers soon after March 1.

April 5 Deadline for Proposed Amendments, Resolutions and New Business

The OREA Constitution Committee has announced an April 5 deadline for member and local unit submission of proposed amendments to the OREA Constitution for possible consideration by the 2011 House of Delegates on May 20.
