AN ORDINANCE AUTHORIZING JEFFERSON COUNTY, MISSOURI, TO ENTER INTO AN AGREEMENT REGARDING CONDITIONS OF PARTICIPATION IN THE HOMEOWNER REHABILITATION PROGRAM (SEXTON) AND AUTHORIZING THE COUNTY EXECUTIVE TO EXECUTE THE AGREEMENT ON BEHALF OF THE COUNTY LOCATED IN COUNCIL DISTRICT 3.

WHEREAS, the United States Congress enacted the housing and community Development Act of 1974 providing federal funds to units of local government for the purposes of developing urban communities and improving housing conditions and community services; and

WHEREAS, Jefferson County, Missouri, (hereafter, "the County") receives federal formula funds annually from The United States Department of Housing and Urban Development under its Community Development Block Grant Program (hereafter, "CDBG"), and is administered by The Economic Development Corporation of Jefferson County, Missouri, (hereafter, "EDC"); and

WHEREAS, the EDC, as Contracted Administrator, operates an Entitlement Program (hereafter, "Entitlement") within the boundaries of Jefferson County, Missouri, which provides funding to local programs that create suitable living environments, decent housing and economic opportunities for low-to-moderate income persons living within the County; and

WHEREAS, the EDC is operated for the purpose of promoting the economic development of the County; and

WHEREAS, the EDC, in its capacity as Contracted Administrator of the Jefferson County Entitlement Program has funds available through the Homeowner Rehabilitation Program to assist low to moderate income families in making repairs to their home in order to meet health and safety regulations and requirements; and

WHEREAS, Orehlia E. Sexton meets the conditions for which she may receive such funds; and

WHEREAS, the County desires to provide these funds to Orehlia E. Sexton to allow her to bring her residence into compliance with health and safety regulations by making repairs to her home.

BE IT ENACTED BY THE JEFFERSON COUNTY, MISSOURI, COUNCIL, AS FOLLOWS:

Section 1. The County is authorized to enter into the Agreement Regarding Conditions of Participation in the Homeowner Rehabilitation Program (hereafter, "Agreement"). The County Executive is authorized to execute the Agreement on behalf of the County with Orehlia E. Sexton. An un-executed copy of the Agreement to be entered into by all parties is attached hereto as Exhibit "A". A copy of the fully executed Agreement shall be filed with, and kept in, the records of the Department of the County Clerk as will a copy of this ordinance.

- f. The requested development plan is consistent with the UDO in that the development plan is designed, located and proposed to be operated so that the public health, safety and welfare will be protected.
- g. The requested development plan is consistent with the UDO in that the development plan will not impede the normal and orderly development and improvement of the surrounding property.
- h. The requested development plan is consistent with the UDO in that the development plan incorporates adequate ingress and egress that provides for the efficient flow of traffic.
- i. The requested modifications to the development plan are in the best interests of the County in that the modifications incorporate sound planning principles and design elements that are compatible with surrounding properties and are consistent throughout the proposed project.
- j. The requested modifications to the development plan are in the best interests of the County in that the modifications effectively utilize the land upon which the development is proposed.
- k. The requested modifications to the development plan are in the best interests of the County in that the modifications further the stated goals and intent of the UDO.

NOW, THEREFORE, BE IT ENACTED BY THE JEFFERSON COUNTY, MISSOURI, COUNCIL, AS FOLLOWS:

Section 1. Application Number: PI13031 is approved for the real estate described as Parcel Numbers 02-3.0-06.0-1-008-014. and 02-3.0-06.0-1-008-015., from Non-Planned Community Commercial (CC-2) zone district to Planned Industrial (PI) zone district; and a development plan for Kleertech Sales is approved subject to the following, approval of modifications to the Code of Ordinances of Jefferson County, Unified Development Order, Chapter 400, Section 400.1590-C, Section 400.1670, Article VII Division 6, Section 400.2250, Section 400.2560, Section 400.2570, Section 400.4050, Section 400.4100 and Section 400.4750, the regulatory requirements and departmental comments:

Modifications

Approval of the requested modification to Article V Section 400.1590-C to reduce the required overall development size for the Planned Industrial Zone District from 5 acres to 1.378 acres.

Approval of the requested modifications to Article V Section 400.1670 to reduce the southern side yard setback from 20 feet to 10 feet.

Approval of the requested modification to Article VII Division 6 to remove the Industrial Design Standards from the development plan.

Front yard – 20 feet, Southern side yard – 10 feet, All other side yards – 20 feet

Signs

Signs shall comply with Article XIII of the UDO. All regulatory signs, including stop signs, speed limit, etc. shall be provided by the developer.

Geotechnical

A geotechnical study prepared by an Engineer licensed in the State of Missouri shall be required where there is more than 5 feet of cut or 5 feet of fill or slopes greater than 3:1.

Performance and Design Standards

Outside storage

Outside storage of materials is permitted on the site if stored in an orderly fashion or rows or stacks.

Physical appearance

Normal daily wastes of an inorganic nature may be stored in containers not in a building when such containers are screened from view.

Performance standards

Fire hazards

All flammable substances involved in any activity established in this district shall be handled in conformance with the latest edition of the applicable local fire code published by the International Code Council and applicable codes and ordinances.

Noise

No operation shall be carried on that involves noise in excess of the normal traffic noise of the adjacent street at the time of the daily peak hour of traffic volume. Noise shall be measured at the property line and when the level of this noise cannot be determined by observation with the natural senses, a suitable instrument may be used and measurement may include breakdowns into a reasonable number of frequency ranges. All noise shall be muffled so as not to be objectionable due to intermittence, beat frequency or shrillness.

Sewage and other liquid waste

No operation shall be carried on which involves the discharge into a sewer, water course, or the ground of liquid wastes of any radioactive nature or liquid waste of a chemical nature which are detrimental to normal sewage plant operation or corrosive and damaging to sewer pipes and installations.

Air contaminants

No operation shall be carried on which involves air discharges in excess of air quality standards for Jefferson County and any necessary permits from the Missouri Department of Natural Resources shall be obtained.

Stormwater

Land disturbance activities shall follow stormwater management best management practices to prevent and reduce the discharge of pollutants directly or indirectly into stormwater.

Odor

Odor-causing operations shall be controlled so as to reduce escape of odors to the minimum practical within the limits of reasonable technology and economics.

Vibration

All machines including punch presses and stamping machines shall be so mounted as to minimize vibration, and in no case shall vibration exceed a displacement of three thousandths (3/1,000) of an inch measured at the property line. Vibration shall not be so excessive that it interferes with industrial operations on nearby lots.

Heat

No heat from furnaces or processing equipment shall be sensed at the property line to the extent of raising the temperature of air or materials more than five (5) degrees Fahrenheit.

Hazardous materials

Operations involving the storage or use of hazardous materials in reportable quantities, as classified by the Environmental Protection Agency (EPA), shall obtain any necessary permits from the Fire District(s) and make improvements to the building and grounds required by the International Fire Code 2009.

- 1. A Site Development Plan(s) shall be submitted to the Jefferson County Planning Division in accordance with the Unified Development Order of Jefferson County.
- 2. A copy of the approved Development Plan incorporating any conditions shall be attached to each set of Site Development plans submitted.
 - 3. All approved modifications must be listed on future site development plans.
- 4. This site will require proof of lot consolidation (with easement vacations as needed) prior to Site Development Plan approval.
 - 5. General comments:
- a. The project is being proposed on two separate parcels of ground. Required improvements such as parking could be lost if an adjacent parcel were sold, therefore, a boundary line adjustment to eliminate the lot line must be submitted. No plan approval will be granted until this issue is resolved.
- b. There is required parking shown in an ingress/egress easement. The easement appears to serve no function. The easement must be legally vacated to protect the required parking.
 - 6. Pavement:
- a. East entrance pavement thickness shall provide 7" PCC (or 2" Type C Asphaltic Concrete/6" Type X Asphaltic Concrete/4" rock base). Pavement width for entrance at ROW (including curbs) for two-way traffic shall provide 36'-60' (west entrance is only 20' wide).
 - b. The entrance width shall be provided from the street into the site for a throat length of 20'.
 - 7. Parking areas:
 - a. The parking lot improvements shown on the development plan must be constructed as proposed.
 - 8. Stormwater/detention:
 - a. No detention is required if:
- i. Non-residential development has less than an additional 12,000sf of impervious area. However, low impact practices are required to mitigate the additional runoff created by the additional impervious coverage and no adverse impact may be created.
 - ii. The Stormwater Division must approve of all low impact stormwater practices.
- b. Potential negative stormwater impacts to the following adjoining properties must be addressed: Meadowlark Lot 11, Loeffelman is owner of record; Lots 6, 7, & 8, Courtwright is owner of record and also the subdivision street.
- c. Stormwater system shall be designed for the 15-year, 20-minute event. Provide hydraulic calculations and drainage area map for each system.
 - 9. Grading:
- a. Submit a geotechnical report, sealed by an Engineer registered in the State of Missouri, as required where more than 5' of cut or 5' of fill is proposed. Grades at slopes proposed steeper than 3:1 must be included in the report for slope stability.
 - b. A wall with a height of over 4' requires a permit from the Code Enforcement Division.
- Section 2. The zoning map of Jefferson County, Missouri shall be amended by changing the area where said real estate is located on the map with the marking "PI13031".

AN ORDINANCE OF JEFFERSON COUNTY, MISSOURI, COUNCIL AUTHORIZING THE ISSUANCE OF NEIGHBORHOOD IMPROVEMENT DISTRICT BONDS (MARK DRIVE NEIGHBORHOOD IMPROVEMENT DISTRICT PROJECT), SERIES 2013; AND AUTHORIZING AND APPROVING CERTAIN DOCUMENTS AND ACTIONS IN CONNECTION WITH THE EXECUTION AND DELIVERY THEREOF.

WHEREAS, pursuant to Article III, Section 38(c) of the Constitution of Missouri, and Sections 67.453 to 67.475 of the Revised Statutes of Missouri, as amended, named the Neighborhood Improvement District Act (the "Act"), and all other provisions of the laws of the State of Missouri applicable thereto, by proceedings duly had, Jefferson County, Missouri (the "County") has duly authorized and created the Mark Drive Neighborhood Improvement District (the "District");

WHEREAS, the District was created to finance the Mark Drive Sanitary Sewer Extension Project (the "Project"), said Project consisting of the acquisition, construction, extension and equipping of sanitary sewer improvements within the District;

WHEREAS, pursuant to Ordinance No. 12-0187 adopted on April 9, 2012, the County issued its Municipal Temporary Notes (Mark Drive Neighborhood Improvement District Project), Series 2012A (the "Prior Notes") in the aggregate principal amount of not to exceed \$440,000 to finance certain costs of the Project; and

WHEREAS, the County desires to refund all of the outstanding Prior Notes through the issuance of the County's Neighborhood Improvement District Bonds (Mark Drive Neighborhood Improvement District Project), Series 2013 (the "Bonds") for the purpose of (a) refunding the Prior Notes, (b) reimbursing the County for certain costs of the Project paid during construction, (c) funding a debt service reserve fund for the Bonds, and (d) paying the costs of issuance of the Bonds.

BE IT ENACTED BY THE JEFFERSON COUNTY, MISSOURI, COUNCIL, AS FOLLOWS:

Section 1. Approval of Execution and Delivery of the Bonds. The County Council hereby authorizes and approves the execution, delivery and sale by the County of the Bonds in the aggregate principal amount of \$[**Principal Amt**] for the purposes set forth in the recitals to this Ordinance. The Bonds shall mature, be subject to redemption, bear interest at the rates and be secured as provided in the herein-approved Trust Indenture.

Section 2. Authorization of Documents. The County is hereby authorized to enter into the following documents (the "Financing Documents"), in substantially the forms presented to and approved by the County Council at this meeting and attached to this Ordinance (copies of which documents are on file in the office of the County Clerk and shall be permanently filed in the records of the County), with such changes therein as shall be approved by the officers of the County executing the documents, such officers' signatures thereon being conclusive evidence of their approval thereof:

- (a) Trust Indenture by and between the County and UMB Bank, N.A., as trustee (the "Trustee") (attached hereto as Exhibit A);
- (b) Bond Purchase Agreement by and between the County and Stern Brothers & Co. (attached hereto as Exhibit B);
- (c) Tax Compliance Agreement by and between the County and the Trustee (attached hereto as Exhibit C); and
- (d) Official Statement to be dated the date of execution and delivery of the Bond Purchase Agreement (in the form of a Preliminary Official Statement which is hereby approved and attached hereto as Exhibit D).

Section 3. Execution of Documents. The County is hereby authorized to enter into and the County Executive, the Director of Administration and the County Clerk (or Deputy County Clerk) are hereby authorized and directed to execute and deliver, for and on behalf of and as the act and deed of the County, the Financing Documents and such other documents, certificates and instruments as may be necessary or desirable to carry out and comply with the intent of this Ordinance.

<u>Section 4.</u> Use of Official Statement. The County hereby authorizes the use of the Official Statement in connection with the sale of the Bonds.

Severability. The sections, paragraphs, sentences, clauses and phrases of this Ordinance shall be severable. If any such section, paragraph, sentence, clause or phrase of this Ordinance is found by a court of competent jurisdiction to be invalid, the remaining portions of this Ordinance are valid, unless the court finds the valid portions of the Ordinance are so essential to and inseparably connected with and dependent upon the void portion that it cannot be presumed that the County Council has enacted the valid portions without the void ones, or unless the court finds that the valid portions, standing alone, are incomplete and are incapable of being executed in accordance with the legislative intent.

<u>Section 6.</u> Governing Law. This Ordinance shall be governed exclusively by and construed in accordance with the applicable laws of the State of Missouri.

Section 7. Further Authorization. The County Executive and the Director of Administration are hereby authorized and directed to execute and deliver for and on behalf of the County, and the County Clerk (or Deputy County Clerk) is hereby authorized and directed where appropriate to attest, all certificates, documents, agreements or other instruments in connection with the issuance of the Bonds and to carry out, comply with and perform the duties of the County with respect to the Financing Documents. The County Executive and the Director of Administration are hereby authorized and directed to take any and all actions, as may be necessary, desirable, convenient or proper to carry out and comply with the provisions of all agreements or contracts, necessary or reasonably incidental to the implementation of this Ordinance.

Section 9. Effective Date. Ordinance shall be in full force and effect immediately upon approval.
