DUI PERSONAL DEFENSE EVALUATION ENGAGEMENT AGREEMENT

Please read the terms of our engagement below. If you print this form for mailing or faxing, sign the agreement before sending it. The preferred method is to submit the form by Email. There is a "Submit By Email" button on the last page.

For the fee indicated on page two below, the Keyt Law Office will perform an evaluation of the DUI criminal case the government has filed against you. The purpose of this evaluation is to determine whether or not you have a case that can be successfully defended in court. After a review of all the evidence in the case, we will provide you with an opinion letter recommending a course of action on your case. If the facts and circumstances of your case provide you with a possible defense, we will refer you to an experienced DUI attorney to handle your case in court. This attorney will give you a credit against their fees for the cost of the Personal Defense Evaluation (PDE). This agreement will describe the terms of our representation to ensure your complete understanding and approval.

We are not being retained to appear on your DUI case in court. We will not make any court appearances on your behalf. You must go to your court arraignment and plead "Not guilty." You will then be responsible for obtaining the government's evidence against you through the court "discovery" process. We will provide you with guidance on how to obtain the evidence from the prosecutor. You will also be required to complete a detailed description of all the facts and circumstances surrounding your DUI citation. After you have collected the evidence from the prosecutor, provided the evidence to us and completed your description of the facts, we will begin the PDE process. During the PDE process we will interview you regarding legal or factual issues in your case.

If the government has retained a breath sample or a blood sample in your case, you will be responsible for obtaining the necessary forms and permissions from the government to obtain the sample for independent testing. The government will not release the samples to you, but will forward them to a licensed laboratory for testing. We will provide you with guidance on how to work through the process of obtaining the samples and submitting them to a lab.

In all DUI cases collection of the evidence is driven by scheduled court dates and in some cases, prosecutor plea cut-off deadlines. The evidence must be collected promptly to allow sufficient time to evaluate the evidence before a scheduled pretrial conference, or a plea cut-off deadline. Evidence collection is your responsibility and you must remember that failure to collect the evidence as soon as possible may result in the loss of a possible defense, or the loss of a potentially favorable plea offer from the prosecutor. We will provide you with an evidence collection checklist to use as your guide for the the evidence collection process.

After the PDE has been completed, we will advise you to either seek a plea agreement, or if you have a case with legal or factual defenses, retain legal counsel to defend the case in court. If we recommend accepting a plea agreement, it is your responsibility to communicate with the prosecutor and have them make you a plea offer. We will review the plea offer made by the prosecutor and advise you on whether or not it conforms to standard offers made by that prosecutor's office. If it does not, we will suggest possible changes and negotiation points. However, it is your responsibility to negotiate the plea offer with the prosecutor. We are not being retained to negotiate with the prosecutor on your behalf.

This agreement is for a PDE on one criminal DUI case in court. It does not cover any administrative action take by Arizona Motor Vehicle Department (MVD) resulting from your Driver's license suspension for points or DUI. MVD's actions are separate and apart from your DUI criminal case. We will provide you with information about what to expect from MVD if you are found guilty of DUI.
