

99th VSGA Amateur Championship Bayville Golf Club, Virginia Beach June 26-30, 2012

Open to VSGA members of all ages. Participants must have a VSGA/USGA Handicap Index established at a VSGA Member Club and meet the USGA Rules of Amateur Status. For additional information see the VSGA Championship and Tournament Eligibility Guidelines.

ENTRY FEE/DEADLINE

Qualifying

Players competing in a qualifier are required to submit an entry form with the entry fee of \$75 by 5:00 pm, Monday, May 21, 2012. The \$75 qualifying fee does not include cart fee or any other fees on-site. Those who successfully qualify are required to pay the entry balance of \$150 by June 18, 2012 which includes practice round green fee, green/cart fees and lunch for all rounds of competition at Bayville GC.

Exempt players are required to submit an entry form with the entry fee of \$225 by 5:00 pm, Monday, May 21, 2012. Entry fee includes practice round green fee, green/cart fees and lunch for all rounds of competition at Bayville GC.

FORMAT

Qualifying

All non-exempt players must qualify to play in the championship. A player may only compete in one qualifier. There will be 11 qualifiers (see below) and each qualifier will be 36-holes of stroke play. Sites will be filled on a first come, first serve basis. The number of spots available at each qualifier will be determined based on participation and will be announced on-site.

Championship Proper - 120 Players (includes all qualifiers and exempt players)

June 26-27 – Stroke play qualifying (18-holes per day); the low 32 players advance to match play

June 28 – Rounds 1&2 of match play

June 29 - Quarterfinal and Semifinal matches

June 30 – 36-hole match play final

The Champion, Runner-up and Semifinalists receive gift certificates and trophies. All match play qualifiers will receive a gift certificate. All players that qualify for the Championship will receive a gift. All qualifying medalists (including on-site) will receive a VSGA medal.
