## Dues Deduction

Key information for public employee union members, leaders and staff

---

### What is payroll deduction?

**Many public-sector union members pay their union dues by using voluntary payroll deduction. Payroll deduction is easy, efficient and has almost zero cost. Gov. Corbett and his legislative allies want to prohibit all public sector union members from using voluntary payroll deductions.**

- Employers and employees through their collective bargaining agreements voluntarily agree to have union dues deducted from their paychecks.
- Member dues are not used to contribute to political campaigns or to directly support the candidates for office endorsed by the union.
- This legislation is no different from Corbett's previous attempts to attack working people through attacks on their unions. The goal of this legislation is exactly the same as proposals to pass right-to-work, privatize our liquor stores, and cut public pensions – they all silence and hurt workers.
- Employers and employees may negotiate reimbursement of the cost of using automatic payroll deduction, but the cost is so minimal that many public employers have never requested reimbursement.

### Talking Points

**Gov. Corbett is being a bully, and he is retaliating against those who have opposed his agenda by trying to take away the rights of teachers, nurses, firefighters and other public employees.**

- Pennsylvania currently ranks 46th in job growth, but Gov. Corbett made things worse by cutting nearly \$1 billion from our public schools and giving away millions of dollars in corporate tax breaks. Pennsylvania has real problems that need to be addressed, but instead Corbett is obsessed with retaliatory legislation to help his own reelection campaign.
- This legislation is a political power grab by corporate interests that aim to choke off union members' voices, slash their salaries and pension benefits, and pave the way for even more tax breaks for the wealthy and big corporations. We have seen these attacks orchestrated across the country.
- These attacks are about weakening our union, our communities and us. We won't allow bullies to push us around. We're going to fight these attacks with all of our resources, and with the most powerful weapon of all: the truth.
- With his approval ratings at record-low levels, Gov. Corbett is now waging a desperate, unnecessary, politically motivated attack on workers for opposing his attempts to privatize the state liquor stores, his nearly \$1 billion in public school funding cuts and his attempts to slash public employee pensions.
- These misleading bills discriminate against public employee union members and their employers by eliminating the freedom to negotiate payroll deductions.

**Gov. Corbett has sided with the wealthy and powerful at every turn, and he has been rewarded with tens of millions of dollars for his campaign. This legislation is another example of Gov. Corbett putting corporate interests ahead of the interests of the middle class.**

- Proposals like this are being promoted all over the country by a secret network of out-of-state Tea Party billionaires and corporate special interests. They want to tilt laws even more in their favor and keep even more corporate profits for themselves by weakening the ability of middle-class workers to win higher salaries and better benefits.
- A right-wing think tank called the Commonwealth Foundation is leading these attacks, backed by wealthy donors who aren't required to disclose their contributions.
- The Commonwealth Foundation fights for corporate tax cuts, weakening collective bargaining laws, school vouchers, and attacks on pensions.

**There is nothing political about public employees' current payroll deductions, but the attempts to end those deductions are political. We all work hard for the salaries we earn, and we have the right to contribute our money as we choose.**

- Considering this legislation is being pushed by right-wing political operations, it is no surprise that it protects payroll deductions by organizations that support the bills' sponsors, but prohibits payroll deductions for organizations that give a voice to middle-class workers and their families.
- This legislation unfairly singles out and prohibits voluntary deductions made by nurses, teachers and public safety/service workers but continues to allow deductions that go to insurance companies, big banks, and financial companies, even though they use the money to spend heavily on lobbying and politics.
- The bills are unnecessary because payroll deductions of any kind are essentially the press of a button – and cost taxpayers nearly nothing.
- Most government payroll systems are highly automated, so there is almost no cost to taxpayers for union members who choose to pay their dues this way.
- In fact, payroll deduction is the same way that millions of people make contributions to charities like the United Way or the American Cancer Society, or make payments to their credit unions, health insurers, or retirement plans.
- To use payroll deduction to pay union dues or to make voluntary political contributions, it must be agreed upon between a local or a state employer – and public-sector union members can choose to have their union dues deducted directly from their paycheck. Contributions for political activities are entirely voluntary, and public sector unions may not spend member dues on political campaigns or candidates.

**All Pennsylvanians have a right to be heard, but this legislation unfairly singles out public employees like teachers, firefighters, and public safety/service workers and restricts their ability to advocate on behalf of the working families they serve.**

- The collective voices of our public workers – our teachers, our firefighters, and our nurses -- keep us all safe. Nurses negotiate for safer staffing levels. Teachers negotiate for smaller class sizes. Firefighters negotiate for better equipment so that they can protect us more effectively. Police officers negotiate for more training to help keep our communities safer.
- These proposals weaken the ability of public workers to do their jobs. Public employees' voluntary contributions provide them with a voice in matters that directly affect their jobs and the people they serve.
- The real motivation for such legislation that unfairly singles out public employees is to take away their rights and silence their voice.
- Gov. Corbett has shown that he will side with the wealthy and powerful at every turn. Once he has attacked our brothers and sisters in the public sector, how long will it be before he comes for the rest of us?

**FOR LOCALS WITH FAIR SHARE: Opponents claim that payroll deductions of fair share dues for non-members are being forced on them, but that claim is not true. Consider these facts:**

- No one can be forced to join a union, even if a workplace is unionized.
- Unions are allowed to charge non-members a portion of the normal dues paid by their members in order to cover the cost of the benefits provided to every employee by the union.
- Non-members cannot be charged for lobbying expenses.
- They are not even charged when the lobbying helps them too.
- For example, they are not contributing to efforts to lobby to increase school funding, protect our pensions, improve workplace safety, increase the minimum wage, and protect teachers from unfair evaluations.
- There is a fair process in place for appealing fees that are perceived by non-members to be too high, but public employee unions' fair share fees have been upheld every time they were challenged.
- Payroll deductions and fair share fees are bargained between the employer and the union and must be contractually approved by both. Usually something is given up in order for local unions to get fair share into the contract.

### FAQ Summary Information

#### ***What is payroll deduction?***

Many public sector union members pay their union dues by using voluntary payroll deduction. Payroll deduction is easy, efficient and has almost zero cost. Gov. #### ***Why are Gov. Corbett and his allies attacking it?***

Gov. Corbett is being a bully, and he is retaliating against those who have opposed his agenda by trying to take away the rights of teachers, nurses, public safety workers, and other public employees.

#### ***What are Gov. Corbett and his allies trying to do?***

Gov. Corbett and his corporate cronies have already shown their contempt for working people by attempting to push a right-to-work law, attacking our pensions, cutting education funding and attempting to privatize our liquor stores. This legislation is another example of Gov. Corbett putting corporate interests ahead of the interests of the middle class.

#### ***Why are they bringing politics into this?***

There is nothing political about public employees' current payroll deductions, but the attempts to end those deductions are political. Regardless of whether we work in the public or private sector, we all work hard for the salary we earn, and we have the right to contribute our money as we choose.

#### ***Why do we need to stop these attacks?***

This legislation is a first step towards less job security and lower pay for all workers in Pennsylvania. The wealthiest 1% has been the beneficiary of all of the income growth in the state since 2008. By taking away workers' rights, this legislation would hurt Pennsylvania's struggling middle class even more and open the door to increased attacks on other union members.

## **Sample Letters to the Editor**

To the editor:

The Commonwealth Foundation is at it again. They have teamed up with extreme legislators in our state Capitol to push a so-called “paycheck protection” bill which has nothing to do with protecting workers’ paychecks and everything with silencing their voices.

This time the Commonwealth Foundation is teaming up with a sinister organization known as the American Legislative Exchange Council (ALEC) and other out of state interests in two new efforts to attack workers’ rights. HB 1507 and SB 1034 prohibit school teachers, care givers, and public safety workers from choosing how they want to pay their dues through a payroll deduction. Most workers including myself choose payroll deduction to pay my dues and other payments. It is easy, convenient and the costs are next to nothing. The cost is so minimal that our employer hasn’t requested a reimbursement even though we have agreed to do so.

These proposals were not the brainchild of anyone in Pennsylvania. Portions of both laws are lifted verbatim from similar laws that ALEC has pushed in Missouri, Arizona and Kansas. They aren’t written to help working Pennsylvanians – they are written to advance an out-of-state agenda to hurt labor unions and destroy our middle class.

Our legislators need to see these bills for what they are and strongly oppose HB 1507 and SB 1034.

To the editor:

Pennsylvania has a problem with income inequality. One in eight Pennsylvanians live in poverty, while the wealthiest 1% have been the beneficiary of all of the income growth in our state since 2008.

Yet at a time when our leaders should be focusing on strengthening our middle class, some legislators in Harrisburg are actually working to accelerate its decline. Lawmakers and Gov. Corbett are pushing a so-called “paycheck protection” law, HB 1507 and SB 1034 that would hurt our struggling middle class. This law is a first step towards less job security and lower pay for Pennsylvanians.

Tom Corbett’s agenda has been to give away tax credits to corporations while slashing education funding. (He is, conveniently, reconsidering giving our schools a little cash, as it is an election year after all.) This is just another cynical effort to screw middle-class Pennsylvanians by dictating that they must be prohibited from paying dues to their unions and donations to organizations who might give them a voice in the workplace.

Protecting workers’ rights on the job keeps our communities stronger. Instead of pursuing bills like HB 1507 and SB 1034, our leaders should work to strengthen our communities by protecting and creating jobs and supporting policies that lead to higher wages not lower wages for working families. We cannot afford to wait any longer.

To the editor:

I have a question for Rep. or Sen. [NAME]. Do ordinary people deserve as loud a voice in politics as corporations?

According to two new bills in the Pennsylvania Legislature, we don’t.

Extremists in the Pennsylvania House and Senate are pushing for two bills that silence the voices of working families making more difficult for all of us to make our elected officials accountable to us in supporting public education, quality care for our parents and grand-parents and making sure our roads, highways and communities are safe. These bills prohibit voluntary payroll deductions made by teachers, nurses and public safety workers to their union or their union’s political action fund.

Yet these bills do nothing to stem the deductions that go to insurance companies, big banks, and financial companies, even though they use that money to spend heavily on lobbying and politics.

If the Legislature insists on debating these measures, we should at least call them out for what they are: a cynical attempt to silence the voices of ordinary middle class workers.

To the editor:

I have always assumed that we pay our legislators to solve our problems, not create new ones, but this may not be true anymore. Last year Pennsylvania created fewer jobs than any other large state in the country, and what have our leaders done? Well, Rep. Bryan Cutler and Sen. John Eichelberger decided to file bills making it illegal for state workers to pay union dues or fees through automatic payroll deduction.

HB 1507 and SB 1034 do not create jobs. It does not generate revenue that could fund programs to create jobs. It will, in fact, cost our state government more money. It does not solve a problem – it just creates new ones.

Pennsylvania currently ranks 48th in job creation among all U.S. states. Contrary to what Gov. Corbett said in his recent budget address, we have serious work to do to get our economy on track. Our leaders should focus on solutions that address real problems. How workers choose to use automatic payroll deductions isn't one of them.

These bills should be placed in the round file.

Another attack on workers' rights is brewing in Harrisburg. This time it's in the guise of a so-called cost-savings measure known as "paycheck protection". It sounds nice, right?

These "paycheck protection" bills should be named "paycheck deception" bills because they are written to deceive people about their real intent.
