Dear Active/Affiliate/Honourary Member ("Voting Member"):

This is your notice of the Call for Nominations for directors to serve on the Board of Ontario Basketball (OBA) and the Call for Nominations for positions to serve on Ontario Basketball's Provincial Advisory Council (PAC).

#### Please note that:

- As per By-law 1 of Ontario Basketball, four (4) directors' positions are open for election on Saturday, November 13, 2010.
- As per the PAC Terms of Reference, the positions of all Chairs are staggered by two-year terms and therefore open for election on Saturday, November 13, 2010.
- As per By-law 1 of Ontario Basketball, the Board of Directors confirmed the appointment of Marc Dulmage as Chair, Nominating Committee.

The proxy/ballot will enable all voting members to exercise their right to vote even if they are unable to personally attend the Annual Meeting of Members.

**Note:** Provisions were presented for consideration by OBA voting members at the 2009 Annual Meeting of Members on (Saturday, November 14, 2009) to provide for electronic versions as an alternative to paper-copy notices. The amendments to the By-Law were confirmed and approved by the members.

In addition, as required by the Ontario Corporations Act, elections will continue to be held at the Annual Meetings of Members. Please note, however, nominations from the floor will not be accepted.

Please submit any (all) motions in writing to the Ontario Basketball office by Monday, October 11, 2010. The motion form has been included.
