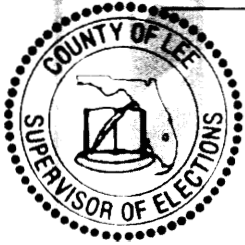

Dear Mr. Thomas:

We are in receipt of the UPDATE Statement of Political Organization and Appointment of Campaign Treasurer and Designation of Bank Depository required under Florida Statutes Chapter 106 that establishes the formation of the political action committee Citizens For A Better Fort Myers Government PAC.

We have provided the committee chairman and treasurer with the 2006 Political Committee Handbook, Florida Statutes Chapter 106 (campaign financing) and the 2007-2008 Calendar of Reporting Dates, Lee County Electronic Financial Reporting System (Candidate and Committee Guidebook). The committee will be required to file periodic campaign treasurer's reports as required by Florida Statutes Chapter 106. Please refer to the enclosed reporting calendar.

The committee may be required to register with the Internal Revenue Service. For more information regarding registration requirements with the Internal Revenue Service, you must contact the Internal Revenue Service by email at [www.irs.gov/polorgs](http://www.irs.gov/polorgs) or call the IRS Tax Exempt Customer Account Service at 1-877-829-5500.

The Lee County Supervisor of Elections can not determine whether a committee will be required to register with the Internal Revenue Service. It is important that the committee contact the Internal Revenue Service to verify whether the committee is exempt from any, or all Internal Revenue Service registration requirements for political action committees.


