## Coaches Information Sheet

## Aloha Coaches...

Welcome to the 47 th Annual Hawaiian Invitational Water Polo Tournament and Mahalo for your interest and support. The following information highlights some of the changes in entry and Tournament procedures for this year:

1. Mandatory coaches meeting. A mandatory coaches meeting is scheduled for the evening of MONDAY, AUGUST 3, 2015, at 6:00 PM at the Outrigger Canoe Club, which is located at the Diamond Head-end of Waikiki Beach (directions can be found at www.hawaiiwaterpolo.com). Any changes to the Tournament schedule or other important announcements will be made at the meeting. Meeting location and time are subject to change. Participating teams will be advised of meeting date and time.
2. Entry into Tournament. Entry forms review and approval process will begin on January 15, 2015. Initial notification of approval/denial will start after that date. The last day to submit your entry forms to the Tournament Director is APRIL 30, 2015. Be advised that the Tournament may already be full by this deadline.

A number of slots in each division are reserved for Hawai'i teams. The majority of the slots in this Tournament are reserved for mainland teams using TIS for all of their travel (complete tour package including flights \& hotel). Teams not using TIS, or using TIS for only a portion of their travel, will be given second priority and given slots only after the full TIS teams are given their slots. Our stated policy is to invite teams at the higher entry fee only after all TIS-committed teams are invited.
3. Number of teams allowed per club. Up to 4 teams per club will be admitted. A team must consist of at least 10 different players of the same age bracket, who are not listed on another club's entered team. Only one team per division will be accepted.
4. Official Travel Agency. Travel International Sports, 15349 DORMAN CT FISHERS, IN 46040, www.tisworld.com. Toll Free: (800) 535-3574. Sponsorship of the Tournament by the agency allows the Tournament to cover travel expenses for officials as well as pool rental and other operating costs. Inquiries: Steve Baker: steve@tisworld.com
5. Waiting List \& Cancellations. A waiting list of teams, for filled divisions, will be kept should accepted teams cancel. Accepted teams that cancel after February 1, 2015, and before April 1, 2015, shall receive a $75 \%$ refund. Accepted teams canceling after APRIL 1, 2015, will forfeit their entire entry fee. Refunds for teams that cancel will be issued after the end of the Tournament.
6. USAWP or NGB Verification. All US athletes must be members of USA Water Polo. All US rosters must be submitted electronically using the instructions included on page 5. All coaches must bring USAWP cards for all players with them to the Tournament. Non-US athletes must have proof of good standing with their NGB.
7. Player's age. The calculation of a player's age is age as of midnight of August 1 st of the current year. For 2015 it will be the athlete's age as of midnight August 1st, 2015.
8. AWARDS. Team awards will be given to the first four (4) places in each division. Individual awards will be given to the Most Valuable Player in each division.
9. IMPORTANT - Hotel Rules \& Behavior: Visiting teams are expected to adhere to hotel or condominium House Rules where they are staying. Proven instances of misbehavior on hotel property premises or public premises, and/or any damage to the hotel property, may result in the team's expulsion from the hotel and the Tournament, and ineligibility for future Tournaments. Make sure to review the House Rules with all team members before checking in.

## Note Regarding Travel/Luggage:

 Warm-up balls will be provided for all teams. Teams do not need to bring balls to and from the tournament. This should help teams avoid the hassle and fees associated with traveling with extra baggage. There will be enough balls for all teams to warm-up prior to games.
## ENTRY FEES:

$\mathbf{\$ 9 0 0}$ /team/division for teams booking complete travel packages (air \& hotel) through TIS.
By submitting the $\$ 900$ entry fee, your club/team is committed to use TIS for their travel arrangements.
Only booking a full travel package through TIS, including both flights \& hotel, qualifies team to
pay lower entry fee. Tournament acceptance may be rescinded if team's travel status changes and entry fee sent is no longer sufficient. There is a $\$ 20$ tournament $t$-shirt fee for each team member.

## $\mathbf{\$ 1 5 0 0 . 0 0}$ /team/division for teams not using TIS or that do not book complete packages with TIS.

Our stated policy is to invite teams at the higher entry fee only after all TIS full package committed teams are invited. By submitting the higher entry fee per team, your team/club is electing to use a non-sponsor travel agency OR your team is only booking a portion of their travel through TIS. It is recommended that team/club does not make travel arrangements until the Tournament Committee has accepted the team. The majority of the Tournament slots are reserved for the teams using TIS for all of their travel arrangements (flights \& hotel). Teams not booking with TIS will be given second priority and given slots only after TIS teams are given their slots. There is a $\$ 20$ tournament t -shirt fee for each team member.

Instructions for Electronic Roster Submission/USAWP Verificaton

## Deadline for Electronic Roster Submission: July 15, 2014

All US team rosters must be submitted electronically using the form by logging to USAWP club admin area and clicking on the Hawaiian Invitational to submit roster for sanctioned event.

All non-US teams must use the form found at:

## Instructions:

Use the roster Verification for Sanctioned Events, and select Hawaiian Invitational.

You must use the email option to have a copy sent to nick@hawaiiwaterpolo.com. You should also print this roster to send in with your Hawai'i Contact Form as well as for your own records.

Submit a separate roster for each team you are entering.
Please contact nick@hawaiiwaterpolo.com if you need assistance with roster verification.

## Rules:

1) All players, coaches, and teams must be registered with USA Water Polo, Inc. (USAWP) or similar FINA recognized organizations. Non-US teams must have a travel permit. These will be checked.
2) Twenty (20) players may be listed and play on the TEAM roster.
3) A player may play on only one team per division, but may play in more than one division. Note, players on more than one team need only pay a single $\$ 20$ tournament $t$-shirt for a single tournament $t$-shirt.
4) Clubs entering more than one team and who have players in other divisions will be required to have a minimum of ten different players on each team in case of simultaneous scheduling that is unavoidable.
5) Age determination is midnight August 1st, 2015 so Junior Olympics Teams may play intact. A player's age as of this time is their age for the 2015 event.
