#### Restricted Gifts:

#### **Donor Allocation Policy:**

- You may allocate up to 100% of your total gift within the United Way network, including LIVE UNITED 24/7 365, Local Impact Areas
  (Education, Income, and/or Health), United Way Partner Agencies, other United Ways, and member agencies of our neighboring United
  Ways (including Butler, Champaign, Clark, Clinton, Darke, Fayette, Madison, Miami and Warren Counties in Ohio, and Wayne County in
  Indiana).
- You may allocate up to 50% of your total gift to any 501(c)3 organization that provides a health or human service program in our region.

#### Designations:

- A **\$24 minimum** applies to all designations. Because it is too costly to track and distribute smaller donations, any designations **less than \$24** will automatically be transferred to our signature fund LIVE UNITED 24/7 365.
- If clarifications or changes to your designations are required to properly process your pledge, United Way will make two attempts to contact you. If we do not receive a response, designations will automatically be transferred to LIVE UNITED 24/7 365.
- Designations made outside the United Way network exceeding 50% of your total gift will be reduced to 50%; the remainder will be transferred to LIVE UNITED 24/7 365.

#### **Donor Privacy:**

Information, including but not limited to: name, address, phone number and email address, collected from donors and companies by United Way of the Greater Dayton Area will not be sold or distributed to any organization outside the United Way system without express written consent.

United Way of the Greater Dayton Area may, from time-to-time, publish names and gift levels as a way of publicly thanking its donors. Corporate gifts will be omitted from such lists if the Chief Executive Officer, or equivalent, requests that the gift be anonymous. Upon provision of a street address or email address, you will receive periodic mail and/or email from United Way of the Greater Dayton Area unless you request no such contact. #### Tax Information

No goods or services have been given to the donor in exchange for this contribution. For gifts of \$250 or more paid during the 2012 calendar year, tax receipts will be mailed February of 2013.
