Our Trammell Roots

When I started the research of the Gillyards, I followed the advice of professional genealogists, start with what you know. I pulled out my Dad's obituary and found the names of my paternal granddad and grandma. The name Charlie Gillyard was no surprise and **Cynthia Trammell** had a familiar sound. I instantly realized however that I knew nothing at all about the Trammells, and decided to research that line also. I knew it would be tough because I did not know one Trammell relative.



Much to my surprise, over a course of only four years, I've come to learn more about my Trammell roots than I ever thought possible. I've collected historical data from newspapers, archives, published books and several other sources. I was shocked to learn that Grandma Cynthia's father and uncles served in the Texas Police during the reconstruction period. I actually obtained copies of their pay receipts.

With documentary evidence, I had discovered that grandma Cynthia was born in Limestone County, Texas. I needed to visit her home. So on, August 14, 2010, my husband and I started our drive from Dallas County to Limestone County, Texas, located in east central Texas, east of Waco. My goal

for my first visit was simply to see the area and to touch and feel the soil. As we approached the County line, I recalled from my research that it was on a plantation in Limestone County Texas that on, June 19, 1865, Grandma Cynthia's dad learned of his freedom from slavery. That had to be a day of great jubilation.

And now here I was, on the soil of the area that my ancestors had been enslaved and then freed. My body was seized with tearful emotion as I stood on and touched the soil.

That first trip to Groesbeck, Limestone County, Texas will be forever indelibly etched in my memory.

In Memoriam We Remember

Jerry was a charter member of the Gillyard-Johnson-Mahoney Family Reunions Organization. His presence, valuable input and contagious laughter will be missed.

On March 23, 2010, President Obama signed into law HR 3590, which enacted sweeping changes to America's health care system. With 46 million Americans living without health insurance, according to the Center for Economic and Policy Research, health care reform's real benefits breached divisions between classes, genders and races. Nevertheless, **African Americans** are still suffering disproportionately with the problems of this country's broken health care system. In 2009, 19 percent of blacks did not have health insurance, according to the Centers for Disease Control and Prevention. The number for whites 10.4 percent in 2007 and **48 percent of African-American adults** suffer from chronic diseases, compared with 39 percent of the general population.

With a series of steps set to roll out over the next five years, HR 3590, also called the Affordable Care Act, is designed to eliminate these and other disparities. And in fact, many of the law's provisions have already begun to be implemented. Simply getting health insurance will be a big step forward for millions of African Americans. The Institute of Medicine has articulated that health insurance is a key component to reducing health disparities within minority communities. A series of measures will guarantee that all people who are insured are treated fairly by their insurance companies. This means that by 2014, insurance companies will no longer be able to deny coverage to anyone with pre-existing conditions -- a huge coup for the **African-American community**, which is plagued with chronic illness.

Insurers are already barred from denying children with pre-existing conditions. Again, while all Americans stand to gain from this particular regulation, **African Americans** in particular should celebrate: **Black children** are more prone than white children to a host of illnesses, including type 2 diabetes and asthma. This will make sure that children up to the age of 19 don't get denied coverage.

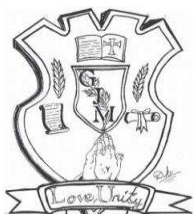
