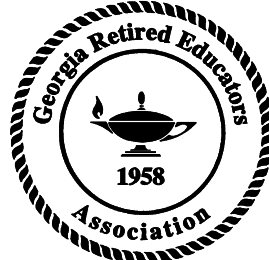

## *Governor Sonny Perdue To Address The 2006 GREA State Convention*

The Governor of the State of Georgia has graciously accepted the invitation of the Georgia Retired Educators Association to be the keynote speaker for the 2006 State Convention. Governor Perdue has been an active supporter of the retired educators in Georgia and we are proud to have him address our state convention.

Sonny Perdue was sworn in as Georgia's 81st Governor on January 13, 2003. Before his run for Governor, Perdue proudly served his local community as a businessman, community leader, Sunday School teacher, State Senator, Majority Leader, and President Pro Tempore of the Georgia State Senate, as well as an officer in the United States Air Force.

Since taking office, Governor Perdue led the state of Georgia with a clear vision, based on a solid set of priorities for the New Georgia. At the top of his list is education.

For three years, Governor Perdue hosted parents, students, and educators from across Georgia to the Governor's Mansion and the State Capitol, soliciting policy change suggestions. Based on these recommendations, he initiated several pieces of legislation that have improved the classroom environment and expanded education opportunities.

In 2005 Governor Perdue created the Georgia Virtual High School, providing students all over Georgia with access to Advanced Placement classes online. Governor Perdue also initiated the Master Teacher program, rewarding Georgia's best teachers, allowing them to serve as academic coaches.

Governor Perdue has taken an innovative approach to address Georgia's SAT score challenges by creating the Governor's Cup Challenge to improve SAT scores. He has also created a task force to study changes to Georgia's funding formula for K-12 education.

This year Governor Perdue's legislative and budget proposals reflect his top priority: education. He proposed that 72 percent of Georgia's increased revenue be spent on education. Governor Perdue proposed a four percent pay raise for all teachers and a classroom gift card giving educators \$100 each to help them purchase needed classroom supplies.

Governor Perdue introduced legislation this year requiring school systems spend 65 percent of their budget "in the classroom." Understanding the importance of smaller class sizes, the Governor proposed funds to reduce class sizes by two students in grades K-3 and by four students in grades 4-8. Governor Perdue also included \$447 million in his budget to build new classrooms with new technology and add school buses in every school system in Georgia.

Governor Perdue quickly took the lead on the request from GREA to fund a pay raise for our most senior retired educators. Governor Perdue included funds for HB 400 in his 2006-2007 budget and both the House of Representatives and State Senate have unanimously approved it. Governor Perdue will sign this bill soon in order to provide additional salary allocations for our older retirees.

The members of GREA are thrilled to have Governor Sonny Perdue as our speaker this year! Register today to attend and hear our outstanding Governor speak to our association and thank him for the passage of HB 400.

# GREA Mourns the Loss of Two Past Presidents

The Georgia Retired Educators Association extends its sincere sympathies to the families of two former GRTA (GREA) Presidents who have recently passed away.

Earl W. May, 91, was President of GRTA during the 1981–1982 term. President May passed away on May 31, 2005 at the Health Park Care Center in Fort Myers, Florida after an extended illness. A native of Cook County, May was a lifetime educator finishing his career in Wayne County in 1972. In 1965 he came to Wayne County from Camden County and was principal of Jesup Junior High School and later Jesup Elementary School. Mr. May held office as President of the Wayne County Retired Teachers Association as well as President of the State Association. He was a member of the Jesup First Baptist Church, the Kiwanis Club, Wayne Memorial Auxiliary, and was a U.S. Navy veteran of World War II.

He was preceded in death by his wife, Essie S. May. Funeral services were held on June 4, 2005 at the Jesup First Baptist Church.

William Starr Miller, 84, was President of GRTA during the 1989–1990 term. President Miller died suddenly Thursday, January 26, 2006. He was a retired college educator whose career spanned more than 40 years.

Dr. Miller was President Emeritus of Brewton-Parker College where he had served twice as president, and was Dean Emeritus of the School of Education of Georgia Southern University where he served for 18 years. His

educational service, beginning in the public schools of Gordon County, also included an administrative and teaching role at Young Harris College, as well as Academic Dean of Tift College.

An activist for retired persons, Miller had served as the Georgia State Director of the American Association of Retired Persons and as president of the Georgia Retired Teachers Association. Miller's various leadership roles have included serving as chair of the Board of the Georgia Baptist College of Nursing, chair of the Education Commission of the Georgia Baptist Convention, chair of the Deacons of First Baptist Church of Statesboro, chair of the Georgia Accrediting Commission for Georgia Schools, president of the Georgia Association of Colleges, and president of the Southern Council of Teacher Education of the Southern Association of Colleges and Schools.

Though Miller held and earned a doctorate from Duke University, he is often cited as a most appreciated recognition the honorary doctorate that his colleagues of Brewton-Parker College later presented him. The Miller Music Building of Brewton-Parker College was built during his tenure as president and carries that name as an honor to him and his late wife, Sarah Fallin Miller.

He was preceded in death by a spouse, Sarah Fallin Miller. W. Starr Miller is survived by his wife, Luine Wilson Baxter Miller of Newnan.

A graveside funeral service was held at 11 a.m. Tuesday, January 31 at Eastside Cemetery in Statesboro. A memorial service followed at 4 p.m. in Saliba Chapel of Brewton-Parker College in Mt. Vernon. In lieu of flowers, the family has requested memorial tributes be sent to: Brewton-Parker College, Mt. Vernon, GA 30445, designated for the Newnan Campus or the Miller Music Building Expansion Project.

# The Story of HB 400

In 2005, with the encouragement of GREA, Representatives Brooks Coleman, Bill Cummings, and Ben Bridges introduced HB 400 in the House of Representatives. This bill would increase the monthly benefit to certain TRS retirees. A bill of this nature requires two years for adoption.

GREA took this as our No. 1 priority for the 2006 legislative session. Many, many GREA members worked countless hours to encourage our representatives and senators to pass this piece of legislation.

In January 2006, Governor Sonny Perdue included \$3,760,000 in his budget request to the state legislature to fund this bill. This was an important step in getting it passed and GREA appreciates the Governor's support of this bill and asking for the money to pay for it.

On February 13, 2006, the state House of Representatives passed HB 400 by a vote of 164-0. Rarely does a piece of legislation receive a unanimous vote.

On March 14, 2006, with several GREA members in the gallery, the state Senate passed HB 400 by a vote of 52-0. Again it received a unanimous vote by this body!

HB 400 will become law when Governor Sunny Perdue signs this piece of legislation. He has 40 days from the end of the General Assembly session to sign the bill. We hope he can sign it at our State Convention in Augusta if the 40-day limit will allow it. If not he will sign it before the convention.

Thanks to all of you who worked on this bill and if you called, emailed or wrote your representative, senator, and governor about this bill, then please follow up with a Thank You note of some kind. You all did a great job!

Effective July 1, 2006, the increased benefit amounts will be based on the date of retirement as follows: Educators who retired prior to 7/1/74 would receive a 10% pay raise. Retirees between 7/1-74-6/30-82 would receive a 6% pay raise. Retirees between 7/1/82-6/30/87 would receive a 2% raise. This is in addition to the regular COLA raise of 1.5% each 6 months.

A former Walker County teacher is loaning her extensive collection of rocks, minerals, and fossils to the Walker County Science and Technology Center.

Helen Solomon began collecting specimens 70 years ago while in the sixth grade. It was while riding through mining towns in her home state of Arkansas that she uncovered a passion for the rocks men pulled up from the earth.

"The miners were allowed to sell the beautiful crystals that they came upon as they were looking for pay-dirt, the ore," Solomon said. "They sold them at fruit stands along the road."

Solomon said her love for geology was cemented with her frequent visits to the Academy of Natural Sciences Museum in Philadelphia.

"I would go over there and spend whole Saturdays looking at their natural science museum, particularly the rocks and minerals," she said.

Solomon was encouraged by her father, an electrical engineer working for RCA who developed technology in 1920 allowing radios to play over speakers instead of headphones, she said.

Over the years, Solomon's collection grew to fill the basement of her current house as well as a two-car garage in her back yard. A large portion of that collection will be on "permanent loan" to the Walker County school system.

The donation will include seven lighted displays to showcase the specimens, samples to take to classrooms for hands-on class work, and lesson plans to guide teacher instruction, she said.

You are entitled to a FREE copy of the credit reports compiled by the three national credit reporting bureaus. You can get one free copy from each company every twelve months. It's easy, and it's important—you can catch errors and detect identity theft.

The credit reporting companies collect information about you—information such as if you pay your bills on time, how much you owe, and whether you've filed for bankruptcy or been arrested. The companies sell your information to creditors, insurers, employers, landlords, and other businesses who want to evaluate your credit.

The three national credit reporting agencies are Equifax, Experian, and Trans Union. The FTC required them to create a joint clearinghouse for consumer requests, so it's very easy: Go to [www.AnnualCreditReport.com](http://www.AnnualCreditReport.com). Or call toll-free to 1-877-322-8228. Or write to P. O. Box 105281, Atlanta, GA 30348-5281. You can order all three reports at once, or you can get them one at a time every four months or so.

You may also go to [www.FTC.gov](http://www.FTC.gov) (the Federal Trade Commission web site) for even more information about how, why, where, and when to get your free credit report, how to dispute errors, and what to do if you are a victim of identity theft.

This is an area devastated by Hurricane Katrina. The school was under 8 feet of water and closed for 47 school days. Everything in the school was ruined. The local teachers were paid during that time, but lost all of their leave time and, consequently, could not take any time off. The Russells were able to give twenty teachers each a half-day off.

The Russells were joined by two retired educators, Gene Rodgers and Pat McNamara, from Harris County, who stayed three days to help. Unfortunately, no other volunteers have made themselves available to the teachers in that area.

Since housing is a problem in the area, the Russells pulled a travel trailer to Mississippi in order to have a place to live while there. Almost all of the teachers and students are living in FEMA trailers.
