In accordance with the New York State Electronic Equipment Recycling and Reuse Act (Environmental Conservation Law, Article 27, Title 26), this annual report form must be completed for each registered electronic waste consolidation facility and submitted to the Department of Environmental Conservation (Department) annually by **March 1st** for the previous calendar year. Failure to submit a complete and timely annual report, including the appropriate signatures, will subject the electronic waste consolidation facility to civil penalties under the Act.

Electronic waste consolidation facilities must also maintain all supporting documentation regarding the management of electronic waste (e.g. registration/reporting forms, shipping invoices, bills of lading, etc.) on-site for a period of three years for data verification purposes.

Any modifications, updates or additional information to what is currently on record with the Department may be included in a cover letter or attached to this annual report with reference in a cover letter. Part II: Electronic Waste Received

Consolidation facilities must separately report the weight of covered electronic equipment (CEE) **received** from electronic waste collection sites or directly from consumers (if applicable) that is eligible to be credited to manufacturers towards their acceptance standard goals from any ineligible weight. Electronic waste collection sites are required to maintain and report this information and should provide it with electronic waste shipments sent to consolidation facilities. Consolidation facilities, in turn, should also provide records of eligible and ineligible weight with electronic waste shipments sent to recycling facilities.

Those weights must be listed in the corresponding columns in the tables on the following page, along with the name, address, and registration number² (if applicable) of each electronic waste collection site from which such electronic waste was received during this reporting period.
