2. State Level Goals

The Supplemental Nutrition Assistance Program (CalFresh) will reduce the prevalence of obesity and the onset of related chronic diseases within the California SNAP-Ed population (\leq 185 % of the Federal Poverty Level (FPL)) and others eligible for SNAP-Ed. This will be accomplished by educating and providing support to participants, especially parents and their children, to consume healthy foods and beverages, reduce consumption of less healthy foods and beverages, increase physical activity, and improve food resource management skills.

3. State Level Objectives

Objective 1: Consumption and Access to Healthy Foods

- By September 2017, increase consumption of healthy foods as described in the Dietary Guidelines for Americans 2010.
- By September 2017, increase fruit and vegetable consumption above baseline, respectively, among adults by 10%, teen by 10%, and children by 10%.

Objective 2: Consumption and Access to Healthy Beverages and Reduce Consumption of Unhealthy Beverages

• By September 2017, increase consumption of low/fat/nonfat milk and water above baseline among adults by 5%, teens by 7%, and children by 5%.

Objective 3:<u>Physical Activity and Sedentary Behavior</u>

• By September 2017, increase physical activity above baseline among adults by 5%, teens by 5%, and children by 5%.

Objective 4: Environmental Supports for Nutrition Education and/or Physical Activity

 By September 2017, at least 60 percent of local jurisdictions will report successful implementation of one (or more) place-based nutrition and/or physical activity standard(s) or environmental support(s) to nutrition education and/or physical activity.

Objective 5: Food Resource Management/ Food Security

- By September 2017, at least 25 percent of adults will report an improvement above baseline in food resource management skills such as meal planning, comparing prices, or using a shopping list.
- By September 2017, at least 25 percent above baseline of adults and seniors will report that they do not run out of food by the end of the month.

4. Jurisdiction Description

San Luis Obispo (SLO) County is a coastal, rural region with a population of 271,000. The county includes 7 incorporated cities and 20 unincorporated areas. Approximately 32% of county residents are Hispanic and 60% are white, non-Hispanic.¹ The two primary languages spoken in SLO County are English and Spanish.

In San Luis Obispo County, almost half (48.1%) of adults are overweight or obese². Research looking at youth in SLO County indicates that 32.2% of 5th, 7th and 9th graders are overweight or obese³ and 34.8% of preschool children are overweight or obese⁴.

Residents in rural areas face unique challenges that affect their ability to be physically active and access healthy food⁵. Though open space is plentiful and many fruits and vegetables are grown in rural areas, opportunities for daily physical activity are often unsafe (i.e. lack of sidewalks and/or lighting on rural roads) and healthy food vendors are often further away than corner stores selling sugary beverages and convenience foods. In SLO County, 14.6% of adults indicated that they had not exercised in the past month⁶. Approximately 33% of adults indicated that they had consumed five or more servings of fruits and vegetables the day prior and 59% of kids reported that they had consumed 5 or more fruits or vegetables the day prior. At the same time, 58.7% of adults and 67.6% of SNAP-Ed eligible adults, as well as 76.6% of youth indicated that they consumed fast food one or more times in the past week. According to California Health Interview Survey data released in October 2013, while most of the counties across the state saw declines, San Luis Obispo County saw a 9% increase in the percentage of youth drinking one or more sugar-sweetened beverages per day from 2006-07 to 2011-12.

San Luis Obispo's low-income adult population appears to be under-represented in terms of census data and Cal-Fresh participation rates. The county ranks 51 of 58 counties on the Cal-Fresh Program Access Index⁷. While only 6.5% (17,743) of total county residents participate in Cal-Fresh, 44.3% (15,366) of all school-age kids qualify for the Free or Reduced Meal Program⁸. In addition, only four census tracts (7.5%) qualify for SNAP-Ed services while 39 schools (46.4%) meet the requirements for SNAP-Ed services. Of the four qualifying census tracts, two are located at or near our

local California State University and therefore may not actually qualify for SNAP-Ed services. There may be many reasons why the census data are not showing higher numbers of qualifying census tracts including lack of population density in rural areas, and/or high concentrations of university students who may be supported by their parents and therefore reporting low-incomes.

In the county there are several other nutrition-related programs serving low-income residents including: The Senior Nutrition Program, the Women Infants & Children (WIC) program, Cal Poly STRIDE (Solutions Through Research In Diet and Exercise), County Department of Social Services (DSS) Cal-Fresh, SLO County 4-H Youth Development Program, Food Bank Coalition of SLO County (food distribution, afterschool meals, breakfast pilot program, nutrition educator), National School Lunch Program, Dignity Health Community Education, and SLO County Health Educators.

5. County Nutrition Action Plan (CNAP) Partners (Or Comparable If Not Available) The goal of the SLO County Nutrition Action Plan (CNAP) work group is to coordinate and leverage nutrition messages, education, and services between United States Department of Agriculture (USDA) Food and Nutrition Service (FNS) funded and unfunded partners in order to maximize benefits for our low income population. Partners include representatives from UC Cooperative Extension (UCCE) Youth Families & Communities Program, the Local Health Department, local non-profits (such as Dignity Health, Boys & Girls Club, Community Action Partnership of San Luis Obispo (CAPSLO), One Cool Earth, Food Bank Coalition, etc.), Cal Poly State University, pre-K-12 schools, WIC program, and DSS.

The CNAP meets quarterly to coordinate agency work throughout the county. To achieve better coordination and efficiency, CNAP developed an assessment spreadsheet to leverage nutrition education messages and resources, help identify gaps in nutrition education services, and identify underserved areas. This work plan was developed using the assessment spreadsheet and input from CNAP partners.

UCCE and LHD will focus on different school districts. LHD will implement Smarter Lunchrooms and School Wellness interventions in the north county at Paso Robles Unified, UCCE will work on Smarter Lunchrooms in south county Lucia Mar Unified in partnership with Dairy Council of California. Partnerships between LHD, UCCE, CAPSLO, Dignity Health, Food Bank Coalition of SLO County will work together to leverage resources to offer nutrition education and physical activity through classes, workshops, and community events. LHD will be working with community Champions in the South County and supporting school garden and wellness efforts there in cooperation and coordination with UCCE. Coordination, information and resource sharing will take place at quarterly CNAP meetings and through additional planning meetings and ongoing communication.

6. Community Assessment data used to develop this Work Plan

The information in the jurisdiction description comes in part from the SNAP-Ed County Profiles prepared by CDPH, which includes county-level data from a variety of sources such as American Communities Survey (ACS) five-year estimates, Department of Social Services CalFresh Annual Trends data, the California Health Interview Survey, Feeding American's Map the Food Gap, Food Insecurity in Your County. Additional information was obtained from the 2013 ACTION for Healthy Communities Report, 2010 CDC Pediatric Nutrition Surveillance System, a locally-based study by Jankovitz et al. (2012), the 2014 press release from California Food Policy Advocates, and the 2011 UCLA Center for Health Policy Research.

This work plan was also informed by Communities of Excellence in Nutrition, Physical Activity, and Obesity Prevention (CX3) assessments conducted in three low-income communities (Paso Robles, San Miguel, and Oceano) as well as continuous work within these communities and feedback from nutrition education intervention participants. Area residents and community partners are interested in working with SNAP-Ed implementing agencies on the following Policy, Systems and Environment (PSE) change efforts: supporting and providing technical assistance to ensure low-income access for Farmers' Markets; working with Food Service to increase students' fruit and vegetable consumption through Smarter Lunchroom strategies and increased use of local produce; support and monitoring of local School Wellness Policy implementation; starting or supporting school and community gardens; and an emerging theme of developing joint use policies in communities where there is not access to parks or other physical activity opportunities. PSE priorities were identified based on informal key informant interviews and surveys with nutrition education participants.

Nutrition education related interventions were developed and informed by data (described above) indicating that adults and teens do not consume enough fruits and vegetables, lack access to physical activity opportunities, as well as data showing a disconcerting increase in the percentage of youth drinking one or more sugar-sweetened beverages in SLO County.

The local interventions detailed in this plan primarily focus on eligible school sites and food bank distribution sites within communities where a high percentage of potentially eligible SNAP-Ed population live, work and play. Further, because there are few eligible census tracts in our county, much of the work in this plan is focused on eligible school sites, Food Bank distribution sites, and eligible congregate meal sites as hubs for conducting comprehensive nutrition education and physical activity related interventions that can reach the broader community. Both the LHD and UC Cal Fresh implementing agencies have a history of conducting successful interventions in the school and community settings and we will use impact and outcome evaluation data and participant feedback to continually inform program planning and scaling.

In addition, consistent with a socio-ecological model and health education theory, this work plan addresses the need for implementing agencies to participate in community events and develop social marketing and social media that supports distribution of nutrition and physical activity messages on a broader scale to help ensure that the SNAP-Ed eligible population is reached in all parts of the county. These community events provide an opportunity for SNAP-Ed funded staff to reach a broader audience and reinforces the messages conveyed in nutrition education interventions. Coordinated community events may include: Latino Health Awareness Month, Walk to School Day, Day of the Child, Drinking Water Week and Physical Activity Days.

In addition, work within our CNAP work group informed the development of coordinated and collaborative intervention activities such as development of a Champion Moms/Dads program and coordinated work in high priority areas. Further, because local statistics show that residents are not fully participating in Cal Fresh and other food programs within the county, through CNAP we will continue to partner with Cal Fresh outreach workers to attend nutrition education events and provide consumer information about availability of food programs within the county, and work with WIC and DSS to disseminate information.

INTERVENTION NARRATIVE SUMMARY, FFY 15:

The implementing agencies in SLO County – UCCE, LHD, and AAA – will collaborate to provide education and support to consume healthy foods and beverages, decrease consumption of less healthy foods and beverages, increase physical activity, implement environmental supports for nutrition education, and address food resource management/food insecurity among the SNAP-Ed eligible population in accordance with the 5 state level objectives.

Activities were selected based on community needs described in the Jurisdiction Description and Community Assessment sections at the beginning of this work plan. The implementing agencies will collaborate to provide comprehensive, multi-level interventions within the communities and schools being served. The agencies will employ public health approaches including problem surveillance, identification of causal factors, development and evaluation of interventions, and implementation and scaling up of effective programs where resources allow.

This will be accomplished through comprehensive behavior-focused nutrition education/physical activity promotion with environmental supports, participation in community events, training and technical assistance for community members and agency staff, utilizing social media and public relations and coordination/collaboration with schools and Community Based Organizations (CBOs) throughout the county.

Delivery methods include:

- For the adult and senior priority population: series classes; one-time classes; community events; and environmental supports (see specific numbers and activities in Section C)
- For the pre-K to High School youth priority population: classroom lessons, cafeteria tastings, school environment changes, and school garden activities
- Utilizing CX3 and other community driven assessment findings implementing Policy, Systems and Environment (PSE) activities: supporting
 and providing technical assistance for Farmers' Markets; working with Food Service to increase students' fruit and vegetable consumption
 through Smarter Lunchroom strategies, as well as increase the use of local produce; supporting local School Wellness Policy
 implementations; starting or supporting school and community gardens and/or joint use policy to increase access to physical activity
 depending on the goals of the community.

FFY 2015:

- LHD will use a coordinated school health model to provide comprehensive nutrition education obesity prevention services within the school setting.
- LHD will provide teachers with curricula, materials and training to conduct in-class nutrition education/physical activity and food tastings with students.

- LHD will provide a 5-class series including nutrition education and community advocacy for adults in priority communities, schools and food bank distribution sites
- LHD will work with Food Service staff and school parents in priority schools to provide fruit and vegetable tastings at lunchtime and work to increase local food procurement in one school district.
- LHD will continue work with community members in priority communities to assess, identify and advocate for policy, systems and/or environmental changes that promote increased access to fruits, vegetables and/or physical activity.
- LHD will convene quarterly CNAP meetings with stakeholders and partners to leverage nutrition education messages, coordinate community
 activities, monitor and promote existing obesity prevention related policies, and increase local agency capacity to address the 5 state level
 objectives
- LHD will work with school food service staff at 2 priority schools to assess, identify, implement and evaluate Smarter Lunchroom strategies to increase fruit and vegetable consumption
- UCCE will provide teachers with curricula, materials and training to conduct in-class nutrition education/physical activity and food tastings with students in 3 priority communities.
- UCCE will provide teachers with curricula, materials and training to conduct garden-based nutrition education and food tastings with students in 2 priority communities.
- UCCE will provide a 4-class series of nutrition education for adults in 2 priority communities.
- UCCE will provide training and technical assistance for nutrition and resource education for 3 alternative education high schools.
- UCCE will provide training and technical assistance to 2 priority schools' food service staff about creating a Smarter Lunchroom Movement
- LHD and UCCE will develop a collaborative Peer Education program with Dignity Health and the Promotores Collaborative to provide training and oversight of nutrition education series classes conducted in priority communities. This collaboration draws on the expertise of each specific agency to provide training on youth education, adult education and community advocacy methods.
- LHD and UCCE will conduct and/or participate in coordinated community events in identified priority communities to promote nutrition education/physical activity and other interventions
- LHD and UCCE will work collaboratively to develop a training protocol and "Champion" program to empower and motivate parents and community members to provide nutrition education related activities to SNAP-Ed eligible.
- LHD and UCCE will work to support the development of a farmer's market and the acceptance of EBT in 1 priority community
- LHD and UCCE will work collaboratively to leverage resources and messages aimed at promoting, implementing and revising school
 wellness policies at a minimum of 4 priority schools and develop joint use policies depending on the goals of the community
