**Terms of Use:**

**The purchaser shall be responsible for all purchases made using the cardlock cards issued to the Purchaser, regardless of whether use by a person is authorized or fraudulent. The Purchaser will immediately notify J.E. Clark II Corp at 805-525-1525 or Toll-Free at 1-866-532-5275 (24/7) if a card is lost, stolen or misused. The Purchaser agrees that they, or anyone issued cards under them, will not have the PIN number security access code on or near the card should it become lost, stolen or used fraudulently in any way.**

**If there is any change in the ownership of Purchaser or if substantially all of the assets of Purchaser are sold, Purchaser shall promptly notify J.E. Clark II Corp of such sales and J.E. Clark II Corp shall have a lien on all the assets of Purchaser and a lien on the proceeds of such sales to secure payment of all outstanding sums owed to J.E. Clark II Corp.**

**Purchaser represents that it and any person using the cardlock cards delivered to Purchaser are and shall be aware of the proper use of the cardlock system and shall use safe practices in compliance with regulations of the local Fire Code in the handling of fuels dispensed from the cardlock system. Purchaser agrees to indemnify and hold J.E. Clark II Corp harmless from any claims and costs including, but not limited to, those for bodily injury and property damage which may be occasioned by the negligence or misuse of the cardlock system by Purchaser or any person using the cardlock system with cards issued to the Purchaser hereunder.**

**J.E. Clark II Corp shall use its best efforts to maintain the cardlock system in good working order and condition at its expense, however, J.E. Clark II Corp shall not be responsible for any damage or loss which may result from its failure to provide fuel or the failure of the cardlock system in any manner whatsoever. Purchaser shall promptly notify J.E. Clark II Corp of any malfunctioning of the cardlock system of which Purchaser or such person is aware.**

**Purchasers right to purchase fuel through the cardlock system may be terminated immediately upon breach of any terms hereof or any other agreement with J.E. Clark II Corp and may be terminated upon notice by either party. Upon termination, Purchaser agrees to surrender all cardlock cards issued to purchaser and to immediately pay all outstanding sums owed to J.E. Clark II Corp.**

**In case of a lost or stolen card, purchaser shall be responsible for purchases made by said card(s) for up to 24 hours from the time J.E. Clark II Corp is notified.**
