On 07/30/2014 at approximately 1600 hours I, Officer Aaron Wise was asked by Sergeant Dowd to speak with Officer Xiong reference an incident that occurred earlier in the day.

Officer Xiong explained to me the following:

At approximately 1508 hours Boulder Police Dispatch aired that a Western Disposal Trash truck was stolen from the area of 2995 E College Ave. in the City/County of Boulder in the State of Colorado. According to Officer Xiong, Officer Biekert informed dispatch over the radio that he was behind the truck and was going to attempt to stop it going eastbound on U.S. 36 (see Officer Biekert's supplemental report for further details).

Officer Xiong then explained to me that the truck did not stop after Officer Biekert initiated a traffic stop with his emergency lights and siren on. I was also informed that Officer Spicely was not too far behind Officer Biekert en-route to cover Officer Biekert. With the truck still eastbound on U.S. 36 and Officers still following, Boulder County Sheriff Deputy Salaman was waiting at the McCaslin on ramp to eastbound U.S. 36 ready to deploy stop sticks if needed. The stop sticks were deployed and hit by the trash truck's driver side front tire; the truck

however, continued on eastbound U.S. 36. (See Boulder County Sheriff report #14-4192)

By this time there were 3 agencies involved: Boulder Police Department, Boulder County Sheriff's Office, and Broomfield Police Department.

Once the first set of stop sticks was unsuccessful, Boulder Police Department terminated its involvement. However, shortly after Boulder Police terminated their involvement, it was aired over dispatch that a second set of stop sticks were deployed at U.S. 36 and Wadsworth, but were avoided by the driver. The driver took the Wadsworth exit ramp to head northbound on State Highway 287. Dispatch then aired that the truck crashed in the #1 lane on Highway 287 between Midway and U.S. 36 in the City/County of Broomfield, Colorado (see Broomfield accident report #14-4183). The driver of the trash truck was taken into custody at approximately1548 hours by Broomfield Police and Officer Spicely then responded to transport the driver to the Boulder County Jail. The driver was identified by his Colorado Identification Card as Daniel Jordan Morkert, date of birth 10/05/1987. Daniel is further described as 5' 07" tall, 135 pounds, with brown hair and brown eyes.

Officer Xiong informed me that the truck was un-drivable and had to be towed from the scene, but was released to Mike Seader with Western Disposal.

While all of the above was going on, Officer Smyth contacted Jose Valencia (DOB 2/15/1983). Jose works for Western Disposal and was driving/operating the trash truck when it was stolen. Jose was backing into the trash enclosure at 2995 E College Ave. when he saw the suspect, who said to Jose, "I'm taking your truck!" Jose replied saying, "Please don't take the truck!" Jose was getting ready to pick up the dumpster at 2995 E College Ave. and had to exit the truck to open the gate to the trash enclosure. When Jose exited the truck he left the door open, Jose then saw the suspect enter the driver's seat of the truck and drive off. Jose ran up to the side of the truck still yelling at the suspect. Jose described the suspect as a white male, about 5 foot 7 inches tall, 130-140 pounds, with longer black hair, wearing brown or green clothes.

Officer Xiong met with Jody Paulson (DOB 10/12/1963) who lives just a few doors down from the suspect, now known as Daniel Jordan Morkert (DOB 10/05/1987). Jody explained to Officer Xiong that she was sure that Daniel is the one who stole the trash truck. Jody said that she thinks Daniel is Schizophrenic. Jody explained to Officer Xoing that "when the cops were out her earlier" (referring to an unrelated domestic violence call at approximately 1425 hours; Boulder Police Department case number P14-9434), Daniel thought you were there for him so he "freaked" out. When Jody was describing what Daniel looked like, he matched the description given by the Western Disposal driver.

I then spoke with Mike Seader who works for Western Disposal. Mike explained to me that the Truck that was stolen is a 2013 Autocar Natural Gas engine trash truck purchased for \$250,000.

While at the Jail, I performed a routine clearance of Daniel through Boulder Police Records and learned that Daniel has a revoked license (Colorado Motor Vehicle Case #07-410818). I issued Daniel a proof of service while at the jail. Along with the revoked license, Daniel has a lengthy criminal history including vehicular eluding, driving without a license, reckless driving.

While covering Officer Askins, I observed the arrested party Daniel Morkert leaving his apartment with his dog. Because we were dealing with the disturbance two doors down from his apartment, I was not concerned with Mr. Morkert.

As Officers were clearing the scene, Officer Askins was arresting his suspect in the disturbance and Officer Gibson and I were clearing the assist. Mr. Morkert while walking his dog, approached me and said "How's it going

Officer?" I responded "Everything is cool". He then asked me if I was a military guy and I said yes. He thanked me for my service to our country. As I was getting in my patrol vehicle he said "Can I borrow your police car?" Thinking he was just joking I said no, got in my patrol vehicle and started to leave the parking lot. On my way out of the parking lot, a Western Disposal truck was backing towards the same lot I was leaving. The truck stopped and let me out and I proceeded west on East College on my way to the Police Department.

I was almost at the Police Department, when the call from dispatch came out as a Western Disposal trash truck had been stolen from the area of East College Ave. Officers Askins, Gibson and I had just left the area after dealing with the domestic disturbance. I believed the trash truck that was stolen, was the same trash truck that let me out of the parking lot. I turned around at Scott Carpenter Park and headed to Hwy 36. Officer Biekert saw the trash truck heading east on Hwy 36 just east of Baseline Rd. I caught up with Officer Biekert and we followed as the trash truck was heading east on Hwy 36 towards Denver. The Boulder Police Dispatch Center contacted Boulder Sheriff Department, Colorado State Patrol, and Broomfield Police Department concerning the stolen Western Disposal trash truck. The trash truck was driving in a very reckless manor and failing to pull over to the emergency lights initiated by Officer Biekert and I (Officer Spicely). Traffic was very heavy on Hwy 36 eastbound doing this incident .

We followed the trash truck until we were called off the incident. As Officer Biekert and I were getting off at Hwy 287, I thought the suspect was going to continue east on Hwy 36. There were Officers from Broomfield Police Department just east of Hwy 287 off ramp on Hwy 36. Instead of continuing east on Hwy 36, the suspect suddenly turned across the white lined exit strip exiting Hwy 36 almost hitting a vehicle in the process. Because of the speed and sudden change of direction, the suspect lost control of the trash truck struck the off ramp wall without slowing down. The trash truck never stopped and continued up the off ramp. The suspect turned north on Hwy 287 without regard for traffic at the signal light. Broomfield Police Department was on scene and following the trash truck at that point. Officer Biekert and I terminated our evolvement in the incident and turned around heading back to Boulder. Shortly after we started back to Boulder, Broomfield Police Department stated on the radio they had the driver in custody. Officer Biekert and I turned around and went back to the scene of the arrest. Officer Biekert took photos of the scene and I took the suspect from the Broomfield Police Officers custody and placed him in my custody. I transported the suspect to the Boulder County Jail where he was booked in by Boulder Police Officer Wise. See additional reports for further details.

On 07/30/2014 at around 1509 hours, I, Ofc Xiong, was dispatched to 2995 E. College Ave, City and County of Boulder, CO, reference to an auto theft that had just occurred. Dispatch advised a dumpster truck had just been stolen from the above location. Dispatch advised the vehicle left in an unknown direction.

While I was rerouted to the above location, Ofc Biekert advised on the radio that he observed a vehicle matching the above stolen vehicle at 28th and Baseline Road. The vehicle was heading eastbound on highway US 36 from Baseline Road. Ofc Biekert attempted to stop the vehicle and the driver refused to stop. I then started driving towards US 36 and Table Mesa Drive, to assist Ofc Biekert. When I got to US 36 and Table Mesa Drive, I was instructed to go contact the driver, Jose.

When I arrived at 2995 E College Ave, I noticed Ofc Smyth was talking to the driver, Jose. I also noticed several people standing around the area of the scene. I asked them if they had witnessed anything and they stated, "No." One of them identified herself as Jodi Paulson and stated that base on the description that was provided by the driver, she believes the suspect is Daniel Morket. Jodi sated Daniel was her neighbor and lived in apartment J14. Jodi stated Daniel has a brown pitbull dog, name "Diesel." Jodi stated she thinks Daniel is schizophrenic and said that when the officers were out there earlier on an unrelated call, Daniel thought the officers were there for him so he freaked out. Jodi described Daniel as a white male, around 25 years old, 5-06 to 5-07, with long dark hair. I asked Jodi if she saw Daniel took the truck, and she stated, "No."

I spoke to Ofc Smyth and he stated that after Jose finished dumping the trash into the back of the truck at 2995 E college Ave. Jose stated he exited the truck to push the trash bin back into the enclosure. Jose stated while he was doing that the suspect jumped into truck with his pitbull and said, "I'm taking your truck!" Jose said, Please don't take my truck." Jose stated the suspect ignored him and drove off with the truck. Jose stated he ran up to the side of the truck still yelling at the suspect. Jose described the suspect as a white male, about 5 foot 7 inches tall, 130-140 pounds, with long dark hair, wearing brown or green clothes.

On 07/30/2014 at approximately 1508 hours I, Officer Matthew Smyth, responded to the call of a theft in progress that had just occurred at 2995 East College Avenue in the City and County of Boulder, State of Colorado. While en route, Boulder Police Dispatch aired that a Western Disposal Trash Truck was stolen and was last seen on Aurora Avenue. I responded to meet with the complainant, Jose Valencia, who was standing by at 2995 E. College Avenue.

Valencia told me that he was emptying a dumpster on the east side of 2775 E. College Avenue when he observed the arrestee (later identified as Daniel Morkert) standing nearby. Valencia did not have any interaction with Morkert at that point in time but said that he observed a back pack that may have belonged to him in the vicinity.

After emptying the first dumpster, Valencia reversed into the parking lot on the north side of 2995 E. College Avenue and emptied that dumpster into his vehicle. He got out of his truck to place the dumpster back into the holding area and when he turned around he witnessed Morkert getting into the unlocked driver side door of the truck. Morkert stated, "I'm taking your truck!" to which Valencia replied, "Please don't take the truck!" Valencia approached the driver side door (where Morkert was sitting) and continued to yell. Valencia was going to attempt to get Morkert out of the truck but he stated that he decided not to when he saw Morkert's Pit Bull sitting next to him. Morkert then drove off with the trash truck towards the area of Aurora Avenue.

Valencia described Morkert, as about 5 foot 7 inches tall, slight build, 130-140 pounds, dark hair and wearing brown or green clothes. Valencia called 911 as soon as Morkert drove off with the vehicle.
