## SAMPLE BEQUEST LANGUAGE

A gift to St. Augustine Catholic Church in your will or revocable trust proclaims your confidence that we will continue to fulfill our mission and make a difference in the lives of future generations. A bequest:

- Is easy to arrange.
- Will not alter your current lifestyle in any way.
- Can be easily modified to address your changing needs.

**RESIDUAL BEQUEST:** A residual bequest comes to us after your estate expenses and specific bequests are paid:

I give and devise to St. Augustine Catholic Church, located in Kit Carson, Colorado, all (or state a percentage) of the rest, residue and remainder of my estate, both real and personal, to be used for its unrestricted use (or for the support of the St. Augustine Parish Endowment Fund).

**SPECIFIC BEQUEST:** Naming St. Augustine Catholic Church as a beneficiary of a specific amount from your estate is easy:

I give and devise to St. Augustine Catholic Church, located in Kit Carson, Colorado, the sum of \$\_\_\_\_\_\_ to be used for its unrestricted use (or for the support of the St. Augustine Parish Endowment Fund).

**CONTINGENT BEQUEST:** St. Augustine Catholic Church can be named as a contingent beneficiary in your will or personal trust if one or more of your specific bequests cannot be fulfilled:

If (insert name) is not living at the time of my demise, I give and devise to St. Augustine Catholic Church, the sum of \$\_\_\_\_\_ (or all or a percentage of the residue of my estate) to be used for its unrestricted use (or for the support of the St. Augustine Parish Endowment Fund).

**RETIREMENT PLAN:** You may name St. Augustine Catholic Church as a beneficiary of your IRA or other qualified retirement benefits. To make a charitable gift from your retirement plan, <u>simply enter the St. Augustine Catholic Church name and Federal Tax ID #84-1042155 on the Change of Beneficiary Form, available from your plan administrator. Consult with your advisor to determine the benefits you would derive from such a gift.</u>
