The Road to Recovery from Anorexia, Bulimia and Other Eating Disorders

Eating disorders often go undiagnosed and untreated in community mental health and addictions centers. Few clinicians have training in identifying and treating eating disorders. Consumers know even less and most have probably never been asked about their eating thoughts and behaviors. This workshop will teach participants what eating disorders are, how to identify them, and what to do about them. Eating disorders will be compared to other addictions, co-morbid conditions that go with eating disorders, such as mood disorders, other addictions, and PTSD will be examined and treatment options, while limited, will be addressed. There will also be discussion of how obesity often requires specialized treatment as some overeating is compulsive and disordered.

Follow-up Discussion of the Cuyahoga County Department of Children and Family Services Practice Review & Improvement Panel Report

In February 2010, public outcry about the deaths of children who had been served by the Cuyahoga County Department of Children and Family Services (DCFS) resulted in the formation of a panel made up of mental health providers and other concerned citizens. The panel reviewed how the agency made decisions about placing children in foster care, developed case plans for children in foster care, and secured the services called for in case plans and then made 72 recommendations across these three areas of analysis. Lessons Learned: 10 Years of Disseminating CET

Cognitive Enhancement Therapy (CET), an evidence-based practice improves cognitive skills and social cognition for persons recovering from mental illnesses. During 48 once-a-week sessions of computer exercises, psychosocial groups and individual coaching, clients learn how to be socially wise and vocationally effective. CET groups average 85 to 90% attendance and graduation rates. Lessons learned from the 10 years of disseminating CET will be presented.
