The Alcohol, Drug Addiction & Mental Health Services (ADAMHS) Board of Cuyahoga County's Training Institute is an approved provider through the Ohio Chemical Dependency Professionals Board and the Ohio Counselor, Social Worker, Marriage and Family Therapist Board offering Recognized Clock Hours (RCH) to Chemical Dependency Professionals as well as Continuing Professional Education hours (CPE) to Counselors and Social Workers.

Fees for the ADAMHS Board Training Institute workshops are \$25 per half-day (2-4 hour) session and \$45 for a full-day (5+ hour) session. Occasionally, workshops will be offered free on an as-needed basis per topic. Workshop fees are non-refundable. Purchase Orders and personal checks and/or money orders payable to the ADAMHS Board of Cuyahoga County are accepted. Credit cards are accepted when registering through Eventbrite. All workshop participants must be registered and confirmed in advance. Walk-ups and cash payments will not be accepted.

## **When the Brain Rains: Understanding the Connection Between Adolescent Brain Development and Alcohol Use**

We will examine the connection between adolescent brain development and adolescent alcohol use. Functional changes take place in the brain from childhood to adulthood. During adolescence changes to the synapses, nerve calls and pre-frontal cortex are greatly impacted by alcohol use. This brain remodeling, that transpires in adolescence impacts the pruning of existing synaptic connections that impact the processes involved in planning and decision making, impulse control, voluntary movement, memory, and speech production, among others (Rubia et al., 2000). Similar changes occur in parts of the brain that seem to affect how a person responds to alcohol and other drugs (Spear, 2000; Teicher et al., 1995). As a result, alcohol appears to have different effects on adolescents than adults (Spear, 2000).

## **EDUCATIONAL REQUIREMENTS FOR CHEMICAL DEPENDENCY COUNSELOR ASSISTANT (CDCA) APPLICANTS**

According to Ohio Chemical Dependency Professionals Board, Chemical Dependency Counselor Assistant (CDCA) applicants will be required to demonstrate 40 educational hours in the following eight content areas:

### **Addiction Knowledge (5 hours)**

- Definition of addiction and range of substance related problems
- Biopsychosocial, cultural and spiritual factors related to addiction
- Understanding substances and their effects on brain processes and physiology
- Models and theories of addiction
- Epidemiology of substance use disorders
- Social, political, economic and cultural contexts of addiction and abuse
- History of alcohol and drug enforcement and addiction treatment policies in the US
- Prevention strategies

### **Treatment Knowledge (9 hours)**

- Models of treatment, recovery, relapse prevention, and continuing care for addiction
- Principles of effective treatment
- Recovery management models
- Appropriateness of treatment to client needs, characteristics, goals, and financial resources
- Historic and evidence-based treatment approaches
- Levels of care
- Stages of change
- Research evaluation
- Interdisciplinary approaches to addiction treatment
- Medical and pharmacological resources in the treatment of substance use disorders
- Helping strategies/engagement strategies
- Treatment planning and methods for monitoring and evaluating progress

### **Professionalism (6 hours)**

- Professional, legal and ethical parameters of addiction practice
- Interdisciplinary approaches to addiction treatment
