CREDIT TERMS AND CONDITIONS

In consideration of the terms of sales, herein and for the extension of credit by Whitfield Oil Company, Inc., the undersigned as an approved representative of applying company (herein referred to as the Applicant) agrees to pay for all purchases in accordance with the terms and conditions set forth below. The applicant assumes full responsibility for payment of goods delivered to the applicant's place of business or location provided by special instruction from the applicant or any approved agent of the applicant. The applicant agrees to notify Whitfield Oil Company, Inc. within 24 hours of any shortages of product delivered and ten (10) business days of any discrepancy in billing invoice.

TERMS

- ✓ Credit for wholesale diesel fuel & gasoline are due NET SEVEN (7) days from the date of delivery.
- ✓ Fastway account terms are EFT (Easy Pay) on the 15th of the billing month.
- ✓ Credit for lubricants and other products are due NET THIRTY (30) days from the date of delivery.

CREDIT POLICY

Credit lines will be established and based on information the applicant supplies to us, and through reports from credit reporting companies. Credit lines will be updated on a "need to be" basis. Your assigned account representative may ask for a prepayment should the credit limit be reached before further shipments are made. Permanent loss of credit may occur if frequent delinquencies occur.

A finance charge of 1.5% will be charged to all accounts not paid by the due date. This is an annual percentage rate of 18%. Based on Whitfield Oil Company's credit standards, delinquent accounts will be placed on credit hold until said account is brought current. At any time, the applicant may be required to remit payments via electronic funds transfer (EFT) to clear outstanding lubricant or fuel balances that are past due.

RETURNED CHECKS

A service charge of twenty (20) dollars will be placed on any account submitting an insufficient payment. The applicant's credit limit will be void after two (2) insufficient payments within a twelve (12) month period.

COLLECTION

The information provided to Whitfield Oil Company by the applicant(s) is warranted as true and accurate. The applicant(s) agrees to pay all costs and expenses including but not limited to attorney fees, incurred by Whitfield Oil Company, Inc., in the collection of past due accounts.
