The University of Cincinnati's Educational Leadership Program is a course sequence for individuals interested in earning a principal license. This course sequence is **only** available to students who already have a master's degree. The course sequence will be delivered in an entirely online format.

The Principal Licensure course sequence provides graduate study, research, field experience, and career development for all persons who aspire to, or presently hold, educational administrator positions. The principal licensure course sequence meets the requirements for licensure in the State of Ohio (out-of-state check with your state licensing board).

#### **Course Requirements for Licensure:**

The Educational Leadership Program is dedicated to serving the diverse, pluralistic leadership needs of all schools, throughout the State of Ohio. We welcome applications from those who would like to be a part of our learning community.

#### Transfer of Credits (Advanced Standing):

On a case-by-case basis, a student may petition to have graduate credit from an accredited college or university counted as the equivalent of another course in the curriculum and accepted as transfer credit. In such cases, a student will have to supply a course syllabus to ensure that the content in the course taken at another university is equivalent to the content of the course in the principal licensure course sequence curriculum. A course with a similar name or the same name as a course offered at the University of Cincinnati does not necessarily mean that the content of the course is similar enough to accept it as transfer credit to our program. Furthermore, some courses in the principal licensure course sequence dat the principal licensure course sequence curriculum are required and cannot be transferred from another college or university.

Students may transfer up to 9 hours of graduate credit in Education courses from an accredited college or university, although this is clearly viewed as an exception due to licensure and NCATE/CAEP requirements in the 20 hour licensure course sequence. Graduate courses outside of education will not be accepted. Courses taken outside an accredited college or university—such as non-credit professional development—will not be accepted. Only courses with grades of B or higher will be considered for transfer. No credit is given for previous work history. Courses taken more than 5 years prior to a student's date of application to the program will not be accepted as transfer credit.

#### Step 1 - Educational Leadership Application

#### 1. Student Admissions Application

In this application packet is the Principal Licensure Sequence Application Form. Complete this form and include it in the application materials you send to the Educational Leadership Program.

#### 2. Letter of Application

A letter of application is required for admission to the program. Your letter should be addressed to the Educational Leadership Admissions Committee and should discuss your interest in school administration and your leadership potential. Include your letter of application in the application materials you send to the Educational Leadership program.

#### 3. Professional Resume and License

A professional resume with three references and a copy of your current teaching license should be included in the application materials you send to the Educational Leadership Program.

#### 4. Undergraduate and Graduate Transcripts

Official transcripts of all undergraduate and graduate coursework are required. Transcripts must be sent directly from each institution to the Educational Leadership Program in order to be considered official transcripts. Student copies will not be accepted. These transcripts will be used to audit student coursework that may be transferred in. Please review the guidelines above regarding transfer credit.

#### 5. At Least Two Years of Teaching Experience under a valid teaching license.

6. International Applicants: Submit Official Scores for the Test of English as a Foreign Language (TOEFL) or the International English Language Testing System (IELTS) (If Applicable)

- International students are required to submit official TOEFL or IELTS scores for tests taken within the last seven years, prior to the application deadline for the term of the application. These scores must be submitted directly to the program office at the address given in Step 6.
