Equine Gestalt Psychotherapy utilizes Gestalt methodologies coupled with the human/horse relationship to assist clients in examining their life with a focus on designing a positive future. The horse and therapist are partners in this approach and work together in the client's exploration of self and experiences. The uniqueness of this integrative approach highlights somatic awareness related to emotional blockages. As a result, physical, emotional, and spiritual healing can occur. Because the horse and therapist are active partners, the profound ability of the horse to become energetically engaged in the healing process is acknowledged and honored for its contribution.

Equine Assisted Psychotherapy (EAP) incorporates horses experientially for emotional growth and learning. It is a collaborative effort between a licensed therapist and a horse professional. The focus of EAP involves setting up activities involving the horse(s) which will require the client of group to apply certain skills. How they approach the activities and use their skills provides therapeutic information for processing. EAP is an effective therapeutic approach that has an incredible impact on the dynamic structure of families and groups.

Utilizing Mini-Horses as Services Animals for the Blind. Ms. Ramouni will talk about her successful experience working with her miniature horse, Cali, and the profound impact it has had on her life. So much so, that she is developing a non-profit foundation to train and provide service horses to people with different disabilities. Miniature horses can be used as alternatives to guide dogs. As with service dogs, these miniature horses are chosen for their temperament, physical health, and willingness to work. Each horse is trained specifically for every handler. This ensures that the horse will help to mitigate the handler's disability.

P2 The Communication Behind the Behavior: Using iPad Apps To Meet Pediatric Patients' Psychosocial Needs

This qualitative research partners with the University of Michigan Mott Children's Hospital to explore how iPads and applications can address and support the biopsychosocial needs of pediatric patients. Prolonged hospitalization presents great challenges for ill children. Beyond the obvious biological, or medical needs, hospital personnel must consider the psychological (mental and emotional) and social (environmental) implications of being sick or injured. Medical procedures, pharmaceuticals, etc., treat the body, but what about the mind? This study investigates how specific iPad apps can help children manage pain and anxiety while improving their coping and goal setting skills.
