## EVENT DETAILS

**PARKING:** Parking for the event is free prior to 9:00am. Enter through the 66th Ave. entrance and park in A-Lot.

**STROLLERS AND PETS:** For the safety of pets and other runners, we ask that you leave your animals at home. We encourage you to bring young ones out in baby joggers or infant strollers to join in the cause and have fun!

**WATER:** There are two water stops on the course provided by Arrowhead Water, the official water of the Oakland A's.

**ENTERTAINMENT:** Fog City Entertainment will provide pre- and post-race music. Krispy Kreme Doughnuts, New Mecca Café, Pepsi and Arrowhead Water provide food and beverages for the tailgate party.

**AWARDS:** The awards ceremony will take place following the run. Prizes donated by Macy's, Shell Vacations, Aloha Airlines and Silverado Country Club and Resort.

**FEES:** Pre-registration fee is \$25 per runner. Deadline for pre-registration is June 10, 2005. Registration for entries received after June 10th and day-of-race is \$35 per runner. Entries received after June 10th will not have their packets mailed out and must be picked up at the registration area on race day. Event t-shirts for all participants will not be mailed and will be available for pick-up at the registration area on race day. Additional game tickets, which include the tailgate party, are available for \$20 per guest. Online registration is available through active.com or link through onyourmarkevents.com. Race will take place rain or shine.

LIABILITY WAIVER AND RELEASE AGREEMENT ("Agreement")

In consideration of the Oakland A's/Macy's of California allowing me to participate in Macy's/Oakland A's 5K Fun Run ("5K Run"), I hereby agree, warrant and covenant to be bound and otherwise abide by the following terms and conditions. I acknowledge that participating in the 5K Run may be a potentially hazardous activity. Therefore, I warrant and otherwise represent that I will not enter and participate unless I am medically able to do so and, properly trained, I am assuming all risks associated with my participation in the 5K Run, including but not limited to any and all effects of weather, such as high heat, extreme cold and/or humidity, traffic, course conditions/surfaces, falls and contact with other 5K Run participants, volunteers, and/or spectators. I am aware that medical support for the 5K Run will be provided by volunteer personnel who may be called upon to provide assistance, including first aid, to me. Furthermore, I agree to abide by the decision of any race official relative to my ability to safely complete the 5K Run. Having read this Agreement and knowing these facts, and in consideration of the Oakland Athletics and Macy's of California, the City of Oakland, and County of Alameda, I hereby agree to release, defend, hold harmless, and hold the City of Oakland, the City of Oakland, and County of Alameda, and all other persons or organizations named in this Agreement, known or unknown, arising directly or indirectly out of my participation in the 5K Run or any related activity, even though liability may arise from negligence or carelessness on the part of persons or organizations named in this Agreement. I consent to the use of photographs, video, film, and sound recordings taken by the Oakland A's/Macy's and any other foregoing partners of the 5K Run, for any lawful purpose, promotional or otherwise. Therefore since this Agreement releases all known, unknown and/or anticipated personal/property damage injuries/claims (including death) which arise or may arise in connection with the 5K Run, I hereby waive any and all rights or benefits I may have under California Civil Code Section 1542, which states as follows: "A general release does not extend to claims which the creditor does not know or suspect to exist in this/her favor at the time of executing the release; which, if known by (him/her), might have materially affected (his/her) settlement with the debtor."
