REGISTRATION:

All registration is online at www.missmillcreek.com and closes at 11:59pm on August 31st. Registrations can be edited through the close of registration. Fees are due by the close of registration.

ATTIRE:

This is a natural pageant that does not like anything fake (hair, teeth, etc.) A teen should look like a teen. The Miss Mill Creek Pageant is looking for age appropriate representatives who are the total package. Pageant dress and makeup should be age appropriate.

BACKSTAGE ACCESS:

In order to keep the backstage area secure and as stress free as possible, only contestants will be allowed in the backstage area.

MISS SWEETHEART SPONSORSHIP:

Miss Sweetheart Princesses will be awarded in each grade, subject to qualification. Miss Sweetheart Princesses will be onstage during the coronation of Miss Mill Creek during the high school pageant. The princess collecting the most Miss Sweetheart sponsorship money will be awarded the title of Miss Sweetheart and recognized for her contribution to the Mill Creek Encore Alliance.

TICKET PRICES:

Presale tickets will be available online. Tickets prices are \$5 for the Elementary and Middle School divisions and Miss Portray Pageant. Tickets for the High School division are \$10. Advance purchase of tickets is advised so that your friends and family do not find themselves unable to attend the pageant because of a sold out house. One compliminary ticket will be issued to the family of each contestant for the division in which they are competing.



Miss Mill Creek Pageant Rules

- All judges' decisions are final! Talking with the judges while they are judging is prohibited. If any family, friends of the contestants or the contestants themselves is caught violating this rule, the contestant will be disqualified.
- Good sportsmanship is required at all times. Failure to show good sportsmanship (including parents and guests) will result in the disqualification of the contestant; without refund and with forfeiture of any and all awards received. It may also result in contestant not being allowed to compete in the pageant the following year. This includes texting, Facebook, mySpace and any other social media, during or after the pageant.
- All registration/entry fees are non-refundable.
- Miss Mill Creek Pageants reserves the right to refuse admittance to anyone that the director, MCEA Board, or school Administration deem a security risk. This includes all pageant events.
- Miss Mill Creek Pageants and the host buildings are not responsible for loose due to injury incurred at, or in travel to and from all pageant events. Miss Mill Creek Pageants are also not responsible for any thefts that may occur.
- Miss Mill Creek Pageants, MCEA Board, and school administration require high moral standards; therefore any contestant or winner caught engaged in such acts as drinking/drugs, smoking, swearing, etc. will be immediately disqualified at the discretion of the director and the MCEA Board.

- Each pageant contestant must be in good academic standing; passing all six of their classes. Potential contestants who fail to meet this criterion will not be allowed to participate in the pageant.
- Contestants must participate in the pageant in the grade level listed on their official Mill Creek transcript.
- You attendance at Mill Creek must follow school policy.
- Attendance at all pageant rehearsals is MANDATORY. All practices are listed on www.missmillcreek.com and outlined in the contestant letter.



Awards

The Miss Mill Creek High School Scholarship Pageant will award titles in four divisions: Miss Freshman, Miss Sophomore, Miss Junior and Miss Mill Creek 2014-15. Along with these; titles will be awarded in the categories of Miss Congeniality, Miss Sweetheart, Most Photogenic.

TAGS: Attached is a sheet of tags. If you want to type in the information before copying to colored paper, you can save this file to your computer, re-open it and fill in the forms, then print to any color paper you like; or you may print the tag sheet on white paper and copy them onto any color paper and use any color pen or fancy scissors which makes sorting tags easier! THE KEY IS COLORED PAPER! Safety pin tags to the upper right hand corner of the garment (as you face it.) NO STRAIGHT PINS PLEASE.

SELLER CODE: Please use the last 4 digits of your phone number. Please be sure to register (by returning the attached form along with a copy of your tags. (Remember to make a copy of your completed tag sheet before you start cutting them apart.)

PRICING: You set your own selling price. Most use a quarter to 1/3 of retail value. Some use an average price like \$50.

REMEMBER: You keep 70% of the selling price, with 30% going to the Theatre Department.

CLOTHING: Please carefully inspect all your items before tagging them. We do not accept stained, torn or faded items. Follow the hanging and tagging instructions listed above.

ACCESSORIES: Safety pin belts, ties, and other accessories to the dress.

Q: How can I donate items that I do not want to sell to the MCHS Theatre Department? A: You can drop them off at the same time as the sellers.

Q: Should I keep my dress in a garment bag to protect it?
