

# 2014-15 Federal Direct Parent PLUS Loan Authorization Form

The purpose of this form is to grant Dominican University permission to access your Direct PLUS Loan Request and credit check which will be completed at www.studentloans.gov. To be eligible for the PLUS loan, the student must be enrolled in a degree-seeking program for at least six credit hours each semester of the loan period. Please note that federal regulations do not allow PLUS loan requests to be processed for an outstanding balance that is associated with an academic year that has ended.

## **Step One**

Parents who do not have a parent PIN or cannot recall their PIN should go to www.pin.ed.gov to request one.
