Please make sure that you (and your parent{s}, if you are a dependent student) **complete your 2014-2015 FAFSA online** at <a href="https://www.fafsa.ed.gov">www.fafsa.ed.gov</a> Students and parents are strongly encouraged to use the IRS data retrieval tool when completing the FAFSA to avoid delays in financial aid processing.

### **SEANC Scholarship**

The State Employees Association of North Carolina (SEANC) Scholarship Foundation, Inc. will issue 46 annual scholarships in 2014 for SEANC members, their spouses and their dependents.

The scholarship application consists of three categories: Financial Need, Merit and Member Only. The scholarship application is available online at

www.seanc.org/membership/scholarship/ and must be returned completed to the District Scholarship Chairperson postmarked by April 15, 2014. All winners will be notified by July 1, 2014.

## Forgivable Education Loans for Service (FELS)

The FELS application and information for 2014-15 will be available beginning in November 2013. The priority deadline for submitting the FELS application is April 1, 2014. Students must apply online at <a href="www.cfnc.org/fels">www.cfnc.org/fels</a>. They are required to sign a Master Promissory Note (MPN) and agree to work in NC after graduation. In addition, they must agree to work one year for each year of funding received. Failure to perform the required service will result in repayment of the loans with interest. Students must major in nursing, teaching, allied health fields or medicine.

#### \*New\* Question of the Month

Question: If I received an email or letter in regards to Federal Pell Grant Lifetime Eligibility Used (LEU), how is my LEU calculated and how I can I view my LEU percentage?

Answer: The Department of Education keeps track of your LEU by adding together the percentages of your Pell Grant scheduled awards that you received for each award year. To determine how much of the maximum six years (600%) of Pell Grant you have used each year, the U.S.

Department of Education (ED) compares the actual amount you received for the award year with your scheduled award amount for that award year. You can log on to National Student Loan Data System, using your Federal Student Aid PIN and view your LEU. The LEU will be found on the Financial Aid Review page.

#### **Veteran Services**

All VA students must submit a VA worksheet and a copy of your schedule each term signed by you and your advisor. This worksheet informs us of the classes you are taking in your degree program. - Satisfactory Academic Progress (SAP) is very important in continuing to receive your financial aid. We encourage you to access your Student Handbook on our website for the Policies and Procedures.
  - Before withdrawing from or dropping a class, please consult with a financial aid counselor. We may have to return money and/or you could possibly lose your financial aid.
  - **Have additional expenses**? Access our website to find more information on the Parent Plus and private alternative loans that may be of assistance.
  - Repeating a class? If you are repeating a class and receive financial aid, you will only be able to repeat a previously passed course once. For more information, review the <u>Repeated Courses Policy</u> on the Office of Financial Aid Website.

• Attention 2<sup>nd</sup> Degree Students! You must submit a copy of your DARS (Degree Audit) after you have registered for your Summer and Fall classes. Your class registration must be in line with the required courses listed on your Plan of Study. In addition, if you have not submitted a copy of your Plan of Study and Written Statement, your financial aid cannot be processed. For Licensure students, you are required to submit the Plan of Study and Written Statement. If you have any questions, regarding this contact your assigned financial aid counselor.
