To be Classified as a Tennessee Resident and for fee purposes, regulations promulgated by the Tennessee Board of Regents state that an individual must reside in Tennessee for one year preceding the date of application. In determining whether a student is domiciled in Tennessee all pertinent evidence is considered by the College. Presence or absence of any particular item(s) of evidence will not automatically result in an in-state or out-of-state classification.

You may wish to attach supportive materials (letters, photocopies of documents, etc.), particularly at the places marked "Documentation".
