The Greenwich High School Student Loan Fund offers financial assistance to Greenwich High School graduates for full-time college undergraduate education by providing interest-free loans of up to \$4,000 a year for four years. New applications must be submitted for each year a loan is requested. The education may be technical preparation as well as traditional college study. Loans will not be made for graduate school. To qualify for a loan, the applicant must show financial need. You must provide 2 cosigners, each with independent income. If your application is approved, you and your cosigners will be required to sign a legal document in which you promise to repay your loan in monthly installments upon the completion or cessation of your full time undergraduate education. The loan check will be made out to you and the college you attend and you will need to endorse it over to the college for credit to your account.

If any special expenses or obligations affect your ability, or your parents' ability, to contribute toward college costs and these conditions are not otherwise disclosed on these forms, please enclose a note explaining them.

There is no deadline for filing your application, but you should allow at least five weeks for processing your application. As soon as the review process is completed, each applicant will be notified of the Board's decision. If you wish to receive a confirmation of receipt of your application, include a selfaddressed, stamped envelope or postcard, but do not contact us further regarding its status.
