**I. CALL TO ORDER**

President Bill Moor called the meeting (Session A) to order at 10 am.

President Moor requested that the agenda be modified to include a discussion of the History Project, which would be led by Val Peterson. The agenda was accepted as modified.

**IV. REVIEW AND APPROVAL OF THE MINUTES OF MARCH 14, 2012 BOARD MEETING**

The minutes of the March 14, 2012 Board meeting were approved as corrected.

**V. FINANCIAL REPORT/TREASURER'S REPORT – BARRY BRUNS**

The report was approved (see Treasurer's Report). Barry observed that the present budget was tracking well. The need to replace the office copy machine was brought up and Bill Moor instructed Carolyn Minner and Carol Moore to proceed with the replacement.

## VII. STANDING COMMITTEE REPORTS FOR THE UNIVERSITY

### A. Community Outreach Committee - Subcommittee Reports

- Adopt-A-Family – Joan Leard: No report
- Emeritus College Liaison – Dick Jacob: The Emeritus College would like to assist the ASURA publicize its activities. He asked the Board to send news items to Winifred Doane at [wdoane@asu.edu](mailto:wdoane@asu.edu) for inclusion in the newsletter and announcements to Amanda Meyers at [Amanda.Meyers@asu.edu](mailto:Amanda.Meyers@asu.edu) for distribution through E-Cards.
- Scholarship Committee - Sue Blumer referred the Board to the Committee's report for details on the selection of this year's scholarship winner. The Committee selected Krissy Jo Bergen, a single mother and a member of the White Mountain Apaches, a psychology major at ASU West.
- University Club Liaison - Jim Fordemwalt: no report
- Video History Project - Dave Scheatzle and Linda Van Scoy reported they had shown a video medley of the experiences of several members at the Annual Meeting. Bill announced that Linda would probably be leaving her position at the end of the year and that her replacement would be needed. He asked for help in finding volunteers to help her with this year's scheduling and arrangements chores.
- History Committee – Val Peterson referred the Board to the ASURA History Committee Report. The Committee is requesting that ASURA produce a printed version of the second edition of the ASURA History and consider seeking sponsorships for the printed version.

### B. Events Committee - Subcommittee Reports

- Events Committee – Bill Moor suggested that the ASURA Vice President be the chair of the Events Committee and the group agreed this would be worth trying. Barry McNeill then presented a proposed ASURA Events Calendar for the year 2012/2013. The calendar along with short event write-ups is to be published in *Prime Times*. He reported that the chairs of the various Events Committees had met and agreed to the proposed calendar had agreed to write the short blurbs. Publishing the calendar in *Prime Times* has some benefits. One, it allows the members to see what is coming up and plan accordingly and two, it offers the organization an opportunity to reduce its mailing costs. Since so few (8 last year) “snail mail only” ASURA members attend any of the events, it is reasonable to stop mailing event announcements and to rely on the *Prime Times* calendar to get event information out to the “snail mail only” members. It was agreed to stop mailing for ASURA events.

- Luncheons & Special Events – Barbara Bradford Eschbach discussed upcoming events planned by her committee: the Meet/Greet in September, a Fall Luncheon to be held at Friendship Village in November, and the Annual Holiday Potluck in December.
  - Retirees Day – Barry McNeill: Barry reported that ASU would be charging ASURA a fee for use of all the rooms in the MU for its Retirement Day event. This would require that the ASURA subsidize the event if registration fees are to remain unchanged. Barry reported that the committee had not found another venue which was less expensive. After discussion, Dave Scheatzle proposed a motion that the Board authorize a subsidy of \$750 for Retirement Day. In a discussion, Barry presented an analysis of the event’s costs and revenues and a justification of the requested supplement (see attached reports). The motion was passed.
  - Seminars – Gary Kleemann: Gary reported that the Seminar Committee met twice to discuss the seminars for 2012-2013. The Committee proposed the following list: Genealogy (September, Bill Stasi), Medicare, Affordable Care Act, Social Security (early October), ASRS versus ADOA health plans (late October synchronized to open enrollment period), Financial Planning (March), Introduction to Financial Planning for Retiring Faculty/Staff (March), Volunteering or Assisted Living (April).
  - Travel – Gary Anderson: No report. (For a list of 2012/2013 travel events, see report, ASURA Events Calendar.)
- C. Finance Committee – Mary Stevens reported that several boxes of books had been received. For a list of books, see ASU Retirees Online Sales Report. Mary referred the Board to the Annual Review of ASURA Expenditures 2010-2011 – the Finance Committee audited last fiscal year’s financial reports and found them sound.

Barry Bruns moved that the annual membership donation be increased from \$20 to \$30. Barry Leshowitz seconded the motion. The motion passed unanimously. The new membership donation will be implemented with the membership drive to begin this month.

Wilma Mathews reported that the cost of printing 750 copies would be about \$3500, which she hoped would be offset by financial support from sponsors. Barbara Shaw-Snyder offered to ask ASU Public Affairs to fund, on a one-time basis, the printing of the second edition of the ASURA History (second edition). Wilma indicated that the Committee would be seeking additional sponsors, for example, Karsten Golf Course.

Val made a motion that the Board approve the History Committee's request that the ASURA History (second edition) be published in a printed version in addition to an on-line version provided there is sufficient sponsorship and other financial support. The motion was seconded by Elmer and approved by the Board.

Bill announced that all of the committee chairs are now filled. Arthur Ashton and Robert M. Moroney have agreed to serve as co-liaisons to ADOA. Bill announced the appointment of an ad hoc committee to review and revise the ASURA Bylaws. ## Legislative Update

5/7/12

After 116 days, the legislative session came to a close at 8:25 P.M. on May 3<sup>rd</sup>, 2012, when the 50<sup>th</sup> Legislature adjourned Sine Die. As of 4:00 P.M. today, May 7, the Governor has signed 288 of the 1,395 bills introduced and vetoed 18. There are still about 80 measures that the legislature passed, upon which Governor Brewer has yet to act.

This has been a very successful session for ASU!

Our main priority of the year — Parity in per-student funding — is included in the budget!

The budget that was just signed by Governor Brewer includes an appropriation for \$11,971,100 in funding for Arizona State University - with a line stating that "It is the intent of the legislature to appropriate funding to Arizona State University and Northern Arizona University in fiscal year 2013-2014 through fiscal year 2016-2017 with the goal of achieving per student funding parity between the universities under the jurisdiction of the Arizona board of regents at the beginning of fiscal year 20162017."

The ASU community was heard loud and clear when it came to issues like keeping our campuses safe and gun free, as well as not burdening our students with a minimum tuition contribution requirement. The ASRS retirement contribution rate issue was addressed, and there were even successful bills that will promote and provide an agricultural classification for Algaculture! Our own Dr. Milt Sommerfeld, co-director of the Laboratory of Algae Research and Biotechnology, provided expert testimony on two algae bills this session.

*Thank you all for the support and help over the session. We truly could not have had such a positive session without you.*

Please be on the look-out for our official end of session Legislative Wrap-up Report, which should be out in the next week or so.

Also, please see an article from ASUnews about parity in the budget, as well as the just released signing document from Governor Brewer regarding the state budget — both are included below. Please forgive the loss of formatting in the Governor's budget document below, it is also attached.

### Statement from Governor Jan Brewer

#### *Conservative Budget Plan Positions State for Future, Prepares for Unknown*

"Today, I proudly signed into law a conservative and comprehensive budget plan that adds real **resources to our State's most critical programs, while setting aside dollars for the fiscal challenges that lay ahead.** I applaud and commend legislators of both chambers who worked with me in good faith to make this **possible.**"

**"It is worth remembering how far we've come together. When I took office in January 2009, the State of Arizona** faced an estimated budget deficit of nearly \$3.5 billion for the following year. On a per-capita basis, our **shortfall was the nation's worst.**

**"The decisions that followed were** the toughest of my career. Together, lawmakers and I cut spending by **the most in our State's history.** We asked voters to temporarily increase their own taxes — and they overwhelmingly agreed. We passed into law historic economic legislation, bringing the public and private sectors together with the Arizona Commerce Authority, and spurring business investment with broad tax reforms and targeted business incentives.

**"We have begun to see these efforts bear fruit. Our State budget is balanced, with sufficient revenues** to augment education, public safety and health and human services. Our Rainy Day Reserve is empty no longer. Best of all, the Arizona **economy is generating jobs in numbers we haven't seen in years** — 47,000 in February and March alone.

**"This is all great news. When** this budget process began, however, I warned that **'we in State** government must be mindful not to repeat the mistakes of the past, when economic recovery and fiscal exuberance too often went hand-in-hand — **leading to unwise and unsustainable expenditures.'** It is with pride that I say this budget avoids that trap, while leaving Arizona better positioned for long-term prosperity."

# State budget addresses per-student funding disparity at Ariz. state universities

The Arizona Legislature has approved a state budget that includes a plan to address the per-student funding disparity at Arizona's three state universities.

The budget bills now go to Gov. Jan Brewer, who is expected to approve. The guiding philosophy of the plan is that every student attending one of the three state universities should be supported with a base-level state appropriation at the same dollar figure.

It is unprecedented in the past 40 years of Arizona history that all three university presidents, the Arizona Board of Regents, the students, the legislature and the governor have come together and agreed upon a plan to address parity in student funding that has plagued the state for years.

"Arizona State University thanks Governor Jan Brewer and the legislature for supporting the needs of our students in next year's budget," said ASU President Michael M. Crow. "This additional funding is greatly needed and will help us to continue to provide our students with an excellent education and enable us to serve the community and the state at the high level we have in the past."

Last year ASU received nearly \$900 less in state funding per student than the University of Arizona, while Northern Arizona University received nearly \$760 less per student than UA. These disparities were caused by explosive enrollment growth in the last decade at both ASU

and NAU, for which state dollars were not increased significantly. In fiscal 2012, UA got \$6,598 per full-time student in state funding, ASU got \$5,702 and NAU got \$5,840.

The plan is to phase in additional funding over several years, beginning in fiscal year 2013, to help ASU and NAU catch up with UA on a per-student funding basis.

The state legislature approved \$15.3 million in parity funding for fiscal 2013, with the rest to be phased in over four years. The change could eventually bring nearly \$60 million more annually to ASU and \$16.5 million more to NAU. UA would not lose or gain any funding under the proposal.

In the last decade ASU has developed into a major research university, ranking among the top 100 research institutions in the world. Enrollment and research growth drove changes in ASU's cost structure, which now approximates that of UA.

## Scholarship Committee Report 2012

The Scholarship Committee met on April 12 to select the 2012-13 scholarship recipient from 35 applications. All of the participating members had spent several hours reviewing them. We selected Krissy Jo Bergen, a single mother and a member of the White Mountain Apaches, a psychology major at ASU West. She has not yet been notified.

This year's scholarship recipient spoke at the annual meeting. He seemed eager to appear and brought a guest.

At the committee meeting, we discussed the matter of whether to split the \$10,000 award between two students. Four members voted against the change, and two were in favor. Reasons for not changing are briefly as follows: (1) The award has always been for the approximate annual tuition, which is now \$9,800, with other academic fees and books bringing the total over \$10,000; (2) The student and ASURA have a good identification of this student as our scholarship student, which might not occur if the student had support from several sources; (3) The larger award helps to enable the student to work minimal hours, insuring a good academic result and degree completion; (4) These older students tend to have less family support and more family responsibilities. The reasons in favor of splitting the award are: (1) The student should be providing more of his or her support; (2) There are at least two outstanding candidates; (3) The committee should have flexibility to decide the number of awards each year based on the quality of the applicants and award amount. The committee did not recommend changes at this time.

## Request For Financial Support and Advice

The Retirees Day Committee requests the ASURA Board:

- commit additional financial support for Retirees Day by either agreeing to pay some portion of the room charges and let the committee set the registration fee to cover all other charges or to pick up those event costs not covered by the registration fee, and
- advise the committee on the desirability / acceptability of changing the event format in an effort to reduce the room fees (e.g., reduce the number of presentations per session to 3, reduce the size of the luncheon room).

## Justification of Financial Support

The cost of offering Retirees Day has increased about thirty-three percent now that ASURA has to pay room charges. A review of alternative venues has not turned up any location that is less expensive (see Table 1) and so the issue is how to deal with the MU costs. The committee was able to have the room fees waived this past year but if the fees had been assessed Table 1 shows that the registration fee would have to have been \$39.57, almost \$10 more than the actual fee and \$15 more than the fee from the year before.

If the registration fee is set too high we run the risk of discouraging members from attending. So what is too high? In order to get some sense of the impact of raising the registration fee, the 2012 attendees were polled and asked questions related to location, cost, and format. The information relative to the registration fee is shown in Table 2. A review of the table shows that while some ASURA members are willing to pay \$50/\$60/\$70 registration fees (double for a couple) this is not universally the case. When asked at what point they would *consider* not attending 58% indicated that they would at least begin to think about not coming if the fee were \$45. When asked at what point they would you not come, 16% said that would happen if the fee were \$45.

Given the data in Table 2 the Retirees Day Committee would like to keep the registration fee in the \$35 range which is only possible if the ASURA Board will approve funds to cover some of the room charges. The committee recognized that this would be a change in ASURA policy but there are already exceptions to the historic policy that events should set a fee that covers all costs except for advertising. The Fall Meet and Greet was given \$400 for food and the seminars have been given a “cookie & water” allowance. Paying for the presenters’ lunches is another cost which has historically been covered by ASURA. So the committee feels there is precedence.

## Request from Retirees Day Committee Relative to Retirees Day Registration Fees

The costs shown in Table 1 are based on 100 attendees. Since the room charges and some of the catering costs are fixed, i.e., not dependent on attendance, Table 4 and Figure 1 (next page) give a better picture of the relationship between registration fees, attendance, and event revenue shortfalls and or surpluses. Figure 1 shows that for any fixed registration fee, as the attendance increases the revenue shortfalls steadily decrease and can eventually become surpluses. Table 4 shows that for a registration fee of \$35 there is a shortage of \$638 if 100 people attend the event but that this reduces to only \$176 if 150 attend. Figure 1 also shows that if the attendance is 100 then the registration fee has to be more than \$40 to break even.

### The Need for Advice on Format Changes

The justification given above assumes that no changes are made to the event format however there are some changes that could be considered in an effort to reduce the room charges. Table 3 shows the impact on the registration fee for several different cost saving options. Since the room charges are about a third of the registration fee the suggested reductions do not have a particularly large effect on the registration fee.

Each of the suggested options for cost reduction comes with some loss in event quality. Rincon is not very big and is set up more for a board meeting; squeezing the lunch into one of the Ventana rooms will result in a more crowded (or intimate) luncheon feeling; reducing the number of presentations per session would reverse a long held practice. Since the reduction in registration fee is not particularly significant unless it is absolutely necessary the committee would prefer to not implement any of these changes but would like to hear from the ASURA Board relative to the desirability of making any of these suggested changes.

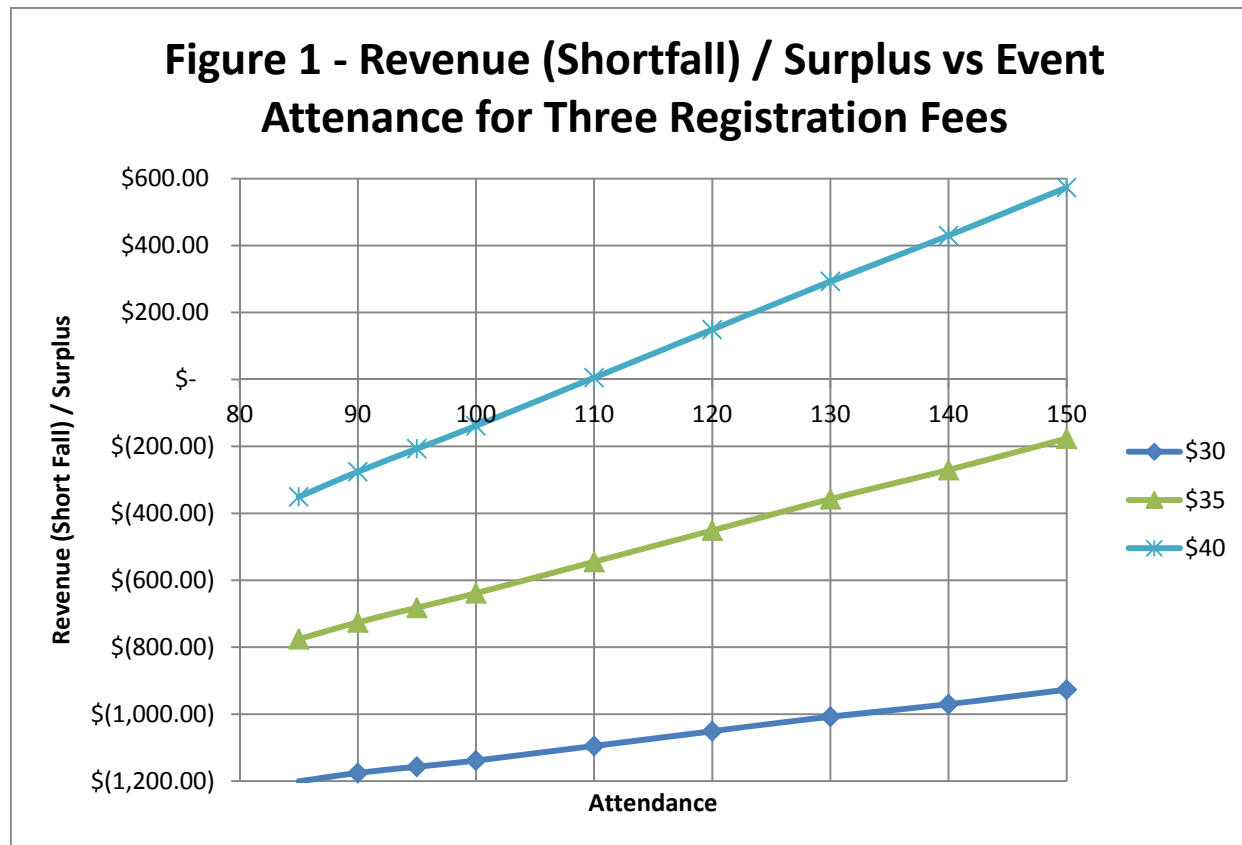

### **ASRS Board of Trustees Meeting, March 16, 2012**

- **\*\*Legislative Session Report** As I have previously reported, the retirement legislation in this session is primarily of a housekeeping nature, with little of interest to ASRS members. However, the following deserve some attention:
  - SB 1119 would require that an ASRS member who is married must name their current spouse as a beneficiary to receive at least 50 percent of the member's account, and at retirement is required to elect a joint and survivor annuity with the spouse as the contingent annuitant. The spouse may choose to waive this requirement.
  - HB 2571 is an attempt to place all state agencies under a one-size-fits-all personnel policy. This would render inoperable the current ASRS Employee Policy Manual, which has been developed to assist effectively both the employees and clients of ASRS. There are aspects of the ASRS mission which do not lend themselves to an omnibus employee policy.
  - There are various legislative attempts to reverse (with retroactive reimbursement to employees) the 53 – 47 contribution breakdown that was passed by last year's legislature, restoring the 50 – 50 split. This will likely be done in the budget bill.
- **\*ASRS Total Fund Performance Review** This item took up the bulk of the day's meeting time. Both U.S. and International Equity Classes were reviewed in detail, with manager performance in each sector given close attention. The total fund rolling annual rate of return over a 20 year period is 7.9%, falling 0.1% short of the actuarial assumed interest rate of 8%. Details and rates of return over other periods are available in the agendas, copies of which are placed in the ASURA office.
- **\*The value of the ASRS portfolio** as of January 31, 2012, was \$27,170,386,318, an increase of \$840M over December 30, 2011.

### **ASRS Board of Trustees Meeting, April 20, 2012**

- **\*\*Legislative Session Report** As the legislative session winds down, there are some final actions on bills to report. Among the most pertinent:
  - HB 2088 This is an omnibus bill, sponsored by ASRS, which contains several housekeeping items. It was **vetoed by the Governor** on an issue involving ASRS's exemption from State procurement rules regarding the hiring and dismissal of investment fund managers. The Board and staff are working with the Governor's office to find an accommodation that would be acceptable to the Governor. The other provisions in the bill may find a home in other carrier bills.
  - SB 1117 involves ASRS disbursement and collection technicalities. **PASSED AND SIGNED BY THE GOVERNOR**
  - SB 1119 would require that an ASRS member who is married must name their current spouse as a beneficiary to receive at least 50 percent of the member's account, and at retirement is required to elect a joint and survivor annuity this the spouse as the contingent annuitant. The spouse may choose to waive this requirement . **PASSED AND SIGNED BY THE GOVERNOR**
  - SB 1194 again involves administrative technicalities. **PASSED AND SIGNED BY THE GOVERNOR**
  - HB 2571 is an attempt to place all state agencies under a one-size-fits-all personnel policy. This would render inoperable the current ASRS Employee Policy Manual, which has been developed to assist effectively both the employees and clients of ASRS. There are aspects of the ASRS mission which do not lend themselves to an omnibus employee policy.
  - HB 2038 This is an attempt to reverse (with retroactive reimbursement to employees) the 53 – 47 contribution breakdown that was passed by last year's legislature, restoring the 50 – 50 split. It appears to be on track for passage. It is on track for passage; ASRS is attempting to obtain some amendments that would exempt it from some of the bill's sweeping features.
- **\*ASRS Director's Report** Director Paul Matson reported that
  - At least three new members of the Board of Trustees will be introduced at the May meeting.

- A ruling from the Maricopa County Superior Court reversed the current 53% - 47% employee-employer split on contributions for those currently employed, stating that the recently legislated split was unconstitutional. The issue is, however, as stated above, being addressed legislatively with more sweeping terms, i.e., retroactive reimbursement to employees and return to the 50 – 50 split for all, including future, employees.
- Improvements have been made on telephone response rates.
- \*The value of the ASRS portfolio as of February 29, 2012, was \$28,037,078,696, an increase of \$870M over January 31, 2012.

Comment: This was the shortest ASRS Board Meeting in my memory and, as stated by the Board Chair, in history.

## Board Report and Discussion Item – ASURA History Committee

The ASURA History Committee has held four (4) meetings since its formation. Assignments have been made to committee members and they are responding commendably. The deadline for written materials from past-presidents was set for April 30<sup>th</sup> and the deadline for other written materials solicited from ASURA members is set for May 31<sup>st</sup>. Most of the materials from the past-presidents has been received and is in the process of editing. Some of the other solicited written materials with the May deadline has already been received and are in the process of compilation and editing. At this point the work seems to be progressing well and on target for completion by the deadline set by the committee for having a final product by the Annual Meeting in 2013.

One item that could affect this deadline needs to be raised. The authorization given the committee by the Board to produce a history of ASURA's second decade was for a digital or online version only. In our committee deliberations, concern has been expressed that this approach will most likely limit about one third of the current ASURA members from accessing this history since they are not computer users nor do they have access to the Internet. In addition, others who may have computers and Internet access may not want to read the history at their computer screen and may not want to download a 100+ page book. We have observed that many retired individuals prefer a hard-copy book rather than online books. And it should be noted that printed books introduce certain constraints not associated with online materials such as formatting, font issues, length of the book, photo insertions, printing time, printing costs, etc.

With permission of the Board, our committee would like to seek estimates for printing costs for a limited number of books or any number deemed advisable by the Board. In addition to non-computer using ASURA members and those who prefer a hard copy book, the committee has also noted that others such as ASU officers, administrators and leaders, ASU archives, Office of Public Affairs, ASU Foundation, presenters and speakers at ASURA activities and events, current ASURA members, new ASURA members and others may wish to read and learn more about the organization and its history. Obviously our committee recognizes that no commitments would be made until authorized by the Board.

The printed history for ASURA's first decade was approximately 100 pages. It appears that the new history may be closer to 150 to 200 pages given some additional emphasis to programs and activities not covered in the original history book and expansions of existing programs. Assuming the development of a printed version of the book, the committee suggests that sponsors for the book be considered to offset or underwrite the costs for printing. ASURA has had close working relationships with many operations and organizations both inside and outside the University that may wish to have their names listed as sponsors in our publication. Additionally, there may be individual ASURA members who would like to be a sponsor.

The matters put before the Board today for decision are: (1) Should the ASURA produce a printed version of the 2<sup>nd</sup> edition of the ASURA History and (2) If "yes," should the ASURA History Committee seek sponsorships for that printed version.
