After two years at EODMU ELEVEN, he was transferred to Coronado, CA as an initial member of the Very Shallow Water Mine Countermeasures Test Detachment. He served in Okinawa as EOD staff officer in Amphibious Group ONE. He was then assigned to U.S. Joint Forces Command, Norfolk, VA as the Improvised Explosive Device (IED) Defeat and Counter-IED lead action officer. He then commanded EOD Training and Evaluation ONE. His most recent assignment was in Iraq as Deputy Commander of Combined Joint Task Force TROY, Iraq's Counter-IED brigade task force.

# **Legislative Update**

**Senate Passes Defense Bill** After more than a week of debate and consideration of more than 300 amendments, the Senate passed its version of the FY2010 National Defense Authorization Bill (S. 1390) late Thursday night, July 23 by a vote of 87 to 7.

One key amendment was Sen. Bill Nelson's initiative to end the deduction of VA Dependency and Indemnity Compensation (DIC) from military Survivor Benefit Plan (SBP) annuities. Upon learning at 8:00 AM Tuesday that the amendment would be considered that same afternoon, MOAA sent out a special alert to legislative update subscribers. This alert generated nearly 13,000 messages to the Senate in support of the amendment in under 6 hours, resulting in the amendment's adoption. Thanks to all who participated in this time-sensitive action to help military widows.

Several other MOAA-supported amendments were adopted by the Senate including:

Sen. Joe Lieberman's (I-CT) amendment to increase Army manpower levels by 30,000, starting in FY2010.

Sen. Frank Lautenberg's (D-NJ) amendment emphasizing the need to sustain a military health benefit consistent with the unique demands and sacrifices inherent in a military career, and the need to find other ways of cutting DoD health costs besides shifting costs to retirees.

Sen. John Kerry's (D-MA) and Saxby Chambliss' (R-GA) amendment to provide reserve retirement age credit for all post-9/11 active service.

Sen. Charles Schumer's (D-NY) amendment (with inputs by Sen. John Cornyn, R-TX) to protect military absentee voting rights by authorizing electronic communications and limiting the counting of absentee ballots based on technicalities (e.g., lack of notarization).

Sen. Barbara Boxer's (D-CA) amendment (prompted by MOAA's discussion with her staff) expressing Congress's view that the Secretary of Defense should use existing authority to implement Flexible Spending Accounts for currently serving members so they can set aside pre-tax money to pay out-of-pocket health and dependent care expenses, just as all other federal and major corporate employees can.

Sen. Richard Burr's (R-NC) amendment to give military spouses the option to elect the same state of domicile as their servicemember spouse.

Unfortunately, several other amendments MOAA supported were not acted upon, including Sen. Harry Reid's (D-NV) concurrent receipt amendments and Sen. Lindsey Graham's (R-SC) amendment to authorize a one-year reduction in the reserve retirement age for each two years served beyond the 20-year point.

The proposal to phase out the disability offset for medically retired members, regardless of length of service is still very much alive, though, as it was included in the House bill.

Next, House and Senate leaders will be appointed to a conference committee to resolve more than a thousand differences between the House- and Senate-passed versions of the defense bill, including difficult issues on procurement, detainees and more.

Hearing Highlights Family Needs A July 22 House Armed Services Military Personnel Subcommittee hearing reinforced that access to healthcare providers - both on and off installations - continues to present a serious challenge for many military families. With military medical personnel deployed, there's an increasing reliance on civilian providers. But many civilian doctors don't accept TRICARE due to low reimbursement rates and administrative hassles.

Rep. Carol Shea-Porter (D-NH) raised the issue of compensation for caregivers of injured troops, observing that many family members must give up their jobs to support wounded warriors.

The panelists also expressed their concern regarding the funding of family readiness programs. Currently the programs are funded through supplemental appropriations. The panel stressed the importance of funding these programs through base-line budgets.

# **NJROTC Topic At Joint Dinner in April**

LtCol Janus discussed the threat to JROTC programs throughout the state due to a decision by the California Department of Education that would cause the loss of physical education (PE)-credit for JROTC participation. The severe drop in JROTC enrollment in San Francisco from 1,600 to 500 in just one year after the loss of PE Credit is indicative of what would happen program-wide unless JROTC is accepted as a PE substitute or exempted. Assembly member Mary Salas (79<sup>th</sup> District) has introduced AB No. 351 - Physical Education. This bill would exempt students taking specified programs and courses, including

JROTC, from courses in physical education. This bill has cleared the Education Committee and is headed to the Assembly floor. MOAA Chapters across the state are encouraged to call their Assembly member and voice support for this bill.

# **Coronado NJROTC Completes Banner Year in True Navy Tradition**

The cadets of Islander Company, Coronado High School's Navy Junior ROTC unit, recently closed out another banner year. Recognized for the third consecutive year as an "NJROTC Distinguished Unit with Academic Honors", this year's award ceremony moved from the comfortable but somewhat sterile environment of the school's theater to a venue much more applicable to the awards and recognition given to such an accomplished group of cadets. Captain Roy Kitchener, the Commanding Officer of the AEGIS guided missile cruiser, USS PRINCETON, offered up the small but cozy flight deck on the stern of USS PRINCETON on the afternoon of Thursday, May21for the CHS NJROTC awards day. Vice Admiral Derwood Curtis, a long-time strong supporter of youth programs, attended.

Come the day of the event, there could not have been a more fitting setting for what is believed to be the first ever San Diego NJROTC Awards Ceremony and Change of Command to be hosted on the deck of an active duty, deployable Navy ship. With the ship decked out in patriotic bunting, 50 states flags unfurled, and all the pomp, honor and tradition that goes into an actual Change of Command ceremony, Islander Company enjoyed a ceremony like no others before them. Under a clear blue sky, with breezes blowing stiffly but gently enough, and a view that commanded San Diego Bay and the Bay Bridge as a backdrop, over 200 visitors enjoyed watching Islander Company as a unit and 26 cadets individually receive due recognition for their many accomplishments this past year. These accomplishments included four top 5 finishes at area drill meets. They included 2,232 community service hours completed in support of such organization as the Coronado Schools Foundation, Islander Sports Foundation, the Coronado Coffee, Friends of the Library and the annual Flower Show. Additionally, the unit's marksmanship team earned a top 3 finish out of over 30 teams. Islander Company cadets also completed 27 field trips to include embarkations on ships like USS NEW ORLEANS and fun trips like paintballing and travel to Knott's Berry Farm. Of course no year is complete without the legendary Islander Company Military Ball which was attended by more guests than ever and robustly hailed as "the best Ball ever."
