Each category of product and each championship class will have its own Contingency Awards postings.

Bodywork - Bodywork, ducting and windscreens

Brakes - Brake rotors, master cylinders and calipers

Crash Protection - Engine covers, case covers and guards

Drive Systems - Sprockets and chains

Electronics – Engine Control Units: Stand-alone and piggyback style, instrument panels

Engine - Oil pans, camshafts, slipper clutches, radiators, oil coolers,

Exhaust – Complete systems, slip-ons and silencers/mufflers

Frame - Subframes, front and rear

Suspension – Fork internals, rear shocks & linkage, steering dampers and triple clamps, rake kits, fork brace
