#### FORM 6C SPECIAL AFFIDAVIT OF A RESIDENT PROVIDING HOUSING FOR A FAMILY WITH SCHOOL AGE CHILDREN

This is a legal document which must be sworn to and signed in the presence of a notary public. The Board of Education will use this affidavit to determine whether the student is entitled to a free education in this school district. Every question must be answered or the Affidavit will not be considered. You bear the burden to provide proof sufficient to establish the existence of a family in your resident.

Special affidavit children are those children who with their parents are being housed in Union Township and want to attend Union Township's Public Schools. Such children and their parent(s) must be kept in the home of a person who is domiciled within Union Township. Such person shall be referred to as "responsible resident" in this document.

An affidavit must be filed on an <u>ANNUAL BASIS</u> by the responsible resident with the Superintendent and/or his/her designee indicating that he/she is domicile within the district and is providing housing for the child(ren) and his/her parent (s) and intends to provide said housing for the school term. New Jersey statutes provide as follows:

18A:38-1 Attendance at school free of charge.

Public school shall be free to the following persons over five and under twenty years of age:

a – Any person who is domiciled within the school district.

If the information provided is false, the Board of Education will seek reimbursement of tuition at a cost of \$10,000.00 annually. The Board of Education may file a criminal charge against you for any willfully false statement.
