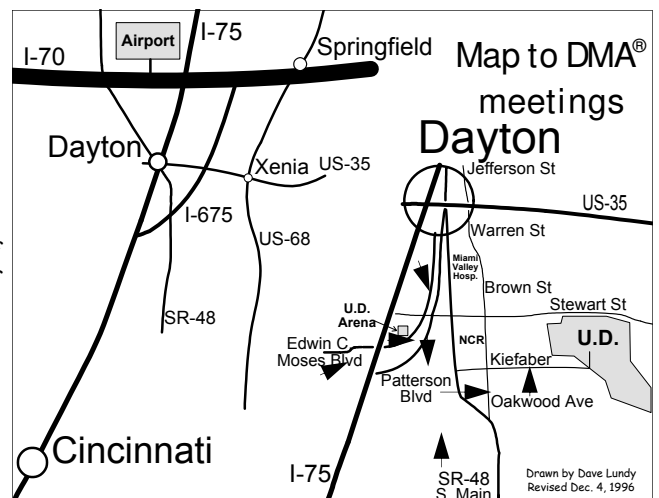

DMA[®] Board of Trustee and Officer Elections September 28, 2004

Elections will be held at the annual general meeting September 28, 2004. The DMA[®] By-Laws state specific requirements to be a nominee for a Board of Trustee or Officer. Each year three people will be elected as Board of Trustees for a three (3) year term by the membership present at the September General Membership meeting. At the October Board meeting, the President, Vice-President, Secretary and Treasurer are nominated and then elected by the Board of Trustees for a one (1) year term.

Requirements:

- You must be a paid up individual regular or associate member of DMA[®] in good standing for at least the 12 months prior to election.
- You must be twenty-one (21) years of age before the date of the election.

- You are required to fill out and sign all forms and return them to the **Nominating Committee Chairman** by August 31, 2004.

Any DMA[®] member wishing to run for Board of Trustee position MUST contact the Nomination Committee Chairman or Committee members. The Committee will send you a Nomination Packet consisting of a copy of the current DMA[®] By-Laws, an Expression of Interest and Commitment form and DMA[®] Code of Ethics Form.

The Nominating Committee Chairman will send every eligible nominee a certificate of acceptance notice. Every eligible nominee will be asked to send a short write up, electronic form preferred, not to exceed 500 words, and a photograph before August 31, 2004 to be printed in the October DataBus. This write up should include a Bio and why you would like to be a DMA[®] Trustee.

Nominations will NOT be accepted from the floor on election night, Tuesday September 28, 2004.

Hardware Review: Thrustmaster Firestorm Game Pad

At the tender age of 9, Dan got his start enjoying computer games on his TI-99/4a home computer, and he's been at it ever since. He graduated in 1996 with a B.S. in Environmental Studies. Most of the games available for the PC platform can be enjoyed just fine with a mouse and keyboard. However, once in a while, you are bound to find yourself wanting something else, especially for arcade style games, shooters, fighting games, and any sort of racing or flight combat games. The turning point for me came when I saw a racing game which I had wanted to try out for a couple of years. I knew a keyboard just wouldn't do the game justice, so I went online and decided to get a good but cheap game pad for my computer. I ended up with the Thrustmaster Firestorm USB game pad, for only \$7 refurbished at computergeeks.com.

As game pads go, the Firestorm USB left me with a good first impression. It has a high quality cord which is several feet longer than I am tall, which means that you won't have to stay huddled up close to the CPU just to play games. The second detail I noticed was the fact that this game pad does not feel like slick plastic, but instead has a comfortable rubberized feel to it. It also has 10 different buttons, several of which are placed under the game pad, where they can be accessed using the ring or "pinky" fingers. There are also 3 small axis controllers on the pad, 1 of which is analog, and is more like a typical game pad controller. The other 2 are the default digital "control sticks", which are really just nubs about half an inch long.

Of course, the hardware doesn't work by itself, software is involved as well. When I first installed the game pad, Windows was quite happy to set it up as a basic controller. It did actually work right out of the box. However, once the included software/driver CD had been loaded, I was able to program

the various buttons to coincide with a multitude of in-game commands. There were even hundreds of "game profiles" already available, with buttons mapped to a functional default, customized for each game.

One of the reasons I opted for the Thrustmaster Firestorm was due to its force feedback support. While I had experienced this form of virtual feed-



back on platform systems such as the Playstation, I had never before tried it on a PC game. For those who are not familiar with this, the game pad employs several tiny motors which are out of round and produce a vibration when activated. The game pad installed just fine on a Windows 98 system, but for some reason the same games would not detect it on a Windows XP system. It turned out that I simply needed to download the latest driver and software from the Thrustmaster website.

Actual game play depended a lot on the game. I tried out a couple of racing simulations, both of which had force

feedback support. The older title, *Dirt Track Racing 2*, was actually a lot more fun to play. The force feedback in this game simulated crash impacts and the mud or dirt driving surface well and truly did add to the game. On the newer title, *NASCAR Thunder 2004*, I found that the force feedback was actually much stronger. I could feel the vibrations in certain raceways, as though I was actually driving a car that was hugging the pavement. Unfortunately, the game itself was rather lousy, repetitive, and not at all fun to play. In fact, the force feedback was probably about the only positive aspect I could see in this title, and I doubt that I will reinstall it. This just goes to show that an older title, while perhaps a bit inferior in the graphics department, can truly offer much more in the way of enjoyment and value.

Summary: When bought new, this game pad has a full 2 year warranty, which is a good clue as to the quality of the components. The Thrustmaster Firestorm is an excellent quality game pad that is fully customizable, feels good in the hand, and is serviceable for a broad range of games. If you have a free USB port and an extra \$20 lying around, go ahead and grab one of these. You'll be getting a good deal on a great controller, and I seriously doubt you will need another one any time soon.

Software Review: NIK Image Sharpener Pro

When taking a photograph, it is rare that you have the time to compose it perfectly. It is even rarer to have the opportunity to play with the settings on your camera to make sure it is the best photo that it can be. Point the camera, zoom to compose as best you can, then the electronic wizardry take over. The exposure and focus are handled for you. It is the next step that separates the digital photographer from his film counterpart: the ability to manipulate the image prior to printing without spending thousands of dollars on dark-room equipment. Digital photographers take their cameras home, download the image to the computer, and edit them prior to printing.

The first step in editing a photo is to use a program such as JASC Paint Shop Pro, or Adobe Photoshop to crop the photo and adjust the color. Here is where you make up for imperfections in your photographs caused by your imperfect composition, your limited opportunities (or skills), and the errors caused by your camera (yes, better cameras do take better pictures). After all of your editing is complete, the last step is to sharpen the image.

Sharpening an image involves looking for boundaries between objects and increasing the contrast and definition of the image in these areas. It creates details using mathematical "magic" to bring out fine points that may or may not be apparent in the original image. One of the many real life situations where image sharpening is used is to identify license plate numbers on moving cars where the photograph is slightly blurry due to the motion. Sharpening can make an unintelligible blur completely readable and identifiable.

Image sharpening was originally developed by NASA for the Apollo missions. Photographs were taken digi-

tally so they could be downloaded by radio to Mission Control. Digital imaging was in its infancy and camera resolutions were extremely low. Most were taken at a mere 320X400 resolution (that's a mere .1 megapixels). In order for the images to be useful to scientists, NASA developed the first image sharpening techniques.

NIK Image Sharpener Pro is a plug in filter for Photoshop that brings state of the art image sharpening to any image editing software that is compatible with Photoshop plug-ins. This includes



Photoshop Elements and Paint Shop Pro. Utilizing a proprietary process, Image Sharpener Pro optimizes sharpening for the various print processes, including Offset, Inkjet, Color Laser, and Photographic Printers, and includes a separate sharpening calculation engine for sharpening internet or screen-viewed images. Sure Photoshop has a built in image sharpener (perplexingly named the Unsharp Mask), but NIK has taken sharpening to a new level.

With Image Sharpener Pro, you can optimize your photographs for your specific printing method. The same photograph will print differently on an

Inkjet printer from how it will look on a Laser, and different still will be its representation on the Internet. The biggest difference will be the appearance if the picture is to be printed on a 4 color Offset Press. Image sharpener Pro takes the printing method into account when it performs the sharpening so that the image will always look good.

Digital Images always look the best when they are edited at the same size that they will be printed. Image Sharpener Pro allows you to set the finished print size for the image when you sharpen it. If you will be placing the image in an Adobe Pagemaker document and it will print as a 4x5 inch image, you sharpen the photo for 4x5 inches and it will add or subtract detail from the image so it looks good. The good news is that it works great! The bad news is that you have to edit your image for the specific publication that you are putting it into. You cannot edit an image to print on an inkjet at 8x10 size, then place it as a thumbnail in a word document and expect the same great results.

Each image setting (inkjet, laser, offset and internet) can be run in auto-scan or manual modes. In autoscan image sharpening is almost completely automatic. You tell the program the final size of the image and the resolution of your printer (in dots per inch), and the quality of your printer (bad, average, or above average) and it does the rest. In manual mode you have a few more controls to work with. Regardless of the methods or settings, NIK Image Sharpener Pro consistently brought details out that were not visible in the original photograph! Side by side comparisons between images sharpened with NIK Image Sharpener Pro and Adobe Photoshop Elements showed a major improvement in the clarity of the image in all instances!

The Single Responsibility Principle – Part II

Mark: In our last column, you gave an example of an Employee class and you made a comment that this was an example of a class you might have written back in the olden days when you were struggling with Object Oriented concepts and bread cost a nickel. What would you do differently today?

Bob: The context of the example was to illustrate the Single Responsibility Principle: A class should do one thing and do it very well. Or said another way, a class should have a single reason to change. I admit up front that deciding if a class is doing more than one thing is difficult and often ends up being a judgment call. But I feel that the classes that I write now are smaller and more focused because I constantly think about this principle as I'm designing and programming.

When I was learning about Object Oriented techniques, the general consensus from practitioners was that a class should know everything that it needs to do its job. A class should know how to display itself on a computer screen and, as our example from last month shows, it should know how to get itself from a database. This is the opposite extreme from having a single responsibility.

So Mark, you had a month to contemplate our example. How many responsibilities does our Employee class have?

Mark: I think it's obvious that the Employee class is doing two distinct things. It knows how to calculate its pay, something that an Employee object should know how to do, and it also knows the details of how it's stored in the database.

What's the right answer?

Bob: I don't think there is a right answer. As I said earlier, deciding what a single responsibility is often a judgment call.

Mark: Then make a judgment. How many classes are in your solution?

Bob: Four.

Mark: Four? How in the world do you see four responsibilities?

Bob: I admit it isn't obvious. Let's split Employee into two

pieces, one that knows the business of being an Employee and another, let's call it EmployeeDAO, that knows the details of the database.

Mark: What does the suffix DAO indicate?

Bob: Data Access Object.

Mark: That's two classes. Where are the other two?

Bob: We have to look at the code for EmployeeDAO. Let's restrict ourselves to just two methods, one that puts Employee objects into the database and another that creates Employee objects out of data stored in the database.

What is the responsibility of the store() method?

Mark: It takes the fields of the Employee object and stores them as a record in a database.

Bob: I see it as 1) knowing the SQL for inserting an Employee, 2) setting the parameters of the PreparedStatement, and 3) executing the PreparedStatement.

Mark: That's a very granular decomposition. I would say too granular. What's wrong with having store() do all three?

Bob: To answer your question, I'll ask you another question. How would you write a unit test for store() ?

Mark: I'd create an Employee object with known parameters, call store(), and then verify that store() actually put the Employee record in the database. Here's the code I might write:

Bob: I used to write code just like that. The thing I didn't like was the Catch-22 of needing findById() working in order to test store(). If the test fails, it isn't clear why it's failing. I would prefer my test to fail for one reason.

Mark: Instead of using findById() to get the newly stored Employee out of the database, I could make JDBC calls in the unit test and get the Employee out directly. Then I'd only be testing store().

Bob: And you would be duplicating the same exact code in findById() in your unit test so if and when the database schema changes, you have two places to change it.

Mark: You're right, that's just evil.

Bob: To solve the testing problem, I use a few more objects that I can unit test more easily. In particular, I have a PreparedStatementHelper class whose job is to make Prepared-

StatementData objects.

The PreparedStatementHelper is only concerned with Strings and Lists and doesn't have any dependency upon JDBC or a database, so it can be tested quite easily. PreparedStatementData holds the SQL string and a List of parameters for the PreparedStatement. Finally, PreparedStatementExecuter inserts the PreparedStatementData into the PreparedStatement and finally executes it.

PreparedStatementExecuter is the only class that actually needs a database for testing. But since all it does is process PreparedStatementData, once it's working, there is no reason why it should ever stop working. Hence, all my testing effort goes into making that PreparedStatementData is correct, and that doesn't need a database.

Mark: I like it. But we've kind of strayed off topic from the Single Responsibility Principle and ventured into Test Driven Development.

Bob: Perhaps we have. Or perhaps designing our classes to be testable from the outset helps us uncover just what the responsibilities are.

Mark: Once again we're out of space.

Bob: Next month we'll tackle the Liskov Substitution Principle, the principle that guides us in the proper use of inheritance between two classes.

Mark: Until then, may all your designs be clean, and your code bug-free.

Last month I wrote a little about the American Water Works Assn. Show and here's more about it this month. I briefly watched the "tapping" contest, which was fun. There was seating for a small audience and the competition teams came from all over the world. There was a 20' length of approximately 8" steel pipe mounted on pedestals and it was capped and pressurized with water at about 45 psi. When a three-man team was ready, a signal was given and they were to quickly install a special tapping device around the pipe tightly, then drill and tap a hole, then install an outlet valve on that 8" pressurized steel pipe. At the same time, one of their team was cutting a 6' length of 1" copper tubing, forming a proper bend, and connecting one end to a pressure gage mounted on a stand, and the other end to the newly installed valve when the tapping device was removed. When they pressurized the gage, it stopped the clock. This procedure must end up without any leaks.

Improper bending of the copper tubing, any leaks, and a couple of other rules, if infringed upon, were assessed an extra seconds penalty to determine the official time. A Hawaiian team performed the fastest time I saw in 1 minute 55 seconds. I can tell you that there were hands and elbows flying everywhere for those sessions. Unfortunately, I only got to watch a few contestants, but it was held every day of the show. When I watch our own local utility workers, there are never any record times. In fact, I worry about the quality of the shovel handles they are leaning on.

It does not work with Web based mail as the name POPfile suggests. Anyway, I'm including his suggestion for your perusal. - The Inkjet Edition provides optimal sharpening for any Inkjet printer and retails for \$169.95

• The Complete Edition provides sharpening for any type of output device, including continuous tone printers, digital photographic printers, inkjet printers, offset and half-tone printers, as well as publishing to the web. It retails for \$329.95.

A trial version of the software is available for download at their website www.nikmultimedia.com. There are no specific system requirements to run this plug-in, but you must have an image editing software that supports Adobe Photoshop plug-ins and a computer with enough power to support that software.

The CCNA exam is the qualifying exam available to candidates pursuing a single-exam option for the Cisco Certified Network Associate CCNA certification. The CCNA (640-801) exam will test materials from the new Interconnection Cisco Network Devices (ICND) course as well as the new Introduction to Cisco Networking Technologies (INTRO) course. The exam will certify that the successful candidate has important knowledge and skills necessary to select, connect, configure, and troubleshoot the various Cisco networking devices.

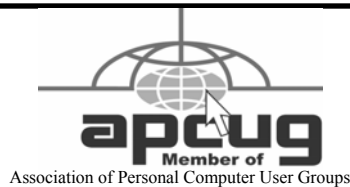
